Annotations

In its resolution 57/242, the General Assembly decided that the International Ministerial Conference of Landlocked and Transit Developing Countries and Donor Countries and International Financial and Development Institutions on Transit Transport Cooperation should be convened at Almaty on 28 and 29 August 2003. The General Assembly also decided that the second session of the Intergovernmental Preparatory Committee for the Conference would be held at Almaty from 25 to 27 August 2003.

Pending the election of the Bureau, the Secretary-General of the Conference will open the session.

3. Election of the Bureau

The Intergovernmental Preparatory Committee elected its Bureau at its first session, held from 23 to 27 June 2003. The Bureau consists of 10 representatives of Member States from landlocked and transit developing countries and donor countries who were elected on the basis of equitable geographical representation. As is the practice, the members of the Bureau of the Committee will also serve as the Bureau of the Conference.

4. Consideration of the draft Programme of Action of the Conference

The Conference will consider the draft Programme of Action of the Conference. The Chairman's text was prepared as a result of the first session of the Intergovernmental Preparatory Committee.
