Letter dated 31 October 2003 from the Chairman of the Security Council Committee established pursuant to resolution 1373 (2001) concerning counter-terrorism addressed to the President of the Security Council

In its resolution 1373 (2001) of 28 September 2001, the Security Council called upon all States to report to the Counter-Terrorism Committee by 27 December 2001 on the steps taken to implement that resolution, and thereafter according to a timetable set by the Committee. In the declaration adopted by the Council in its resolution 1456 (2003) of 20 January 2003, the Security Council, meeting at the level of Ministers for Foreign Affairs, stressed the obligation of States to report to the Committee to report regularly on progress.


In the work programme of the Counter-Terrorism Committee for the ninth 90-day period, the Committee urged all States that had not submitted their reports on time to submit them as soon as possible in fulfilment of the provisions of resolution 1373 (2001). The work programme further indicated the intention of the Chairman of the Committee to write to the Security Council by 31 October with the list of States late in submitting their reports.

A total of fifty-eight States, listed in the annex to the present letter, have failed to meet the 31 October deadline for the submission of outstanding second and third reports.

The Counter-Terrorism Committee will continue to be in contact with the States concerned and remains available to discuss any aspect of the submission of the reports requested of them, as well as any assistance that may be required. The Committee continues to be of the view that submitting reports in a timely manner is the best way for States to find the assistance they may need to implement resolution 1373 (2001). The Committee and its subcommittees, as well as its experts, stand ready to offer assistance and guidance to States in their implementation of the resolution, as well as in their submission of reports to the Committee.
