Report of the Second Committee*

1. At its 2nd plenary meeting, on 19 September 2003, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-eighth session the item entitled:

“Macroeconomic policy questions:

“(a) International trade and development;

“(b) Science and technology for development;

“(c) Specific actions related to the particular needs and problems of landlocked developing countries;

“(d) International financial system and development;

“(e) External debt crisis and development;

“(f) Outcome of the International Ministerial Conference of Landlocked and Transit Developing Countries and Donor Countries and International Financial and Development Institutions on Transit Transport Cooperation;

“(g) Commodities”

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate jointly on sub-items (b), (c), (d), (e) and (f) at its 19th to 21st meetings, from 22 to 24 October, and on sub-items (a) and (g) at its 23rd to 27th meetings, on 3, 5 and 6 November 2003.
