Addendum

The following text should be added after subparagraph 91 (d) of document A/C._/43/12, in section IV on the security and independence of the International Civil Service:

92. Set out below is a list of cases of violations of fundamental rights of staff members of the United Nations system, which has been established on the basis of current information. The list consists of two parts: section A concerns all organizations except UNRWA; and section B deals exclusively with UNRWA staff.
