PROPOSED FUND PROGRAMME ACTIVITIES 1976-1977

Note by the Executive Director

1. INTRODUCTION

- I. The Governing Council at its third session decided (decision 36 (III), paragraph I) on an apportionment of resources for Fund programme activities in 1976 and 1977, subject to a revision of the 1977 proposals in order not to exceed the proposed total allocation of \$82,000,000 for Fund programme activities for the three-year period 1975-1977.
- 2. The proposed activities outlined below are maintained within the above total, with due regard for expenditures incurred in 1975 and commitments made for 1976 and 1977 as a result of approved projects. In view of the biennial cycle of the UNEP programme, the policy directives contained in decisions taken at the third session, as well as the allocation of funds made at that time, will basically govern the activities of the secretariat in 1976 and 1977. Therefore, this document could have on which the Council's guidance was required. The programme itself could have been carried out, with a few exceptions, within the approved apportionment, adjusted by a maximum of 20 per cent in some lines. However, to facilitate comparisons with last year's programme has been retained Council a complete picture of activities planned for the biennium.
- 一多。 The year 1975 has seen considerable acceleration of pace and increase of level of Fund programme activities, as reported in document UNEP/GC/68. Many of the activities initiated then will continue into 1976 and 1977 and obligate funds from these two years! budgets. As of I danuary 1976, forward commitments totalled \$24 million, as compared with \$4 million at I January 1975. Furthermore, some \$4.5 million approved for 1975 activities were carried over to 1976 due to delays experienced by co-operating agencies and supporting organizations (recruitment of personnel, meetings and publications). It is expected that these activities will be completed according to plan and the corresponding funds committed in the first part of 1976. The Executive Director therefore feels that in order to maintain the momentum of the programme and to move it towards greater action orientation, the requested levels of Fund programme expenditure for 1976 (\$34 million) and 1977 (\$35.7 million) are both realistic and necessary. In regard to 1976, \$15.5 million are already committed and an additional \$4.5 million mentioned above are carried over from 1975. Thus, a total of \$20 million of out of \$34 million is already committed and only \$14 million is available for new activities. The total does not require any adjustment whatsoever in the proposed level of resources which the Council approved at its third session.
- 4. The Fund programme reflects a further effort at concentration on fewer selected areas of work. In view of the large scope of UNEP's mandate, the number of individual projects still remains considerable. Every effort is made, however, to integrate projects that belong together, to provide links through umbrella-type projects (e.g. in the case of the Mediterranean), and to co-ordinate activities through advanced planning. The Fund programme at the beginning consisted essentially of a series of reactions to proposals from external sources; later a balance was achieved between external proposals and UNEP initiatives;

now the Fund programme has achieved a thrust of its own, reflecting UNEP initiatives in the pursuit of the objectives set by the Council. This has become possible through the close working relationship and trust built with the specialized agencies, the growing number of supporting organizations whose capabilities are now better known, and above all. the clarification in the substantive programme content achieved over the last two years, through a number of Fund projects.

- In order to give an overview of the use of resources for Fund programme activities Table I presents, at the level of budget lines, the expenditures Incurred in 1973, 1974 and 1975 and the proposals of the Executive Director for revised apportionment of resources for Fund programme activities for 1976 and 1977.
- 6. Table II presents a summary of the proposed apportionment for 1976 and 1977 by sub-line. The House Street
- This document presents the Fund programme proposals in the same 7. overall order and sequence as the proposed programme contained in document UNEP/GC/61. Thus UNHHSF, which has a separate budget line, is shown together with the human settlements section. However, there are some differences within individual sub-sections.
- Finally, the document presents a suggested decision by the Council approving the revised apportionment for Fund programme activities for 1976 and 1977 and confirming the forward commitment authority of the Executive Director for 1978 and 1979 at the level already approved last year.
