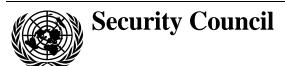

## Letter dated 13 December 2003 from the Permanent Representative of Côte d'Ivoire to the United Nations addressed to the President of the Security Council

## Final communiqué

On Thursday, 4 December 2003, the Defence and Security Forces of Côte d'Ivoire and the armed forces of the Forces nouvelles held a meeting at the Félix Houphouët-Boigny Foundation for Peace in Yamoussoukro under the auspices of His Excellency, Mr. Laurent Gbagbo, President of the Republic of Côte d'Ivoire, and with the Prime Minister of the Government of National Reconciliation and the impartial forces of the United Nations Mission in Côte d'Ivoire (MINUCI), the Economic Community of West African States (ECOWAS) Mission in Côte d'Ivoire (ECOMICI) and the French Forces (Unicorn) in attendance.

In light of the gravity of the events now taking place and the possibly catastrophic consequences which they may have for the peace process currently under way, the parties have agreed on the need to do everything in their power to create as soon as possible a climate conducive to the resumption of talks and activities aimed at restoring normalcy and lasting peace to Côte d'Ivoire.

After a frank and fruitful exchange of views centred on the recommendations of the meetings held earlier at Bouaké at the Baptist Mission and at the quadripartite command post, on 27 November and 3 December 2003, respectively, agreement was reached on the following:

- 1. The Defence and Security Forces of Côte d'Ivoire and the armed forces of the Forces nouvelles reaffirm their commitment to the Joint Declaration of 4 July 2003 putting an end to the war;
- 2. By noon on 5 December 2003: completion of withdrawal of units from Allangouassou and Bania as well as of all other units stationed in the zone of confidence;
- 3. On 7 December 2003: release of all detained soldiers;
- 4. On 10 December 2003: quadripartite meeting at Bouaké to establish a timetable effective from 15 December 2003 for the:
  - removal of unauthorized checkpoints and barriers;
  - administration of the zone of confidence;
  - cantonment of troops;
  - collection of light arms and heavy weapons.
- 5. On 12 December 2003: meeting of the Technical Operations Unit (CTO) of the National Committee for the Reunification of Côte d'Ivoire in Abidjan to finalize the timetable of activities.
