I. Introduction

1. Under agenda item 121, the Fifth Committee considered the proposed programme budget for the biennium 2004-2005. The Committee recommends a gross appropriation of \$3,160,860,300 and an estimate for income (other than income derived from staff assessment) of \$28,800,100. The net expenditure for the biennium 2004-2005 is thus estimated at 3,132,060,200 dollars.¹
2. With regard to the Working Capital Fund, the Fifth Committee recommends that the Fund should be at the level of \$100 million.
3. The Fifth Committee also recommends an estimate of \$382,270,700 as staff assessment for transfer in the course of the biennium 2004-2005 to the Tax Equalization Fund, from which credits are distributed to Member States in accordance with General Assembly resolution 973 (X) of 15 December 1955.
4. For its examination of the proposed programme budget for the biennium 2004-2005, the Fifth Committee had before it, as basic documents, the proposed programme budget for the biennium 2004-2005 submitted by the Secretary-General,² the first report of the Advisory Committee on Administrative and Budgetary Questions on the proposed programme budget for the biennium 2004-2005³ and the report of the Committee for Programme and Coordination on the work of its forty-third session.⁴ Revised estimates and programme budget implications affecting various appropriation sections were subsequently considered on the basis of reports of the Secretary-General and of the Advisory Committee on Administrative and Budgetary Questions.
5. In accordance with the guidelines for the contingency fund as annexed to General Assembly resolution 42/211 of 21 December 1987, the Fifth Committee, at its __ meeting, on __ December 2003, considered a consolidated statement of programme budget implications and revised estimates that were subject to the criteria for the use of the contingency fund (A/C.5/58/__) and the corresponding report of the Advisory Committee. The Fifth Committee, after due consideration, decided upon a number of individual changes in respect of programme budget implications and revised estimates totalling \$9,857,000.
6. The debate on the proposed programme budget for the biennium 2004-2005 was held at the __ meetings, on __ October and __ December 2003. The debate is reflected in the relevant summary records (see A/C.5/58/SR.__).
7. Introductory statements were made by the Secretary-General, the Chairman of the Advisory Committee on Administrative and Budgetary Questions and the Chairman of the Committee for Programme and Coordination at the __ meeting, on __ October 2003 (see A/C.5/58/SR.__).

9. At the __th meeting, on __ December 2003, draft resolution A/C.5/58/L.48, entitled "Questions relating to the proposed programme budget for the biennium 2004-2005", was introduced. The Committee adopted the draft resolution without a vote (see A/C.5/58/L.56 (Part II), para. 59, draft resolution I).

10.
