#### 联合国援助酷刑受害者自愿基金

#### 秘书长的报告

#### 摘要

本报告更新了秘书长提交大会的关于联合国援助酷刑受害者自愿资金活动情况的报告(A/58/284)所载的资料。该报告所载资料阐述了董事会在 2003 年 5 月 12 日至 28 日第二十二届会议上通过的<sup>1</sup>建议以及最近的趋势，尤其述及通过基金为酷刑受害者及其亲属提供的援助以及这种援助对于受惠者的影响。本报告提供的资料阐述了自提交大会的报告发表以来所收到的捐款和认捐款额、2004 年所需经费以及董事会的筹资活动。报告还介绍了第二十二届会议通过的<sup>2</sup>建议执行情况以及最近开展的各项活动。三月份拟向委员会提交一份简短的增编，说明可供董事会第二十三届会议使用的最新捐款款额。

## 一、年度报告

1. 根据大会为管理联合国援助酷刑受害者自愿基金所作的安排，秘书长向大会提交了年度报告，说明现有的资金、认捐款额和已收到的捐款以及基金支付的款额(1981年12月16日第36/151号决议)。

2. 2003年12月1日定稿的本报告补充并更新了2003年8月14日根据议程项目119(a)编写的，提交大会第五十八届会议的年度报告(A/58/284)。报告是根据委员会第2003/32号决议提交的。

## 二、对基金运转情况的评估

3. 按照人权委员会第2003/32号决议第39段的要求，业已采取步骤着手“按照联合国规则和条例，对基金的运转、特别是对从基金活动中得出的教训和最佳做法作独立评估，以期进一步增强基金的有效性”。评估将由内部监督事务厅在两名外聘顾问参与下进行。为此，于2003年11月26日向各会员国送交了职权范围草案，并将于2003年12月12日与有关代表团举行会议，商讨这份文件。评估将审查基金总部及实地活动的影响。即将视察其项目得到资助的所有区域以及一个跨部门项目，以确保进行尽可能全面的审查。将向人权委员会第六十届会议提交临时评估报告，并向人权委员会第六十一届会议提交最后评估报告。

## 三、财务状况

### A. 自董事会上届会议以来已交付的赠款

4. 基金董事会第二十二届会议(2003年5月12日至28日)建议为世界各地的项目捐赠略超过700万美元的款项，为酷刑受害者及其家庭提供医疗、心理、社会、法律和资金援助。人权事务代理高级专员以秘书长的名义批准了上述建议。截至2003年12月1日，根据高级专员办事处掌握的资料，自董事会上届会议以来已支付的赠款为520万美元。一旦理事会或基金秘书处从各有关组织获得所要求的进一步的资料并认为令人感到满意，董事会下届会议即可支付尚待拨出的数额为180万

美元的赠款。基金 2003 年资助的组织一览表载于附件一。同时，已另行预留一笔数额为 50,000 美元的经费，拟支助在董事会下届会议(2004 年 5 月 10 日至 27 日)之前可能会面临财务困难的组织，或用于没有此类资助项目的国家内酷刑受害者提出的个别请求。

#### B. 已支付的捐款

5. 秘书长提交大会的报告(A/58/284,第 9 段,表 1)详述了董事会第二十二届会议及时收到可供拨出的捐款。2003 年 12 月 1 日,按高级专员办事处现有资料编制的表 1 表明了第二十二届会议之前联合国财务处未正式记录但事后入册的捐款数额。董事会将在第二十三届会议上将上述捐款情况与 2004 年 5 月 10 日前正式记录的其他捐款一并考虑。2003 年 12 月 1 日后支付的捐款将载于本报告增编。

7. 联合国财务处 2004 年 5 月 10 日之后正式记录的任何捐款将存入下届会议(2005 年 5 月)的账户。董事会根据实际支付和财务处基金账户已记录的捐款提出了资助建议；理事会不考虑认捐情况。

### 四、筹 资

8. 正如大会 2002 年 12 月 18 日第 57/200 号决议、委员会 2003 年 4 月 23 日第 2003/32 号决议(第 34 段)、禁止酷刑委员会、基金董事会、人权委员会酷刑问题特别报告员以及联合国人权事务高级专员在 2003 年 6 月 26 日联合国支持酷刑受害者国际日发表联合声明和致辞，表示感谢并赞赏向基金捐款的各国政府、组织及个人。联合国各机构，尤其是关注与酷刑有关问题的机构，鼓励曾向基金捐款的捐助方继续提供捐助，可能时应大幅增加捐款额，以顾及日益增长的援助要求。联合国各机构还呼吁各国政府、组织和个人定期向基金捐款，可能时最好于每年 3 月 1 日前提供年度捐款，以便正式记录他们的捐款，供董事会会议之后进行调拨，但无论如何都应在理事会年度会议之前捐出。

9. 大会设立本基金的第 36/151 号决议授权董事会鼓励并争取捐款和认捐。大会还请秘书长为董事会提供其可能需要的一切协助。在通常于理事会届会最后一天

举行的年度会议上，董事会董事有机会向各国常驻联合国日内瓦办事处代表团的代表争取捐款。委员会已确定了惯例，在委员会三、四月份届会议期间邀请当时可能在日内瓦的董事会主席或董事与会，按有关议程向委员会提交有关基金财务状况的最新报告，并鼓励与会各方在董事会 5 月份会议之前支付捐款。2003 年 4 月 8 日，秘书处代表主席宣读了他的发言。

10. 按照 2002 年董事会发起的基于针对捐助方更具区域性倾向做法的筹资战略框架，将安排第二十二届会议主席与五个区域集团成员国在 2004 年初进行会晤。

## 五、2004 年需求估算

### A. 收到的资助请求和提供的赠款(2000 至 2004 年)

11. 为了考虑到赠款请求与可拨赠款的现有资金(参见以下表 3)之间的差别，并考虑到提出要求筹资的项目不断更新以及每年拨出的赠款金额不断增加，理事会连续几年一直建议将所有的赠款差不多全部拨出。因此，下一年所剩的资金仅为强制性准备金。根据适用于人道主义目的自愿捐助的联合国规则，强制性准备金为现有赠款额的 15%(参见 A/55/178,第 11 段)。

## B. 2004 年估算需求

12. 根据收到的 2003 年资助请求(相当于 1,300 万美元), 理事会估算下届会议将需要 1,400 万美元来支付所有预期的新资助要求, 因为自 1998 年以来, 所要求的资助款额每年增长 100 万美元。

13. 截至 2003 年 12 月 1 日, 自上届董事会届会以来, 已支付的新捐款总额仅为 202,365 美元(参见以上表 1), 而同期征得的认捐额仅为 82,606 美元(参见以上表 2)。

## 六、如何捐款

14. 给基金的所有捐款均应写明: “payee: United Nations Voluntary Fund for Victims of Torture, account CH”。付款既可通过银行转账: (a) 如为美元或其他货币请转入“United Nations Geneva General Fund”账户, 账号 485001802, J.P. ## 七、结论和建议

15. 依照大会、人权委员会、秘书长、人权事务高级专员和基金董事会的呼吁, 请各捐助方在 2004 年 3 月 1 日之前支付给基金的捐款, 使理事会得以在 2004 年 5 月举行的第二十二届会议上考虑到这些捐款。

16. 大会、委员会、秘书长和高级专员以及董事会还促请经常提供捐助的捐助方在可能时增加各自的捐款额，以便董事会可有资金满足酷刑受害者及其亲属不断增长的需求。

17. 董事会强烈鼓励未曾为基金捐款的各国政府最好在 2004 年 3 月 1 日前为基金提供首次捐款。
