Decisions

2003/201 E

Elections to subsidiary bodies of the Economic and Social Council

At its 51st plenary meeting on 31 October 2003, the Economic and Social Council took the following action with regard to vacancies in its subsidiary bodies:

Commission on Science and Technology for Development

The Council elected **Greece** to fill a postponed vacancy for a term beginning on the date of election and expiring on 31 December 2006.

The Council further postponed the election of two members from Western European and other States for a term beginning on the date of election and expiring on 31 December 2004.

Intergovernmental Working Group of Experts on International Standards of Accounting and Reporting

The Council elected **Ethiopia, Italy, Malta and Portugal** to fill postponed vacancies for a term beginning on the date of election and expiring on 31 December 2005.

The Council also elected **Benin, Brazil, Cyprus, Poland and Thailand** to fill postponed vacancies for a three-year term beginning on 1 January 2004.

The Council postponed the election of two members from Asian States, two members from Latin American and Caribbean States and three members from Western European and other States for a term beginning on the date of election and expiring on 31 December 2005, and two members from Asian States, one member from Eastern European States and two members from Latin American and Caribbean States for a three-year term beginning on 1 January 2004.

International Narcotics Control Board

The Council elected Melvyn **Levitsky** (United States of America) for a term beginning on the date of election and expiring on 1 March 2007, to fill a vacancy arising from the resignation of Rosa Maria **del Castillo** (Peru).

Executive Board of the International Research and Training Institute for the Advancement of Women

In accordance with its resolution 2003/57 of 24 July 2003, the Council elected the following members to the newly established Executive Board for a term beginning, exceptionally, on the date of election and expiring on 31 December 2006: **El Salvador, Mexico, the Philippines and Spain**.

The Council postponed the election of two members from African States, one member from Asian States, two members from Eastern European States and one member from Western European and other States for a term beginning on the date of election and expiring on 31 December 2006.

Committee for the United Nations Population Award

The Council elected **Belarus, Cameroon, Guyana** and the **Islamic Republic of Iran** to fill postponed vacancies for a three-year term beginning on 1 January 2004.

The Council postponed the election of one member from Latin American and Caribbean States for a three-year term beginning on 1 January 2004.

Governing Council of the United Nations Human Settlements Programme

The Council elected **Israel** to fill a postponed vacancy for a four-year term beginning on 1 January 2004.

Programme Coordination Board of the Joint United Nations Programme on Human Immunodeficiency Virus/Acquired Immunodeficiency Syndrome (UNAIDS)

The Council elected **France** for a one-year term beginning on 1 January 2004 to replace **Germany**, which was resigning its seat on the Board.

Executive Board of the World Food Programme

The Council elected **Greece** and **Norway** to fill postponed vacancies for a three-year term beginning on 1 January 2004.

Ad Hoc Advisory Group on Burundi

At its 50th plenary meeting, on 22 August 2003, the Economic and Social Council, recalling its resolutions 2002/1 of 15 July 2002 on the establishment of an ad hoc advisory group on African countries emerging from conflict and 2003/16 of 21 July 2003, by which it established the Ad Hoc Advisory Group on Burundi, decided:

(a) To appoint the Permanent Representatives to the United Nations of Belgium, Burundi, Ethiopia, France, Japan and South Africa to the Ad Hoc Advisory Group on Burundi and to appoint the Permanent Representative of South Africa to the United Nations as Chairperson of the Group;

(b) That the Ad Hoc Advisory Group on Burundi will invite the participation in its work of the Permanent Representative of Guatemala to the United Nations, in his capacity as President of the Economic and Social Council, and the Permanent Representative of Angola to the United Nations, in his capacity as Chairperson of the Ad Hoc Working Group of the Security Council on Conflict Prevention and Resolution in Africa;

(c) That the Ad Hoc Advisory Group will examine the humanitarian and economic needs of Burundi and review relevant programmes of support and prepare recommendations for a long-term programme of support, based on Burundi's development priorities, through the integration of relief, rehabilitation, reconstruction and development into a comprehensive approach to peace and stability, as well as provide advice on how to ensure that the assistance of the

international community is adequate, coherent, well-coordinated and effective and promotes synergy;

(d) To request the Ad Hoc Advisory Group on Burundi, taking into consideration the unique character and needs of the situation in Burundi, to submit a report on its recommendations to the Council by mid-January 2004.

Participation of an intergovernmental organization in the work of the Economic and Social Council

At its 51st plenary meeting, on 31 October 2003, the Economic and Social Council decided to grant observer status with the Council to the Helsinki Commission, an intergovernmental organization.

Change of date of the eleventh meeting of the Ad Hoc Group of Experts on International Cooperation in Tax Matters

At its 51st plenary meeting, on 31 October 2003, the Economic and Social Council decided to endorse the decision to change the date of the eleventh meeting of the Ad Hoc Group of Experts on International Cooperation in Tax Matters from 10 to 14 November 2003 to 15 to 19 December 2003.

Implementation of General Assembly resolutions 50/227 and 52/12 B

At its 52nd plenary meeting, on 19 December 2003, the Economic and Social Council decided to defer consideration of the item "Implementation of General Assembly resolution 50/227 and 52/12: Consolidated report on the work of the functional commissions of the Economic and Social Council in 2003" to the organizational session of the Economic and Social Council in 2004.

United Nations Forum on Forests

At its 52nd plenary meeting, on 19 December 2003, the Economic and Social Council decided that the ad hoc expert group of the United Nations Forum on Forests on consideration, with a view to recommending the parameters of a mandate for developing a legal framework on all types of forests, would meet in New York from 6 to 10 September 2004.

Sustainable development

At its 52nd plenary meeting, on 19 December 2003, the Economic and Social Council decided to defer consideration of chapter IV of the report of the Committee

for Development Policy on its forty-first session (E/2003/33) and chapter I.B of the report of the Commission on Sustainable Development on its eleventh session (E/2003/29) to the organizational session of the Economic and Social Council in 2004.
