Studies at the University of Naples; Doctor of Law in 1929; Doctor of Political Science in 1930; won a scholarship to the Academy of Law at The Hague in 1935.

Born at Belgrade on 10 November 1901.

### University degrees

Bachelor of Law (Belgrade 1924). Doctor of Law (State diploma, Paris, 1927).

### Career

Served on the Belgrade Faculty of Law from 1928 (qualified professor in 1929, visiting professor in 1933, full professor since 1940 and Dean in 1945-1946). Has taught international private and international public law.

Inducted into the armed forces in 1941. Prisoner of war from 1941 to 1945.

After the Liberation (1945), served in the diplomatic service, simultaneously with his professorship (from 1946 to the end of 1962) as minister plenipotentiary (1946), embassador (since 1950); headed many ad hoc missions, head of the Permanent Mission with the Allied agency for German reparations (1946), Director of the International Political and Economic Institute in Belgrade (1947-1949), Chief Legal Adviser in the Secretariat of State for Foreign Affairs, Belgrade (1949-1962); Member of the United Nations Advisory Group on the archives of the League of Nations.

Member of Yugoslav delegations to the United Nations General Assembly (continuously from 1946 to 1958); to the Paris Peace Conference (1945); to the Danube Conference (Belgrade, 1948) etc.; agent of the Yugoslav Government in the International Court of Justice on the question of admission of new Members to the United Nations.

Took an active part in the codification of international law: member of the United Nations ad hoc committee for drafting the statute of the International Law Commission (1947); member of the International Law Commission since 1957, its Vice-Chairman in 1963, its first Vice-Chairman and Chairman of the Drafting

Committee in 1964, Chairman of the International Law Commission in 1965-1966, Special Rapporteur of the Committee on Special Missions (1963, 1964, 1965 and 1966). Head of the Yugoslav delegation to the Geneva Conferences on the Law of the Sea (1958 and 1960) and to the Vienna conferences on diplomatic (1961) and consular (1963) relations, etc.
