EUROPEAN AGREEMENT ON IMPORTANT INTERNATIONAL COMBINED TRANSPORT LINES AND RELATED INSTALLATIONS (AGTC)

New amendment proposals to the AGTC Agreement

Note by the secretariat

A. AMENDMENT PROPOSAL

1. Based on documentation prepared by the Russian Federation (TRANS/WP.24/2003/9 and Add.1), the Working Party, at its fortieth session (29 September to 1 October 2003), welcomed and approved in principle five newly proposed lines extending the AGTC network to Nakhodka Vostochnaya, Kazan, Kotelnich, Kurgan and Kaliningrad. It requested the secretariat, to finalize, in cooperation with the Russian Federation, the required amendment proposals to Annex I of the AGTC Agreement and to identify also relevant installations on the newly proposed lines for formal adoption by Contracting Parties at its next session (TRANS/WP.24/101, para. 12).

2. The secretariat, in cooperation with the Russian Federation, has prepared the following amendment proposals to the AGTC Agreement for consideration by the Working Party in accordance with Article 15 of the AGTC Agreement. Since by the time of finalizing this document not all relevant information and data required for inclusion into Annexes I and II of the AGTC Agreement could be obtained, the secretariat will issue, before the session of the Working Party, an addendum to the present document containing also possibly a map with the proposed lines and installations.

B. AMENDMENT PROCEDURE

3. In accordance with paragraph 2 of Articles 14, 15 and 16 of the AGTC Agreement, any amendment proposed by a Contracting Party to the Agreement should be considered by the UNECE Working Party on Combined Transport. If, in accordance with paragraph 3 of Articles 14, 15 and 16 of the AGTC Agreement, the amendment(s) is (are) adopted by the Contracting Parties present and voting, the secretariat would transmit the amendment proposal(s) to the Secretary-General of the United Nations in his capacity as depositary of the Agreement.

4. In order to formally notify the depositary of any amendment proposal adopted by the Working Party, it is necessary for countries to be Contracting Parties to the Agreement. At its nineteenth session, the Working Party had felt that, in case such amendments referred to annexes I and II to the Agreement, countries directly concerned, as defined in Article 15, paragraph 3 of the Agreement, should be consulted on an informal basis by the Contracting Parties proposing such amendments <u>before</u> any such amendment proposals were transmitted to the Secretary-General of the United Nations. The secretariat had been requested to provide all necessary assistance to facilitate such consultation (TRANS/WP.24/59, para. 35).

5. In accordance with Article 15 of the AGTC Agreement, the Working Party may wish to consider and adopt the above amendment proposals and request the secretariat to transmit them to the United Nations Office of Legal Affairs for necessary depositary action.

C. BACKGROUND INFORMATION

6. At present, the <u>AGTC Agreement</u> contains the following railway lines and terminals of importance for international combined transport on the territory of the Russian Federation:
