INFORMATION CIRCULAR N°. 4

Subject: Revised salary scales for staff in the General Service and Language Teacher categories

- 1. The current procedure for effecting interim adjustments of the salary scales for staff in the General Service and related categories at Geneva calls for an adjustment in the net salaries of such staff whenever the consumer price index (CPI) for Geneva moves by 5 per cent by reference to the index used at the time of the previous adjustment or every 12 months, whichever comes first. In order to obtain the amount of the net salary increase, the CPI movement is then adjusted by a factor of 0.9 per cent to account for local taxation. In line with the established practice, 12-months CPI movement is measured two months in advance of the reference date of the salary scale (currently 1 January).
- 2. In application of the above-mentioned procedure and based on 12-months CPI movement for the period October 2002 October 2003, the net salaries of staff in the General Service and Language Teacher categories have been adjusted upwards by 0.70 per cent, with effect from 1 January 2004. The revised scales are attached as annexes I and III to the present circular.

General Service

- 3. The revised salary scales for the General Service category (Annex I) are applicable to all staff regardless of the date of recruitment.
- 4. Revised gross pensionable salaries effective 1 January 2004 are lower than those in effect as of 1 January 1994. Therefore, for those staff members on board prior to 1 September 1995 gross pensionable salaries effective 1 January 1994 (Annex II) will continue to apply for the purpose of computing pension contributions and benefits until overtaken as a result of subsequent revisions to the scales reproduced in Annex I.
- 5. The dependency and language allowances remain unchanged.

Language Teachers

- 6. The revised gross and net salary scales effective 1 January 2004 apply to all staff in the Language Teacher category irrespective of the date of recruitment. They are reproduced in Annex III.
- 7. The dependency allowances remain unchanged.

Payroll implementation of revised scales

8. The implementation of the revised scales, which are contained in the annexes to the present circular, will be reflected in the February 2004 payroll with retroactive effect to 1 January 2004.
