تقرير اللجنة الفرعية لتعزيز وحماية حقوق الإنسان: انتخاب الأعضاء

مذكرة من الأمين العام\*

-١ طبقاً لقرار مجلس الاقتصادي والاجتماعي رقم ٣١ (٤٤-١٣٣٤) المؤرخ ٣١ أيار/مايو ١٩٦٨ و٣٥/١٩٨٦ المؤرخ ٢٣ أيار/مايو ١٩٨٦، ومقرريه رقم ٢١/١٩٧٨ المؤرخ ٥ أيار/مايو ١٩٧٨ و١٠٢/١٩٨٧ المؤرخ ٦ شباط/فبراير ١٩٨٧ انتخبت لجنة حقوق الإنسان في دورتها الرابعة والأربعين، باقتراع سري، ٢٦ عضواً في اللجنة الفرعية لمنع التمييز وحماية الأقليات (التي أعيدت تسميتها في عام ١٩٩٩ باسم اللجنة الفرعية لتعزيز وحماية حقوق الإنسان) من بين الخبراء الذين رشحتهم الدول الأعضاء في الأمم المتحدة على النحو التالي: (أ) سبعة أعضاء من الدول الأفريقية؛ (ب) خمسة أعضاء من الدول الآسيوية؛ (ج) ثلاثة أعضاء من دول أوروبا الشرقية؛ (د) خمسة أعضاء من دول أمريكا اللاتينية؛ (ه) ستة أعضاء من دول أوروبا الغربية ودول أخرى.

-٢ ووفقاً لقرار مجلس ٣٥/١٩٨٦، ينتخب أعضاء اللجنة الفرعية لفترة أربع سنوات، وينتخب نصف أعضاء اللجنة الفرعية والعدد المقابل من المنشآت، إن وجد، مرة كل عامين. وقام رئيس الدورة الرابعة والأربعين للجنة حقوق الإنسان بإجراء القرعة لانتخاب الأعضاء، وعند الاقتراع، العدد المناظر من المنشآت الذين تنتهي فترتهم ولا يتم بعد عامين وفقاً للنمط التالي: ثلاثة أعضاء من الدول الأفريقية؛ وثلاثة أعضاء من الدول الآسيوية؛ وعضو واحد من دول أوروبا الشرقية؛ وثلاثة أعضاء من دول أمريكا اللاتينية؛ وثلاثة أعضاء من دول أوروبا الغربية ودول أخرى.

\* يصدر المرفق الأول بهذه الوثيقة، نظراً لطوله، كما ورد باللغات الأصلية فقط (الإسبانية وإنكليزية والفرنسية).

-٣ وفي الأعوام ١٩٩٠ و ١٩٩٤ و ١٩٩٦ و ١٩٩٨ و ٢٠٠٢ و ٢٠٠٠ ، عندما انتهت فترة ولاية نصف أعضاء اللجنة الفرعية، أجرت لجنة حقوق الإنسان في دورتها السادسة والأربعين والثانية والخمسين والرابعة والخمسين وال السادسة والثانية والخمسين انتخابات جديدة لأعضاء اللجنة الفرعية ومناويهم\* .

-٤ -ويتضمن المرفق الثاني قائمة بأسماء الأعضاء الحاليين في اللجنة الفرعية.  
-٥ ولما كانت مدة ولاية نصف أعضاء اللجنة الفرعية قد انقضت مرة أخرى، فإن لجنة حقوق الإنسان مدعوة في دورتها الستين لإجراء انتخاب جديد لأعضاء اللجنة الفرعية والمناوبيين وفقاً للنمط التالي: أربعة أعضاء من الدول الأفريقية؛ وعضوان من الدول الآسيوية؛ وعضوان من دول أوروبا الشرقية؛ وعضوان من دول أمريكا اللاتينية؛ وثلاثة أعضاء من دول أوروبا الغربية ودول أخرى.

-٦ وفي قرار لجنة حقوق الإنسان ٥٩/٢٠٠٣ المؤرخ ٢٤ نيسان/أبريل ٢٠٠٣ ، طلبت اللجنة إلى الدول لدى ترشيح وانتخاب أعضاء اللجنة الفرعية ومناويهم:

- (أ) أن تدرك الحرص الشديد على ضمان استقلالية هذه الهيئة واعتبارها كذلك؛
- (ب) ألا تغيب عن بالها ضرورة التوفيق المتوازن بين فوائد الاستمرارية وأهمية التجديد؛
- (ج) أن تخذل أعضاء يشهد لهم بالخبرة في مجال حقوق الإنسان؛
- (د) أن تقدم الترشيحات، إن أمكن، قبل بداية الدورة التي سيتخبون فيها بشهرین على الأقل كي يتسلى لأعضاء اللجنة أن يقيّموا مؤهلات المرشحين واستقلاليتهم تقريباً دقيقاً.

وبناءً على الإشارة إلى أن اللجنة الفرعية كانت قد استرعت انتباها لجنة حقوق الإنسان بوجه خاص، في قرارها ٣٢/١٩٨٧ إلى توصية الفريق العامل المعنى بأشكال الرق المعاصرة بأن تحاول لجنة حقوق الإنسان إقناع جميع الحكومات بترشيح مزيد من النساء لانتخابهن في اللجنة الفرعية.

-٧ وفيما يتعلق بتنمية المناوبين، اعتمد المجلس الاقتصادي والاجتماعي القرار ٣٢/١٩٨٣ الذي قرر فيه أنه:

"بصرف النظر عن الفقرة ٢ من المادة ١٣ من النظام الداخلي للجان الفنية للمجلس الاقتصادي والاجتماعي، تسرى القواعد التالية من الآن فصاعداً على اللجنة الفرعية لمنع التمييز وحماية الأقليات:

(أ) يجوز أن تصبح تسمية المرشح لعضوية اللجنة الفرعية تسمية خبير من نفس الجنسية ينتخب في آن واحد مع المرشح لعضوية ويمكن أن يعمل مؤقتاً بصفة مناوب له في حالة عدمتمكن العضو من الحضور؛

(ب) تكون المؤهلات المطلوبة توافرها في الأعضاء المناوبين هي نفسها المطلوبة أن تتوافر في الأعضاء؛

(ج) لا يجوز لأي شخص غير الخبير المنتخب كعضو مناوب أن يعمل كعضو مناوب لأحد الأعضاء، عملاً بالفقرة الفرعية (أ) أعلاه".

-٨ وحتى ٢٤ كانون الأول/ديسمبر ٢٠٠٣، تلقى الأمين العام ترشيحات لانتخاب أعضاء اللجنة الفرعية من حكومات إثيوبيا وآيسلندا وبليزيكا وبنما وبيرو وتونس والجزائر والجمهورية العربية السورية وجمهورية كوريا وجمهورية مولدوفا ورومانيا وسيراليون وكوبا ومصر والمغرب وهنغاريا والولايات المتحدة الأمريكية واليابان.

-٩ وستعمم الرسائل والترشيحات الأخرى التي ترد من الحكومات كإضافات إلى هذه الوثيقة.

-١٠ وترتدى أدناه قائمة بالترشيحات التي وردت حتى الآن، ويتضمن المرفق الأول بيانات السير الذاتية للمرشحين.
