
## **Calendar of conferences and meetings of the United Nations** for the biennium 2004-2005

#### Note by the Secretariat

1. The Secretariat is circulating herewith, as an annex to the present note, the calendar of conferences and meetings of the United Nations for the biennium 2004-2005 as adopted by the General Assembly in section I of its resolution 58/250 of 23 December 2003, taking into account other resolutions and decisions adopted by the Assembly at its fifty-eighth session.

2. The calendar of conferences and meetings of the principal organs of the specialized agencies, the International Atomic Energy Agency and treaty bodies established under the auspices of the United Nations for the biennium 2004-2005 is also contained in the annex.

3. In section I, paragraph 4, of its resolution 58/250, the General Assembly noted with satisfaction that the Secretariat had taken into account the arrangements it had requested at its previous sessions concerning Orthodox Good Friday, and requested all intergovernmental bodies to observe those decisions when planning their meetings. As required, the decision to avoid holding meetings on 29 April 2005 should be brought to the attention of the intergovernmental or expert bodies whose work programmes include those dates. (In 2004, the United Nations holiday in observance of Good Friday, 9 April, falls on the same day as the Orthodox Good Friday.)
