### **Acreditación de las organizaciones no gubernamentales y otros grupos importantes para participar en la Reunión Internacional encargada de examinar la ejecución del Programa de Acción para el desarrollo sostenible de los pequeños Estados insulares en desarrollo y su reunión preparatoria**

#### **Nota de la Secretaría\*\***

1. En su resolución 58/213, la Asamblea General decidió que la acreditación y la participación de los grupos principales, incluidas las organizaciones no gubernamentales, en la Reunión Internacional encargada de examinar la ejecución del Programa de Acción para el desarrollo sostenible de los pequeños Estados insulares en desarrollo, se hiciera de conformidad con el artículo 65 del reglamento provisional de la Reunión Internacional que figura en la nota del Secretario General (A/58/567 y Corr.1). En la misma resolución, la Asamblea decidió que las organizaciones no gubernamentales cuyas actividades tuvieran que ver con el tema de la Reunión Internacional y que no estuvieran acreditadas por el Consejo Económico y Social podrían presentar solicitudes para participar en calidad de observadores en la Reunión Internacional, así como en su reunión preparatoria, a reserva de la aprobación de la reunión preparatoria de composición abierta.

2. El Departamento de Asuntos Económicos y Sociales, por conducto de su División de Desarrollo Sostenible, pidió a todas las organizaciones no gubernamentales y a otros grupos importantes que no estuvieran acreditados y desearan asistir a la Reunión Internacional y a su reunión preparatoria que presentaran sus solicitudes, junto con los materiales complementarios de rigor, para su evaluación. Con el apoyo del Servicio de Enlace de las Naciones Unidas con las Organizaciones no Gubernamentales y otros órganos pertinentes, según procediera, la División examinó la pertinencia de la labor de cada solicitante, basándose en sus antecedentes y su participación en las cuestiones relativas al desarrollo sostenible, en particular el proceso de seguimiento de la Conferencia de las Naciones Unidas sobre el Medio Ambiente y el Desarrollo y la Conferencia Mundial sobre el Desarrollo Sostenible de los Pequeños Estados Insulares en Desarrollo.

3. La División indicó que recomendaría a la Comisión sobre el Desarrollo Sostenible la acreditación de las organizaciones solicitantes cuyos objetivos declarados fueran legítimos y cuyas actividades fueran pertinentes para la labor de la Reunión Internacional en función de una evaluación basada en la información que hubiera proporcionado cada organización. En el caso de una recomendación contraria a la acreditación, la División daría a conocer sus razones a la Comisión, y presentaría sus recomendaciones sobre todas las solicitudes de acreditación a los Estados Miembros dos semanas antes del comienzo de la reunión preparatoria.

4. La División ha recibido y evaluado las solicitudes completas presentadas antes del plazo final del 1º de marzo de 2004, que serán examinadas por la Comisión en su 12º periodo de sesiones, en el marco de la reunión preparatoria de la Reunión Internacional que se celebrará del 14 al 16 de abril de 2004. En el anexo figuran la lista de las organizaciones no gubernamentales y otros grupos importantes cuya acreditación la División recomienda y la lista de las organizaciones y grupos cuya acreditación no recomienda.
