LETTER DATED 25 MARCH 1968 FROM THE PERMANENT REPRESENTATIVE OF MONGOLIA TO THE UNITED NATIONS ADDRESSED TO THE SECRETARY-GENERAL

On the instructions of my Government, I have the honour to transmit herewith a message from the Chairman of the Presidium of the Great People's Khural of the Mongolian People's Republic, Jhamsrangin Sambu, dated 23 March 1968, addressed to His Majesty King Hussein of Jordan on the subject of the new violation by Israel ruling circles of the resolution of the United Nations Security Council on the cease-fire in the Middle East.

In drawing this to your attention, I should be grateful if you would take steps to circulate this message as a document of the General Assembly and of the Security Council.

Accept, Sir, the assurances of my highest consideration.

To His Majesty Hussein ibn Talal, Amman.

Your Majesty,

The Government of the Mongolian People's Republic and the entire Mongolian people have learned with deep indignation of the new barbarous attack on Jordan by Israel militarists and the scandalous violation of the resolution of the United Nations Security Council on the cease-fire in the Middle East and resolutely condemn the new criminal actions of Israel ruling circles and their imperialist patrons as a brazen challenge to the people of the Arab countries and to all peace-loving forces.

On the instructions of our Government, I assure the Jordanian people of the sincere solidarity of the Mongolian people and offer our deep sympathy to the victims of the new aggression.

I take this opportunity to assure you that the Mongolian people and Government will continue consistently to support the just struggle of the Arab peoples to defend their freedom and independence, to restore peace and to achieve a political settlement in the Middle East.

The Government of the Mongolian People's Republic strongly demands that Isarel ruling circles cease the new aggression immediately and unquestioningly implement the provisions of the resolution of 22 November 1967 of the United Nations Security Council.

I am confident that the struggle of the peoples of Jordan and the other Arab countries against imperialism and aggression will be crowned with success and will make an important contribution to the common cause of the maintenance of peace throughout the world.

Accept, Your Majesty, the assurances of my highest consideration.
