1. This document, which is part of a series of research aids to the application and interpretation of the UNCITRAL Model Law on International Commercial Arbitration (1985), covers all Model Arbitration Law cases having appeared in CLOUT documents A/CN.9/SER.C/ABSTRACTS/1-38. The index is based on the classification and keyword system introduced in the UNCITRAL Thesaurus of the Model Law on International Commercial Arbitration (document A/CN.9/SER.C/INDEX/4).
2. Court and arbitral decisions are indexed by CLOUT case number; MAL article number; keyword; jurisdiction; and date. The keywords include synonymous terms for broad concepts, so that the same issue within a decision may be located with either keyword.
3. For technical reasons, this index has been issued under a single document number with addenda. Updated indices will be published periodically as subsequent revisions of this document.
