LETTER DATED 21 FEBRUARY 1967 FROM THE PERMANENT REPRESENTATIVE OF CAMBODIA ADDRESSED TO THE PRESIDENT OF THE SECURITY COUNCIL

On instructions from my Government and further to my letter No. 5637 of 8 December 1966, I have the honour to bring to your attention, for the information of members of the Security Council, a list of violations of Cambodian air space by the United States-Scuth Viet-Namese air forces during October 1966.

1 October 1966

At 7.30 a.m. two jet aircraft flew about 1,000 metres inside the border over the village of Anlong Krès, Khum of Daun Tey, Srok of Thbaung Khmum, Province of Kompong-Cham;

At the same time two jet aircraft flew about 9,500 metres inside the border over the post at Krabao, Srok of Peamchor, Province of Prey-Véng;

At ll a.m. a twin-engined aircraft flew over the centre of Snuol, Srok of Snuol, Province of Kratié;

At 12.40 p.m. a helicopter flew at low altitude over the same area;

At 3.10 p.m. a twin-engined aircraft flew about 1,000 metres inside the border over the village of Anlong Krès, Khum of Daun Tey, Srok of Thbaung Khmum, Province of Kompong-Cham.

2 October 1966

At 1 p.m. a twin-engined aircraft flew at low altitude over the base at Labansiek, Srok of Lumphat, Province of Rattanakiri.

6 October 1966

At 1.30 a.m. a jet aircraft flew about 2,000 metres inside the border over the Provincial Guard post at Koh Sampeou, Khum of Koh Sampeou, Srok of Peamchor, Province of Prey-Véng;

At 2.20 a.m. a jet aircraft flew over the Kompong Trach district, Srok of Romeas Hèk, Province of Svay-Rieng;

At 1 p.m. a reconnaissance aircraft flew at high altitude over the Provincial Guard post at Khsim, Khum of Khsim, Srok of Snuol, Province of Kratié;

At 11.30 p.m. a jet aircraft flew at low altitude over the post at Angkor Borey, Srok of Prey Krabas, Province of Takéo.

7 October 1966

At 9.10 a.m. a jet aircraft flew at high altitude over the village of Preah Sdau, Khum of Trapeang Phlong, Srok of Mimot, Province of Kompong-Cham;

At the same time an F-105 jet aircraft flew at high altitude over the post at Krek, Khum of Krek, Srok of Mimot, Province of Kompong-Cham;

At 7.10 p.m. a jet aircraft flew at high altitude over the villages of Krek and Trapeang Pring, Khum of Krek and Trapeang Phlong, Srok of Mimot, Province of Kompong-Cham;

At 7.45 p.m. an aircraft flew over the villages of Ampil and Koki, Srok of Romeas Hèk, Province of Svay-Rieng;

At 8.10 p.m. a jet aircraft flew over the village of Thlok Trach, Khum of Krabao, Srok of Mimot, Province of Kompong-Cham.

9 October 1966

At 9 a.m. three reconnaissance aircraft flew over the Phum of Cheam Kravien, Khum of Cheam Kramey, Srok of Mimot, Province of Kompong-Cham;

At ll a.m. a reconnaissance aircraft flew at low altitude over the post at Pich Dar, Province of Mondulkiri.

10 October 1966

At 9.50 a.m. an F-105 jet aircraft flew at low altitude over the Khum of O-Raing, Srok of O-Raing, Province of Mondulkiri.

12 October 1966

At 2.15 a.m. a jet aircraft flew 4,000 metres inside the border over the Khum of Koh Rokar, Srok of Peamchor, Province of Prey-Véng;

At 3 a.m. a jet aircraft flew at low altitude about 600 metres inside the border over the Khum of Angkor Borey, Srok of Prey Krabao, Province of Takéo;

At 3.15 a.m. a jet aircraft flew about 3,000 metres inside the border over the post at Benghi, Srok of Loeuk Dek, Province of Kandal;

At 9.55 a.m. an F-105 jet aircraft flew about 3,000 metres inside the border over the Khum of Koh Rokar, Srok of Peamchor, Province of Prey-Véng.

13 October 1966

At 9 a.m. an aircraft flew at high altitude about 15,000 metres inside the border over the villages of Kbal-Damrey and Trapeang Phlong, Srok of Thbaung Khmum, Province of Kompong-Cham;

At 9.45 a.m. a jet aircraft flew about 5,000 metres inside the border over the post at Koh Rokar, Khum of Koh Rokar, Srok of Peamchor, Province of Prey-Véng.

14 October 1966

At 9.40 a.m. a reconnaissance aircraft flew at low altitude over the Provincial Guard post at Khsim, Khum of Khsim, Srok of Snuol, Province of Kratié; At 10.50 a.m. a jet aircraft flew at high altitude over the post at Trapeang Phlong, Srok of Thbaung Khmum, Province of Kompong-Cham.

15 October 1966

At 12.35 an aircraft flew at high altitude over the centre of Snuol, Srok of Snuol, Province of Kratié;

At 7.55 p.m. a jet aircraft flew over the county town of Snuol, Srok of Snuol, Province of Kratié.

16 October 1966

At 7 a.m. three jet aircraft flew at high altitude about 2,000 metres inside the border over the post at Smach, Khum of Trapeang Phlong, Srok of Thbaung Khmum, Province of Kompong-Cham;

At 9.20 a.m. an L-19 aircraft flew about 2,000 metres inside the border over the Provincial Guard post at Sampeou, Khum of Koh Sampeou, Srok of Peamchor, Province of Prey-Véng;

At 12 p.m. two reconraissance aircraft flew about 4,500 metres inside the border over the post at Lom Kom, Khum of Russey Pok, Srok of Serei Taeut, Province of Rattanakiri.

17 October 1966

At 2.10 a.m. a jet aircraft flew at low altitude about 3,000 metres inside the border over the village of Tuol Kandal, Khum of Koh Sampeou, Srok of Peamchor, Province of Prey-Véng;

At 2.30 a.m. an aircraft flew over Koh Tonsay, Province of Kampot;

At 3 a.m. a jet aircraft flew about 2,500 metres inside the border over the post at Benghi, Khum of Kaâm Samnâr Krom, Srok of Loeuk Dèk, Province of Kandal;

At 4 a.m. a jet aircraft flew at low altitude over the villages of Phnom Char and Phnom Borey, Khum of Angkor Borey, Srok of Prey Krabas, Province of Takéo.

18 October 1966

At 10.35 a.m. two jet aircraft flew at high altitude about 3,000 metres inside the border over the Khum of Kaâm Samnâr Krom, Srok of Loeuk Dèk, Province of Kandal;

At 3.20 p.m. a jet aircraft flew at high altitude over the Provincial Guard post at Mésar Thngâk, Khum of Mésar Thngâk, Srok of Svay Teap, Province of Svay-Rieng;

At 3.30 p.m. a twin-engined aircraft flew over the Khum of Mésar Thngâk, Srok of Svay Teap, Province of Svay-Rieng.

19 October 1966

At 3.45 a.m. a jet aircraft flew at low altitude about 8,000 metres inside the border over the Khums of Roung, Mimot and Triek, Srok of Mimot, Province of Kompong-Cham;

At 8.25 a.m. a reconnaissance aircraft flew about 600 metres inside the border over the Kaâm Samnâr Krom district, Srok of Loeuk Dèk, Province of Kandal.

20 October 1966

At 2 a.m. a jet aircraft flew over Koh Sès, Province of Kampot;

At 8 a.m. two jet aircraft flew over the village of Svay Thlab, Khum of Bassak, Srok of Svay-Rieng, Province of Svay-Rieng;

At 11.20 a.m. three F-105 jet aircraft flew at high altitude about 3,000 metres inside the border over the post at Trapeang Phlong, Khum of Trapeang Phlong, Srok of Thbaung Khmum, Province of Kompong-Cham.

21 October 1966

At 6.55 a.m. a fighter aircraft flew over the county town of Snuol, Srok of Snuol, Province of Kratié;

At 6.30 p.m. a jet aircraft flew at high altitude about 3,500 metres inside the border over the post at Koh Rokar, Khum of Koh Rokar, Srok of Peamchor, Province of Prey-Véng;

At 6.40 p.m. a reconnaissance aircraft flew about 1,200 metres inside the border over the post at Kaâm Samnâr Krom, Srok of Loeuk Dèk, Province of Kandal.

23 October 1966

At 2.20 a.m. a fighter aircraft flew over the village of Choeung Khlou, Srok of Snuol, Province of Kratié.

24 October 1966

At 2.45 a.m. a jet aircraft flew at high altitude over the post at Trapeang Phlong, Khum of Trapeang Phlong, Srok of Thbaung Khmum, Province of Kompong-Cham;

At 3 a.m. an F-105 jet aircraft flew at low altitude over the Provincial Guard post at Svay Angong, Khum of Peam Montea, Srok of Kompong Trabèk, Province of Prey-Véng;

At 7.15 a.m. a jet aircraft flew over the villages of Koki, Peam Metrey and Batras, Srok of Romeas Hèk, Province of Svay-Rieng;

At 9.15 a.m. an F-105 jet aircraft flew over the Provincial Guard post at Peam Montea, Srok of Kompong Trabèk, Province of Prey-Véng;

At the same time a jet aircraft flew at low altitude over the village of Choeung Khlou, Srok of Snuol, Province of Kratié;

At 12.35 p.m. a twin-engined aircraft flew at high altitude over the Khum of Kompong Trach, Srok of Romeas Hek, Province of Svay-Rieng;

At 12 midnight a jet aircraft flew at high altitude about 1,000 metres inside the border over the Khums of Trapeang Phlong and Daun Tey, Srok of Thbaung Khmum, Province of Kompong-Cham;

25 October 1966

At 2 a.m. a jet aircraft flew at low altitude over the Provincial Guard post at Kbal Chrieu, Khum of Khsim, Srok of Snuol, Province of Kratié;

At 11.55 a.m. an L-19 reconnaissance aircraft flew at low altitude about 6,000 metres inside the border over the Provincial Guard post at Koh Rokar, Khum of Koh Rokar, Srok of Peamchor, Province of Prey-Véng;

At 7.45 p.m. a jet aircraft flew about 2,000 metres inside the border over the post at Benghi, Khum of Kaâm Samnâr Krom, Srok of Loeuk Dèk, Province of Kandal;

At 8.10 p.m. a jet aircraft flew at high altitude over the village of Phnom-Den, Khum of Phnom-Den, Srok of Kirivong, Province of Takéo;

At 8.15 p.m. an aircraft flew over Koh Tonsay, Province of Kampot;

At 8.30 p.m. a jet aircraft flew at low altitude over the village of Lork, Khum of Russey Srok, Srok of Kompong Trach, Province of Kampot.

26 October 1966

At 3.5 a.m. a jet aircraft flew at low altitude over the Provincial Guard post at Kbal Chrieu, Khum of Khsim, Srok of Snuol, Province of Kratié;

At 10 a.m. a jet aircraft flew at high altitude over the village of Ampil, Khum of Ampil, Srok of Romeas Hèk, Province of Svay-Rieng;

At 4.50 p.m. an F-100 jet aircraft flew about 1,000 metres inside the border over the village of Prek Kandol, Khum of Dar, Srok of Mimot, Province of Kompong-Cham;

At 5.30 p.m. a jet aircraft flew at high altitude about 2,000 metres inside the border over the village of Saâm, Khum of Krek, Srok of Thbaung Khmum, Province of Kompong-Cham.

27 October 1966

At 8 a.m. a helicopter flew at low altitude about 2,000 metres inside the border over the villages of Chambak Chitriv and Tanh, Khum of Roung, Srok of Mimot, Province of Kompong-Cham;

At 8.45 a.m. an F-100 jet aircraft flew at low altitude about 8,000 metres inside the border over the village of Mimot, Khum of Tramoung, Srok of Mimot, Province of Kompong-Cham;

At 8.50 a.m. four jet aircraft flew at high altitude over the village of Trapeang Sdam, Khum of Ampil, Srok of Romeas Hèk, Province of Svay-Rieng;

At 9 a.m. a jet aircraft flew at high altitude over the Khum of Chrak Motes, Srok of Svay Teap, Province of Svay-Rieng;

At 11 a.m. two jet aircraft flew about 8,000 metres inside the border over the village of Daung, Khum of Cheam Kravien, Srok of Mimot, Province of Kompong-Cham.

28 October 1966

At 8.20 a.m. an F-101 jet aircraft flew about 1,500 metres inside the border over the village of Beng, Khum of Dar, Srok of Mimot, Province of Kompong-Cham;

At 9.25 a.m. an aircraft flew about 1,500 metres inside the border over the district of Krabao, Province of Prey-Véng;

At 9.30 a.m. an aircraft flew at high altitude about 4,000 metres inside the border over the village of Chimorn, Khum of Krek, Srok of Thbaung Khmum, Province of Kompong-Cham;

At 10.25 a.m. an aircraft flew at low altitude about 2,500 metres inside the border over the village of Koh Rokar, Khum of Koh Rokar, Srok of Peamchor, Province of Prey-Véng;

At 7 p.m. an aircraft flew about 2,000 metres inside the border over the Khum of Trapeang Phlong, Srok of Thbaung Khmum, Province of Kompong-Cham;

At 8.15 p.m. a jet aircraft flew over the village of Angkor Borey, Khum of Angkor Borey, Srok of Prey Krabas, Province of Takéo;

At 8.25 p.m. an F-100 jet aircraft flew at high altitude about 2,000 metres inside the border over the Khum of Kaâm Samnâr Krom, Srok of Loeuk Dèk, Province of Kandal.

29 October 1966

At 9.15 a.m. a reconnaissance aircraft flew over the village of Prey Kdey Ampil, Srok of Romeas Hek, Province of Svay-Rieng;

At 1.45 p.m. a jet aircraft flew at low altitude over the village of Choeung Khlou and the county town of Snuol, Srok of Snuol, Province of Kratié.

30 October 1966

At 10.15 a.m. an F-105 jet aircraft flew at high altitude about 1,000 metres inside the border over the village of Taam, Khum of Daun Tey, Srok of Thbaung Khmum, Province of Kompong-Cham.

The Royal Government has lodged a vigorous and indignant protest against these deliberate violations of Cambodian territory by the United States-South Viet-Namese air forces, and has called upon the Governments of the United States of America and the Republic of Viet-Nam to take the necessary steps to put an end to such violations immediately.

I would be grateful if you would have the text of this communication circulated as a Security Council document.
