Extensions of country cooperation frameworks

Note of the Administrator

Summary

The present note contains information on the first one-year extensions of the second country cooperation frameworks (CCFs) for Belarus, Hungary, Latvia, Slovakia, the second one-year extensions of the second country cooperation frameworks for Chile and Uruguay, and the two-year extension of the second CCF for Zimbabwe. The Governments concerned requested the extensions.

In accordance with established procedures, the Administrator approves the first one-year extension of CCFs while requests for second-year or two-year extensions are submitted to the Board for its approval.

The Executive Board may wish to take note of the first extensions of the second CCFs for Belarus, Hungary, Latvia and Slovakia listed in table 1, and approve the second one-year extensions of the second CCFs for Chile and Uruguay and the two-year extension of the second CCF for Zimbabwe listed in table 2.

Belarus	2001-2004	2005			The programmes of the current CCF remain relevant vis-à-vis the priorities of the Government. The proposed extension reflects the need for more time to complete the implementation of major components of the current programme, many of which are much more sizable than expected. The delay in starting up a number of projects was caused by the later-than-planned conclusion of negotiations and operational arrangements with partners contributing to these projects.
Hungary	2001-2004	2005			Beginning in May 2004, Hungary became a European Union member state, and as of 2004 has reached the status of net contributor country. In accordance with UNDP strategy regarding the new European Union member states, the country programming of target for resource assignment from the core (TRAC) will cease in 2006. The extension is needed to cover the year 2005.
Latvia	2001-2004	2005			Owing to the accession of Latvia to the European Union in May 2004, bilateral donor resources (cost sharing) for programming will be phased out; the Government has decided to conclude the programming of UNDP core resources at the end of 2005. The extension is needed to finalize and consolidate current programming, and ensure the sustainability of results through consultations with the Government and other development partners.
Slovakia	2001-2004	2005			Already an Organization for Economic Co-operation and Development (OECD) member country, Slovakia became a European Union member state in May 2004. The Government, in a letter dated 4 September 2004, agreed to continue the programming of regular resources and operational allocations for national programming during 2004-2005 budget cycles. From 2006, the TRAC allocations and programming of core resources will cease. The extension is needed to cover the year 2005.
