Sol KUTTNER

Mr. Sol Kuttner was first elected by the United Nations General Assembly as one of its representatives on the United Nations Staff Pension Committee in 1974. He has served on the Committee continuously since then. He is also a member of UNJSPB as well as the representative of the General Assembly on the Standing Committee of that Board. In addition, he is Chairman of the United Nations Pension Committee.

Mr. Kuttner is a career officer of the United States Department of State. He serves as a senior adviser at the United States Mission to the United Nations. In his current position, he serves as Executive Officer in the Office of Host Country Affairs, where he has staff responsibility in connection with United States obligations as host country to the United Nations. Mr. Kuttner previously had staff responsibility for United Nations personnel matters, the International Civil Service Commission (ICSC), the United Nations Pension System and the United Nations Administrative Tribunal.

Mr. Kuttner has been a member of United States delegations to the United Nations since 1967. He has served as an adviser in both the Fifth and Sixth Committees. He currently serves as an adviser in the Committee on Relations with the Host Country.

Mr. Kuttner is a First Vice-Chairman of the Board of Directors of the United Nations Child Care Centre. He is also a member of the Board of Trustees of the after-school programme for United Nations children. He has served as Vice-Chairman of the Board of Trustees of the United Nations International School (UNIS).

From 1959 to 1961, Teodoro Maus worked as an assistant professor at the National School of Architecture, Autonomous University of Mexico.

Prior to entering the Mexican Foreign Service, he was employed by a construction company as architect and personnel manager.

He entered the Mexican Foreign Service in 1978, serving until 1986 as Cultural Attaché at the Consulate General of Mexico in New York. From 1981 to 1985, he was in charge of administrative and personnel matters in the Consulate.
