Report of the Special Political Committee

I. INTRODUCTION

- 1. The item entitled "United Nations Relief and Works Agency for Palestine Refugees in the Near East" was included in the provisional agenda of the forty-third session of the General Assembly in accordance with Assembly resolutions 42/69 A to K of 2 December 1987.
- 2. At its 3rd plenary meeting, on 23 September 1988, the General Assembly, on the recommendation of the General Committee, decided to include the item in its agenda and to allocate it to the Special Political Committee.
- 3. The Special Political Committee considered the item at its 22nd, 24th, 26th, 27th and 34th meetings, on 9, 10, 14, 15 and 28 November 1988 (see A/SPC/43/SR.22, 24, 26, 27 and 34).
- 4. The Committee had before it the following documents:

- 5. The Committee also had before it two letters from the Permanent Representative of Jordan to the United Nations addressed to the Secretary-General dated 30 March 1988 (A/43/273-S/19720) and 6 June 1988 (A/43/393-S/19930), respectively, and a letter dated 6 October 1988 (A/43/709) from the Permanent Representative of Zimbabwe to the United Nations addressed to the Secretary-General.
- 6. At its 22nd meeting, on 9 November, the Committee heard a statement by the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA), who introduced his report. 1/
- 7. At the same meeting, the representative of Norway, Rapporteur of the Working Group on the Financing of UNRWA, introduced the report of the Working Group (A/43/702).

II. CONSIDERATION OF PROPOSALS

8. In the course of its deliberations, the Special Political Committee considered 10 draft resolutions, as set forth below.

A. Draft resolution A/SPC/43/L.14

- 9. At the 34th meeting, on 28 November, the representative of the <u>United States</u> of <u>America</u> introduced a draft resolution (A/SPC/43/L.14) entitled "Assistance to Palestine refugees", sponsored by his delegation.

B. Draft resolution A/SPC/43/L.15

- 11. C. Draft resolution A/SPC/43/L.16

United Nations Relief and Works Agency for Palestine Refugees in the Near East

A

Assistance to Palestine refugees

The General Assembly,

Recalling its resolution $42/69 \, \lambda$ of 2 December 1987 and all its previous resolutions on the question, including resolution 194 (III) of 11 December 1948.

Taking note of the report of the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, covering the period from 1 July 1987 to 30 June 1988, 3/

- 1. Notes with deep regret that repatriation of compensation of the refugees as provided for in paragraph 11 of General Assembly resolution 194 (III) has not been effected, that no substantial progress has been made in the programme endorsed by the Assembly in paragraph 2 of its resolution 513 (VI) of 26 January 1352 for the reintagration of refugees either by repatriation or resettlement and that, therefore, the situation of the refugees continues to be a matter of serious concern,
- 2. Expresses its thanks to the Commissioner-General and to all the staff of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, recognising that the Agency is doing all it can within the limits of available resources, and also expresses its thanks to the specialized agencies and private organisations for their valuable work in assisting the refugees;
- 3. Reiterates its request that the headquarters of the Agency should be relocated to its former site within its area of operations as soon as practicable;
- 4. Notes with regret that the United Nations Conciliation Commission for Palestine has been unable to find a means of achieving progress in the implementation of paragraph 11 of General Assembly resolution 194 (III), 4/ and requests the Commission to exert continued efforts towards the implementation of that paragraph and to report to the Assembly as appropriate, but no later than 1 September 1989;

- 5. Directs attention to the continuing seriousness of the financial position of the Agency, as outlined in the report of the Commissioner-General;
- 6. Notes with profound concern that, despite the commendable and successful efforts of the Commissioner-General to collect additional contributions, this increased level of income to the Agency is still insufficient to cover essential budget requirements in the present year and that, at currently foreseen levels of giving, deficits will recur each year;
- 7. Calls upon all Governments, as a matter of urgency, to make the most generous efforts possible to meet the anticipated needs of the Agency, particularly in the light of the budgetary deficit projected in the report of the Commissioner-General, and therefore urges non-contributing Governments to contribute regularly and contributing Governments to consider increasing their regular contributions.

Emphasizing the continuing need for extraordinary efforts in order to maintain, at least at their present minimum level, the activities of the Agency, as well as to enable the Agency to carry out essential construction,

- 1. <u>Commends</u> the Working Group on the Financing of the United Nations Relief and Works Agency for Palestine Refugees in the Near East for its efforts to assist in ensuring the Agency's financial security;
 - 2. Takes note with approval of the report of the Working Group;
- 3. Requests the Working Group to continue its efforts, is co-operation with the Secretary-General and the Commissioner-General, for the financing of the Agency for a further period of one year;

Endorses, bearing in mind the objectives of those resolutions, the efforts of the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East to continue to provide humanitarian assistance as far as practicable, on an emergency basis and as a temporary measure, to other persons in the area who are at present displaced and in serious need of continued assistance as a result of the June 1967 and subsequent hostilities;
- 3. Strongly appeals to all Governments and to organisations and individuals to contribute generously for the above purposes to the United

Nations Relief and Works Agency for Palestine Refugees in the Near East and to the other intergovernmental and non-governmental organizations concerned.

Offers by Member States of grants and scholarships for higher education, including vocational training, for Palestine refugees

- 1. Reiterates strongly its demand that Israel desist from the removal and resettlement of Palestine refugees in the Palestinian territory occupied by Israel since 1967 and from the destruction of their shelters;
- 2. - 2. Calls once again upon all Governments, as a matter of urgency, to make the most generous efforts possible and to offer the necessary resources to meet the needs of the United Nations Relief and Works Agency for Palestine Refugees in the F ar East, particularly in the light of the interruption by the Agency of the general ration distribution to Palestine refugees in all fields, and therefore urges non-contributing Governments to contribute regularly and contributing Governments to consider increasing their regular contributions;

- 2. <u>Calls once more upon</u> Israel to render all facilities and assistance to the Secretary-General in the implementation of the present resolution;

<u>Deeply distressed</u> at the suffering of the Palestinian and Lebanese population which resulted from continuing Israeli acts of aggression against Lebanon and other hostile acts,

<u>Deeply distressed</u> at the tragic situation of the civilian population in and around the Palestinian refugee camps in Lebanon which resulted from the fighting,

Having also considered the report of the Commissioner-General of the United Nations Relief and Works Agency for Palestine Refugees in the Near East, covering the period from 1 July 1987 to 30 June 1988, 3/

1. <u>Emphasizes</u> the need for strengthening the educational system in the Arab territories occupied since 5 June 1967, including Jerusalem, and specifically the need for the establishment of the proposed university;

- 2. Requests the Secretary-Central to continue to take all necessary measures for establishing the University of Jerusalem "AI-Quds", in accordance with General Assembly resolution 35/13 B of 3 November 1980, giving due consideration to the recommendations consistent with the provisions of that resolution;
- 3. <u>Calls once more upon</u> Israel, the occupying Power, to co-operate in the implementation of the present resolution and to remove the hindrances that it has put in the way of establishing the University of Jerusalem "Al-Quds";
- 4. Requests the Secretary-General to report to the General Assembly at its forty-fourth session on the progress made in the implementation of the present resolution.
