Chapter ____ Organization of the session

A. Opening and duration of the session

1. The Committee on Non-Governmental Organizations held its 2004 regular session from 10 to 28 May 2004. The Committee held ____ meetings (1st to ____).

B. Attendance

2. The session was attended by 19 members of the Committee. Observers for other States Members of the United Nations, an observer for a non-member State, representatives of organizations of the United Nations system and observers for non-governmental organizations also attended. The list of participants is contained in annex I.

C. Election of officers

3. At its 1st meeting, on 10 May, the Committee elected the following officers by acclamation:
