LETTER DATED 28 DECEMBER 1965 FROM THE DEFUTY PERMANENT REPRESENTATIVE OF INDIA ADDRESSED TO THE SECRETARY-GENERAL

I have the honour to communicate the following further cease-fire violations and other incidents created by Pakistan:

Jammu and Kashmir

Kargil Sector

- 1. Pakistani troops were seen improving defences in an area four and a half miles north of Kargil on 19 December 1965.
- 2. Pakistani troops were seen constructing bunkers in an area four and three quarter miles north-north-east of Kargil on 22 December 1965.

Keran Sector

- 3. Pakistani troops were seen improving defences in an area three and a half miles north-east of Ringpain on 19 December 1965.
- 4. Pakistani troops were seen improving defences in an area three and a half miles north-east of Ringpain on 21 and 22 Detember 1965.
- 5. Pakistani troops fired medium machine-guns and 81 mm mortars towards our post in an area nine and a half miles east-north-east of Keran on 20 December 1965.

Tithwal Sector

6. Pakistani troops fired small arms towards our patrol in an area two miles north-east of Tithwal on 20 December 1965.

Uri Sector

- 7. Pakistani troops were observed improving defences in an area five miles south of Haji Pir Pass on 19 December 1965.
- 8. Pakistani troops were seen improving defences in an area seven and a quarter miles south-south-west of Haji Pir on 21 and 22 December 1965.

Punch Sector

- Pakistani troops fired ineffectively with rifles towards our post in an area four miles north-west of Funch on 20 December 1965.
- 10. Pakistani troops were seen improving defences at two places in areas four and three quarter and five and three quarter miles west-north-west of Punch on 22 recember 1965.
- 11. Pakistani troops fired rifles towards our post in an area five miles west of Funch on 21 December 1965.

Naushahra Sector

- 12. Pakistani troops intruded on our side of the cease-fire line in an area three and three quarter miles north-north-east of Jhangar at 0635 hours on 20 December 1965.
- 15. Pakistani troops were seen improving defences at two places three and a quarter miles north-north-west and two and a quarter miles north-vest of Jhangar on 22 December 1965.

Akhnur Sector

- 14. Pakistani troops fired on our observation post in an area six miles west of Kalidhar on 19 December 1965.
- 15. Pakistani troops were observed improving defences in the following areas:
 - (a) Four and a half miles north-east of Kalit on 20 December 1965.
 - (b) Two and three quarter miles south-west of Kalidhar on 19 December 1965.
- 16. Pakistani troops were seen improving defences in three places in an area between eight and a half miles north-north-west and seven miles north-north-east of Jaurian on 21 December 1965.
- 17. Pakistani troops were seen improving defences in two places in general area, nine and a half miles north-east of Dewa on 21 December 1965.
- 18. Firing noises were heard from Kalit area and three and a quarter miles south-east of Kalidhar on 22 December 1965.
- Pakistani troops were seen improving defences as under on 21 and 22 December 1965;

- (a) At four places in areas between five and a half miles north-east and five miles east of Kalit.
 - (b) In an area one mile south of Kalidhar.
- 20. Six Pakistani troops intruded, on our side of the cease-fire line, in an area four and a quarter miles east-south-east of Jaurian on 21 December 1965 and fired at our patrol in the same area. The intruders went back when challenged by our troops.

Mandhar Sector

- 21. Pakistani troops fired 81 mm mortars and 3.7 inch Howitzers towards areas five miles south-east of Mandhar and three and a half miles south-west and three miles west-south-west of Galuthi on 20 December 1965.
- 22. Approximately ten Pakistani troops intruded on our side in an area five and a half miles south-east of Mandhar on 20 December 1965.
- 23. Three Pakistani troops intruded on our side in an area nine miles west-southwest of Mandhar on 20 December 1965.
- 24. Three Pakistani troops intruded on our side in an area five miles south-west on Caluthi on 21 December 1965.
- 25. Pakistani troops fired 81 mm mortars and 3.7 inch Howitzers towards three of our posts in an area between three and a quarter miles south-west and seven miles west-south-west of Mandhar on the night of 21 and 22 December 1965.
- 26. Pakistani troops fired Browning machine-gun, 81 mm mortar and 3.7 inch. Howitzer fire towards seven of our posts in an area between six miles south-south-west and five miles west-north-west of Galuthi on the night of
- 21 and 22 December 1965.
- 27. Fakistani troops fired at our patrol in an area four and a half miles west of Galuthi on the night of 21 and 22 December 1965.
- 28. Pakistani troops were seen improving defences in an area six and a half miles south-west of Galuthi on 22 December 1965.

Sialkot Sector

29. Six Pakistani troops were seen improving defences in an area five miles north-north-east of Zafarwal on 20 December 1965.

- 30. Pakistani troops fired light machine-guns towards our observation post in an area four miles south-east of Phillora on 21 December 1965.
- 31. Twelve explosions were heard from the direction of Amral, approximately two and a half miles north-east of Zafarwal at 2000 hours on 22 December 1965.

Lahore Sector

- 32. Pakistani troops fired as under:
- (a) One rifle shot towards our position in Bhasin area on 19 December 1965. They again fired with light machine gun, rifle and 2-inch mortars towards another position in the same area on 20 December 1965.
- (b) Eighteen and fifteen rifle shots towards our position in Dograi area on 19 and 20 December, respectively.
- (c) Four rifle shots towards our position one mile north of Dograi on 20 December 1965.
- 33. Three Pakistani infiltrators intruded to our mine field in Dograi area on 19 December 1965.
- 34. Pakistani troops were observed digging fresh positions in Bhasin area on 20 December 1965.
- 35. Pakistani troops were observed digging communication trenches in an area two miles south-south-west of Barki on 20 December 1965.
- 36. Pakistani troops fired as under:
- (a) Rifles towards our position three miles south-south-west of Barki on 19 and 20 December 1965.
- (b) Light machine-guns towards our positions in an area three miles south of Barki on the night of 20 and 21 December 1965.
- (c) Rifle, light and medium machine-gun towards our positions in Bhasin area on 21 December 1965.
- (d) Rifle and light machine-gun towards our posts in an area one and a half miles north of Dograi on 21 December 1965.
- 37. Pakistani troops were observed digging in Bhasin area on 21 December 1965.
- 58. Pakistani troops were observed digging in an area one and a half miles south-west of Manhiala on 21 December 1965.

- 39. Pakistani troops were observed digging in an area two miles west and two and a half miles south-south-west of Barki on 21 December 1965.
- 40. Pakistani troops were observed digging and constructing a bunker in an area four miles north-north-west of Jahman on 21 December 1965.
- 41. Pakistani aircraft flew over our area approximately two miles north-east of Khemkaran at 1545 hours on 21 December 1965.
- 42. Pakistani troops were seen digging in the following areas:
- (a) At three places between one mile north-west and one and a quarter miles south-south-west of Bhasin on 22 December 1965.
- (b) At eight places between five miles north-north-west and four miles south of Barki on 22 December 1965.
- (c) At three places between four and a quarter miles north-north-west and one and a half miles west-north-west of Jahman on 22 December 1965.
 - (d) In an area six miles north-north-west of Khemkaran on 22 December 1965.

Fazilka Sector

- 43. Pakistani troops fired at our patrol in an area four miles west-south-west of Mamdot on 18 December 1965.
- 44. Pakistani troops fired small arms towards six of our posts in an area four and a half miles west-north-west to nine and a half miles south-west of Mamdot on 19 and 20 December 1965.
- 45. Pakistani troops fired small arms towards our post in an area eleven miles north of Jalalabad on 19 December 1965.
- 46. Fakistani troops fired rifle shots towards an area three miles west-northwest of Fazilka on 19 December 1965.
- 47. Pakistani troops set fire to sarkanda in general area two miles north-northwest of Husainiwala on 19 December 1965 and fire spread towards our post in the same area.
- 48. Pakistani troops fired as under:
- (a) One rifle shot on our patrol in an area five miles west-south-west of Mamdot on 20 December 1965.
- (b) Verey light and rifles towards an area five and a half miles and four and three quarter miles north-north-west of Fazilka on 20 December 1965.

- (c) One rifle shot towards an area five and a half miles west-south-west of Fazilka on 20 December 1965.
- 49. Pakistani troops were seen laying mines in an area two and a half miles south of Chananwala on 20 December 1965. They also fired at our troops.
- 50. Pakistani troops fired as under:
- (1) Light and Browning machine-guns towards our posts in areas one mile north-north-west and four miles north-north-east of Husainiwala on 22 December 1965.
- (2) Small arms towards our patrol aid post in an area five miles west-northwest of Jalahadad on 21 December 1965.
- (3) Small arms towards our post in an area eight and a quarter miles westnorth-west of Jalalabad on 21 December 1965.
- (4) Small arms at our patrol in an area nine and a half miles north-northeast of Fazilka on 23 December 1965.
- (5) A few rifle shots towards our post in an area three and a half miles north-west of Fazilka on 22 December 1965.
- (6) Rifle fire towards our post in an area one and a quarter miles westnorth-west of Chananwala on 21 December 1965.

<u>Rajasthan</u>

- 51. Pakistani troops fired with small arms and mortars on our post in an area point 415 approximately fifteen miles south-west of Gadra Road on 20 December 1965.
- 52. Pakistani troops fired at our patrol at Somrar, approximately twenty-two miles south-south-east of Kelnor on 20 December 1965.
- 53. Pakistani patrol trying to probe forward in an area four miles north of Munabao, was challenged by our troops, and withdrew. But subsequently they started shelling our position in the area, on 21 December 1965.
- 54. Two Pakistani aircraft flew over our defences in Gadra Sector on 21 December 1965.
- 55. Two Pakistani aircraft flew over our defences in Gadra City on 22 December 1965.
- 56. Pakistani troops tried to encircle our observation post in an area ten miles south of Miajlar at 1530 hours on 20 December 1965. They withdrew when challenged.
