LETTER DATED 31 DECEMBER 1965 FROM THE PERMANENT REPRESENTATIVE OF INDIA ADDRESSED TO THE SECRETARY-GENERAL

I have the honour to communicate the following further cease-fire violations and other incidents created by Pakistan:

Jammu and Kashmir

Kargil Sector

1. Pakistani troops were seen improving defences in an area five and a half miles north-morth-west of Kargil at 1600 hours on 22 December 1965.

2. Pakistani troops were seen impreving their bunkers in an area thirteen miles west-north-west of Kargil on 23 December 1965.

 Approximately two Fakistani platoons, presumably reinforcements, were observed moving from Harol, approximately fourteen miles north-north-east of Kargil, to an area nine and three quarter miles east-south-east of Marol cn
December 1965.

4. Pakistani troops were seen improving defences in an area eight miles north-west of Kargil on 23 December 1965.

Tithwal Sector

5. Pakistani troops were observed constructing bunkers in an area five and a half miles north-north-east of Tithwal on 27 December 1965.

6. Pakistani troops were observed digging trenches in an area three and a half miles west-south-west of Tithwal on 29 December 1965.

Uri Sector

7. Approximately one section of Pakistani troops were seen constructing new bunkers in an area eight and a half miles west of Uri on 22 December 1955.

8. Pakistani troops were seen digging in an area six and a half miles south-south-west of Haji Pir Pass on 22 December 1965.

9. Pakistani troops fired six shells containing propaganda leaflets towards Haji Pir Pass at 1630 hours on 26 December 1965. These leaflets were recovered from an area three miles west-north-west of Haji Pir Fass.

Funch Sector

10. Pakistani troops were seen digging in an area six miles west-south-west of Funch on 22 December 1965.

11. Pakistani troops fired at our post in an area approximately six miles west-south-west of Funch on 22 December 1965.

12. Pakistani troops were seen digging in areas five and six miles west-north-west of Punch on 24 December 1965.

13. Pakistani troops fired with medium machine-guns at our post in an area four and a half miles west of Funch on 24 December 1955.

14. Approximately ten Pakistani troops were seen digging in an area eight miles south-west of Funch at 0900 hours on 26 December 1965.

15. Pakistani troops fired 81 mm mortars towards our post in an area five miles west-south-west of Punch on 26 December 1965.

16. Pakistani troops were observed digging at two places, five and a half miles west and six and a half miles west-north-west of Punch on 28 December 1965.

17. Pakistani troops were observed digging in an area five miles north-west of Funch on 29 December 1965.

Mendhar Sector

18. Pakistani troops fired with medium machine-guns towards an area nine and a half miles north-west of Mendhar on 22 December 1965. They again fired light machine-guns and 3-inch mortars towards the same area on 23 December 1965.

19. Pakistani troops fired 81 mm mortars and 3.7-inch howitzers on four of our posts in an area between eight and a half miles south-south-west and four and three quarter miles west-south-west of Galuthi on 22 December 1965.

20. Pakistani troops fired 81 mm mortars towards our post in an area three miles south-west of Galuthi on 23 December 1965.

21. Pakistani troops fired with 81 mm mortars at two of our posts in areas three and a quarter miles south of Mendhar and four and three quarter miles westsouth-west of Galuthi on 24 December 1965. 22. Pakistani troops fired 81 mm mortars towards our post in areas six and seven miles west of Mendhar on 25 December 1965.

23. Pakistani troops fired medium machine-guns towards our post in an area six and a half miles west-north-west of Galuthi on 25 December 1965.

24. Pakistani troops fired medium machine-guns and 3.7-inch howitzers towards our post in an area five and a half miles west of Galuthi on 26 December 1965.

25. Pakistani troops fired light machine-guns towards our post in an area eight miles west-north-west of Rajauri on 25 December 1965.

26. Four Pakistan-occupied-Kashmir troops intruded on our side of the cease-fire line in an area five and a half miles west-south-west of Mendhar on 27 December 1965.

27. Pakistani troops were observed digging in an area eight miles west-northwest and nine and a half miles north-west of Rajauri on 26 December 1965.

26. Five Pakistani troops intruded on our side of the cease-fire line in an area seven and a half miles west-south-west of Mendhar on 27 December 1965.

29. Six Pakistani troops intruded in our area five and a half miles west of Galuthi on 27 December 1955. They withdrew when challenged.

30. Pakistani troops were seen improving defences in areas seven and a half miles south-south-west and six miles south-west of Galuthi on 27 December 1965.

31. Approximately eight Pakistani troops intruded on our side of the cease-fire line and started digging in an area five and a half miles west-south-west of Mendhar on 28 December 1965. They withdrew when challenged.

32. Pakistani troops were observed digging in areas nine miles west-north-west and ten miles north-west of Rajauri on 28 December 1965.

Naushahra Sector

33. Four Pakistani intruders came in an area four miles north-east of Jhangar on 25 December 1965. They withdrew when challenged.

 5^{4} . Pakistani troops were seen digging in an area four miles west-south-west of Jhangar on 23 December 1965.

35. Pakistani troops fired with rifles towards our post in an area nine and a half miles south-east of Naushahra on 23 December 1965.

36. Approximately fifteen Pakistani troops intruded on our side of the cease-fire line in an area three and a half miles north-east of Jhangar on 24 December 1965.

37. Fifteen Pakistani troops were seen digging in an area three miles north of Jhangar on 24 December 1965.

53. Approximately twenty-three Fakistani troops intruded on our side of the cease-fire line in an area three and three quarter miles north-east of Jhangar at 0750 hours on 26 December 1965.

39. Pakistani troops fired 25-pounders towards our post in an area two and three quarter miles north-west of Jhangar on 26 December 1965.

40. Approximately twenty-three Pakistan-occupied-Kashmir troops intruded on cur side of the cease-fire line in areas three and a half miles and five miles north-east of Jhangar on 27 December 1965. They withdrew when challenged.

41. Pakistani troops were seen digging in areas approximately three miles north-west of Jhangar and eight and a half miles south-west of Naushahre on 27 December 1965.

42. Pakistani troops were seen digging at two places, three miles north-west and two and a half miles north-north-west of Jhangar on 28 December 1965.

43. Ten Pakistani troops intruded on our side of the cease-fire line in an area five miles north-east of Jhangar at 1115 hours on 29 December 1965.

44. A Pakistani jet aircraft crossed the cease-fire line in an area four miles north-east of Jhangar and flew over our area towards south at 1330 hours on 20 December 1965.

45. Approximately seven Fakistani troops were observed digging in an area four miles north-north-west of Jhangar at 0330 hours on 29 December 1965.

Akhnur Sector

46. Pakistani troops were observed digging as under on 23 December 1965:

(a) At three places in an area between five and a half miles east-north-east and five and a half miles north-east of Kalit.

(b) At five places in an area between one and a half miles east-south-east and six miles west-north-west of Kalidhar.

(c) In an area three miles north-north-east of Deva.

47. Approximately six Pakistani troops attempted to round up some cattle in an area five miles east-south-east of Kalidhar on 24 December 1965. They withdrew when challenged.

48. Pakistani troops were seen improving defences in the following areas on 24 December 1965:

(a) At three places in an area between seven miles north-east and four and a half miles north-east of Jaurian.

(b) In areas three miles south-west and six miles west of Kalidhar.

49. Pakistani troops were seen improving defences in the following areas on 25 December 1965:

(a) At four places between five and a half miles north-north-east and six miles east-south-east of Kalit.

(b) At three places between three miles west-south-west and si: miles east-south-east of Kalidhar.

50. Pakistani troops fired towards an area four miles east-south-east of Kalidhar on 25 December 1965.

51. A Pakistani platoon took position in an area five miles east-south-east of Kalidhar and fired at our patrol in this area on 25 December 1965.

52. Pakistani troops were observed digging or improving defences as under:

(a) At six places in an area between eight and a quarter miles west-north-west and six and a quarter miles west-south-west of Akhnur on 25 and 26 December 1965.

(b) At two places in areas three and a quarter miles west-south-west, and two and three quarter miles south-west of Kalidhar on 25 and 26 December 1965.

55. Pakistani troops were observed doing the following:

(a) Digging in an area three miles east-north-east of Jaurian on27 December 1965.

(b) Digging in an area five and a half miles north-east of Kalit on 27 December 1965.

(c) Constructing bunkers in an area two and a half miles south-west of Kalidhar on 26 and 27 December 1965.

(d) Digging at three places in an area between five and a half miles westsouth-west and six miles west of Kalidhar on 27 December 1965.

54. Pakistani troops were seen improving defences and constructing bunkers as under:

(a) At six places in an area between seven miles north-north-east and three and a half miles east-north-east of Jaurian on 27 and 28 December 1965.

(b) In areas two and three quarter miles south-west and three and a quarter miles west-south-west of Kalidhar on 28 December 1965.

55. Pakistani troops were observed strengthening defences as under:

(a) In an area five miles north-east of Kalit on 29 December 1965.

(b) In an area two and three quarter miles south-west of Kalidhar on 29 December 1965.

(c) In an area six miles west of Kalidhar on 28 December 1965.

Punjab

Sialkot Sector

56. Pakistani troops were seen constructing an observation post on a hut top in an area three and a half miles north-west of Chawinda on 25 December 1965.

57. Noise of gun cotton slabs and firing presumably battle inoculation was heard from the direction of Peloke approximately three and a half miles north-west of Chawinda on 23 December 1965.

58. Pakistani troops established an observation post on the top of a house in an area four and a half miles south-south-west of Suchetgarh on 24 December 1965.

59. Pakistani troops fired three rifle shots towards our observation post in an area four and a half miles south-west of Ikhnal on 24 December 1965.

60. Pakistani troops were seen digging in an area four miles south-west of Phillora on 25 December 1965.

61. Pakistani troops were observed digging at two places 500 yards north and three and a half miles west-north-west of Chawinda on 25 December 1965.

62. Pakistani troops were seen digging in an area approximately three miles north-north-west of Bajra Garhi on 26 December 1965.

63. Pakistani troops fired from an area approximately one mile north of Chavinda on 26 December 1965.

64. Pakistani troops were laying mines in an area approximately four and a half miles north-north-east of Zafarwal on 26 December 1965.

65. Pakistani troops were seen digging in the following areas:

(a) Four and a half miles south-south-west of Ikhnal on 27 December 1965.

(b) Three miles south-south-west of Suchetgarh on 26 December 1965.

66. Pakistani troops were seen digging at three places in general area four miles north-west of Pagowal on 28 December 1965.

67. One Pakistani aircraft flew in the direction of Sialkot-Jammu at 1335 hours on 28 December 1965.

68. Three Pakistani aircraft flew over our area one mile north-east of Suchetgarh on 28 December 1965.

Lahore Sector

69. Pakistani troops were seen digging in an area half a mile north of Dograi on 25 December 1965.

70. Pakistani troops were seen constructing three bunkers in an area four miles north-north-ulst of Jahuan on 22 December 1965.

 Pakistani troops established an observation post approximately seventy feet high in an area three and a half miles north-east of Dera Baba Nanak on 23 December 1965.

72. Pakistani troops were seen digging in an area one mile south-south-vest of Bhasin on 22 December 1965 and digging new bunkers or trenches at three places north of Bhasin on 25 December 1965.

75. Pakistani troops were seen laying mines in an area two and a half miles west-north-west of Manhiala on 25 December 1965.

74. Pakistani troops were seen digging in an area two miles west of Rajoke on 23 December 1965.

75. Pakistani troops fired rifle shots towards two of our posts in areas half a mile south-west and three and a quarter miles south-south-west of Borki on 25 December 1965.

76. Approximately two sections of Pakistani troops infiltrated in our area four and a quarter miles north-north-west of Jahman, on the east bank of Ichhogil Canal and four infiltrators were seen digging in the same area on 23 December 1965.

77. Pakistani troops fired as under:

(1) Rifle and light machine-guns towards our patrol in an area four and a half miles north-east of Dera Boba Nanak on 24 December 1965. They again fired at our patrol in the same area on 25 December 1965.

(2) Light machine-guns towards our post in Bhasin area on 24 December 1965.

(5) Two-inch mortars, light and medium machine-guns towards our positions in an area four miles north-north-west of Jahman on 24 December 1965.

(4) One rifle shot towards Dograi area on 24 December 1965.

78. The following activities of the Pakistani troops have been seen:

(a) Digging and constructing bunkers in an area four and a helf miles northeast of Ranian on 24 December 1965.

(b) Digging in Bhasin area on 24 December 1965.

(c) Digging in Dograi area on 24 December 1965.

(d) Unloading 10 x 3 tons defence stores in Syphom area, approximately three miles south-south-vest of Barki on the night of 23/24 December 1965.

(e) Digging in an area four miles north-north-west of Jahman on 24 December 1965.

79. Pakistani troops were seen digging in the following areas:

(a) Four and a half miles north-east of Dera Baba Manak on 24 December 1965.

(b) In Bhasin area on the night of 24/25 December and 25 December 1965.

(c) In Dograi area on 25 December 1965.

(d) Two and a half miles north of Barki on 25 December 1965.

80. Four Pakistani civilian trucks and one-ton vehicles unloaded sand and bajri at four places near Bhasin on 25 December 1965.

81. Pakistani troops fired rifle shots towards our post in an area three miles south-south-west of Barki on 25 December 1965.

82. Five Pakistani infiltrators came to the east bank of Ichhogil Canal in an area one and a quarter miles north-west of Jahman on 25 December 1965. They fired three light machine-gun bursts when challenged.

35. Pakistani troops fired as under:

(1) One rifle shot towards our post in Dograi area on 26 December 1965.

(2) Three medium machine-gun bursts on our position in an area one and a half miles south of Rajoke on 26 December 1965.

(5) One rifle shot towards our position in an area half a mile south-southwest of Barki and three medium machine-gun bursts four and a half miles south of Barki on 26 December 1965.

84. Pakistani troops were observed digging fresh trenches in an area four miles north-east of Dera Baba Nanak on 26 December 1965.

85. Pakistani troops were observed digging fresh trenches in an area four miles north-east of Dera Baba Nanak on 26 December 1965.

86. Pakistani troops were observed constructing bunkers or improving defences, or digging at six places in Bhasin area on 26 December 1965.

87. Pakistani troops were observed digging at two places in areas two and a half miles south-south-west of Barki on 26 December 1965.

88. Approximately two Pakistani platoons crossed over to the east bank of Ichhogil Conal in an area two and a half miles west-south-west of Manhiala on 26 December 1965.

89. Pakistani troops fired one rifle shot towards our position in Berki area at 1050 hours on 27 December 1965.

SC. Pakistani troops fired rifle and light machine-guns towards our position in an area three miles south of Barki on 27 December 1965.

91. Pakistani troops fired two rifle shots towards our observation post in an area five miles south-south-east of Rejoke on 27 December 1965.

92. Pakistani troops were observed doing the following:

(1) Digging trenches in an area three and a half miles west-north-west of Dera Baba Nanak on 27 December 1965.

(2) Digging in Bhasin area on 27 December 1965.

(5) Digging fresh positions in Dograi area on 27 December 1965.

(4) Digging in an area one and three quarter miles south-west of Manhiala on 27 December 1965.

95. Pakistani troops were doing the following on 28 December 1965;

(a) Digging fresh trenches in an area three and a half miles west-north-west of Dera Raba Nawak.

(b) Digging in Bhasin area.

(c) Unloading twenty vehicles, containing sand and bricks, in Bhasin area.

94. Pakistani troops fired light machine-guns towards two of our posts in areas three miles and three and a half miles north of Khemkaran on 28 December 1965.

95. Pakistani troops fired light machine-guns towards two of our posts in areas four and a half miles south and two and a half miles south-south-west of Barki on 28 December 1965.

96. Pakistani troops were observed strengthening and improving defences as under:

 In an area four miles west-north-west of Dera Baba Nanak on 29 December 1965.

(2) In Bhasin area on 28 and 29 December 1965.

(3) In an area two miles north-north-west of Barki on 29 December 1965.

Fazilka Sector

97. Pakistani troops fired medium machine-gun fire towards our post in an area three and a half miles north-north-east of Hussainiwale on 25 December 1965.

/ ...

98. Pakistani troops fired as under:

(1) Light machine-guns towards our post in an area four miles north-east of Ferozepur Headworks on 24 December 1965.

(2) Small arms towards our post and a patrol in an area three and a half miles and four miles west of Mamdot respectively on 23 December 1965.

(3) Two medium machine-gun bursts towards our post in an area three and a half miles west-north-west of Mandot on 24 December 1965.

(4) One rifle shot towards our post in an area three miles west-north-west of Fazilka on 24 December 1965.

(5) Two rifle shots towards our post in an area one mile west-north-west of Chanarwala on 24 December 1965.

(6) Two and three rifle shots towards our post and a patrol in Chananvala area on 24 December 1965.

99. Pakistani troops were seen digging in areas four and a half miles and five and a half miles north-west of Fazilka on 25 December 1965.

100. Pakistani troops fired rifle shots towards our posts in an area four and a half miles north of Hussainivala on 25 December 1965.

101. A Pakistani patrol, approximately one section strong, intruded into our area, half a mile east-north-east of Chananwala on 24 December 1965 and fired at our patrol when challenged.

102. Two Pakistani F-86 aircraft flew over Fazilka between 1145 and 1149 hours on 15 December 1965.

103. Pakistani troops fired two medium machine-gun bursts towards our position in an area four miles north-west of Ferozepur Headworks on 25 December 1965.

104. Pakistani troops were observed constructing new bunkers in an area two and a half miles north-north-west of Hussainiwala on 26 December 1965.

105. Pakistani troops were observed digging in an area four and a quarter miles and five miles north-west of Fazilka on 26 December 1965.

106. Pakistani troops fired towards our position on 25 and 26 December 1965 as under:

 Small arms towards our patrol four and three quarter miles west-southwest of Mamdot.

(2) Small arms and 2-inch mortars towards an area seven and a quarter miles south-west of Mandot.

(5) Small arms towards an area five and three quarter miles north-north-west of Jalalabad.

(4) Small arms towards an area three and a quarter miles north-west of Fazilka.

(5) Small arms towards three places in Charanwala area.

107. Pakistani troops fired small arms towards our patrol in an area four and three guarter miles north-north-west of Fazilka on the night of 26/27 December 1965.

108. Pakistani troops were observed constructing bunkers in Chararwala area on 27 December 1965.

109. Pakistani troops were observed digging in an area five miles north-west of Fazilka on 28 December 1965.

11C. Pakistani troops fired medium machine-guns towards two of our posts in an area six miles west-south-west of Hussainiwala on 27 December 1965.

111. Pakistani troops fired light machine-guns and automatic rifles towards our post in an area three and a half miles west-north-west of Mamdot on 27 December 1965.

112. Pakistani troops fired small arms towards our patrol in an area five miles west-south-west of Mandot on 27 December 1965.

113. Pakistani troops fired one burst of Browning machine-guns towards our post in Charanwala area on 28 December 1965.

114. Pakistani troops were observed strengthening and improving defences in Chananyala area on 28 Federater 1965.

115. Pakistani trccps fired small arms towards our patrol in an area nine miles south-west of Mandot on 28 December 1965.

Rajasthan

116. Pakistani troops directed artillery fire towards our post at point 473, approximately four miles south-west of Miajlar on 22 December 1965.

117. A Pakistani jet aircraft flew over our defences in Miajlar, Sato and Kelnor areas on 22 December 1965.

118. A Pakistani air observation post aircraft flew over our defences in an area four miles south-west of Miajlar on 23 December 1965.

119. One Pakistani air observation post aircraft flew over Sinaba from 1215 hours to 1230 hours on 19 December 1965.

Cease-fire violation complaints have been or are being lodged in respect of all these violations.

I shall be grateful if this communication is circulated as a Security Council document.
