ELECTION OF FIVE MEMBERS OF THE INTERNATIONAL COURT OF JUSTICE\*

List of candidates nominated by national groups

Note by the Secretary-General

1. By a communication dated 16 February 1966, the Secretary-General invited national groups, in accordance with Article 5 of the Statute of the International Court of Justice, to undertake the nomination of candidates for the election, to be held during the twenty-first regular session of the General Assembly, to fill the five vacancies in the International Court of Justice which will occur on 5 February 1967 when the terms of office of the following five members of the Court expire:

Sir Percy Spender (Australia) Mr. V.K. Wellington Koo (China) Mr. B. Winiarski (Poland) Mr. J. Spiropoulos (Greece) Mr. F. Ammoun (Lebanon)

In his communication the Secretary-General drew attention, <u>inter alia</u>, to the provisions of Article 5, paragraph 1, of the Statute of the Court that nominations should be undertaken "within a given time", and he requested that nominations should be sent so as to reach him not later than 1 August 1966. Subsequently, the Secretary-General extended this time-limit to 1 September 1966. 2. In accordance with Article 7 of the Statute of the Court, the Secretary-General has the honour to submit to the General Assembly and to the Security Council an alphabetical list of the candidates for the election of five members of the Court nominated by national groups by 1 September 1966.

3. <u>Curricula vitae</u> of the candidates will be circulated subsequently in document A/6421-S/7491.
