LETTER DATED 1 JUNE 1966 FROM THE PERMANENT REPRESENTATIVE OF JCRDAN ADDRESSED TO THE PRESIDENT OF THE SECURITY COUNCIL

I have the honour, upon instructions from my Government, to draw Your Excellency's attention to yet another resolution adopted by the Mixed Armistice Commission at its 428th emergency meeting, held on 17 May 1966, condemning the Israeli authorities for their unprovoked and premeditated attack against the Jordanian village of Rafat and Rujm El Madfa'a Police Post, Hebron area.

I shall be grateful if the text of the resolution together with the text of this letter are circulated as official documents of the Security Council.

JORDAN DRAFT RESOLUTION ON COMPLAINT M-221, AS AMENDED

(AFTER VOTING)

(EM/ N.428)

The HJK-I-MAC having considered HJK Complaint No. M-221 and the investigation reports made on this complaint by the UNMOs and the discussions thereon:

FINDS THAT:

- 1. At approx. midnight time of 29/30 April 1966 Israeli regular armed forces crossed the ADL into Jordan and launched a major unprovoked and premeditated attack against the Jordanian village of RAFAT and RUJM EL MADFA'A Police Post, Hebron area, three kms. in Jordan.
 - A The Israeli military force as a result of this attack have demolished completely eighteen civilian houses by explosive charges.
 - B Three other houses were slightly damaged by explosives used by the attacking force.
 - C In the course of this attack and as a result of the firing by the aggressors, the villagers of RAFAT managed to escape.
- 2. No casualties were caused to the civilian population.

FINDS FURTHER THAT:

- "A" The Police Post RUJM EL MADFA'A was shelled and subjected to a concerted attack.
- "B" As a result of this shelling and the attack, the building of this Police
 Post was severely damaged.
- "C" Two soldiers were wounded.
- "D" Four horses were killed near the stable.
- DEPLORES the wanton demolishing of the houses in RAFAT village, the severe damage to the Police Post and the killing of the Police horses.
- DECIDES that this hostile and warlike act, officially planned against Jordan by the Israeli military regular force, is a most serious and flagrant violation of the G.A.A. article III, paras. 2 and 3.

CONDEMNS the Israeli authorities for this most flagrant act by the Israeli regular army force against Jordan in utter disregard of their solemn obligations under the terms of the G.A.A.

TAKES a most serious view of the Israeli authorities openly admitted aggression in utter disregard of their obligations under the G.A.A.

CALLS UPON the Israeli authorities in the strongest terms to desist from their aggressions against Jordan which constitute a threat to peace and security.
