UNECE/FAO STRATEGIC REVIEW AND INTEGRATED PROGRAMME OF WORK FOR 2005-2008

(Item 10 of the provisional agenda)

Note by the secretariat

The present document presents:

- (a) an account of the strategic review process
- (b) the draft integrated programme of work of the UNECE Timber Committee and the FAO European Forestry Commission for the period 2005 to 2008, for review and endorsement by the joint session.

INTRODUCTION

- 1. The UNECE Timber Committee at its sixty-first session in 2003 and the FAO European Forestry Commission at its thirty-first session in 2002 agreed to carry out a strategic review of their joint integrated programme of work on forests and timber.
- 2. Member countries and stakeholders were invited to participate in the process by means of a questionnaire. Twenty-three responses were received, of which 15 from member countries. An extended Bureaux meeting held in Geneva on 1-2 April 2004 examined the replies and made proposals (see report on the website) to the annual joint bureaux meeting of the TC and the EFC in May 2004 (see report on the website).
- 3. The regular joint bureaux meeting on 7 May agreed with the objective, strategy for 2005-2008, expected accomplishments and indicators of achievement, programme elements and formal structure. The Bureaux approved the draft strategic plan reproduced in the annex and agreed that it be submitted for discussion and formal adoption to the joint session of the UNECE Timber Committee and FAO European Forestry Commission.
- 4. The integrated programme of work 2005-2008 will have increased emphasis on communicating and fund raising. A fund raising strategy is being prepared and will be circulated before the joint session for comments. In addition, significant inputs will be expected to UNECE cross-sectoral activities, and the external evaluation of UNECE's role and structure.
- 5. One topic remains under discussion, the future of the Joint FAO/ECE/ILO Committee on Forest Technology, Management and Training. The regular joint bureaux meeting further made the following remarks:

"The meeting reiterated that the Joint Committee had done an excellent and innovative work while adapting its methods of work. Communication and reporting between the Joint Committee and its parent bodies could have been improved. Resources of the partner organisations, FAO HQ, UNECE and ILO, had been reduced and there was a need to prioritise activities. The meeting stressed the interest attached by countries to work area 4, social and cultural aspects of forestry, which would be maintained regardless of the discussion concerning the Joint Committee.

The meeting acknowledged the benefits of supporting a Network of committed practitioners, and the fact that the existence of such an institution could support funding applications. It stressed that the TC and the EFC, with the secretariats, were responsible for all activities under the integrated programme and it was essential that mechanisms be in place for them to exercise this responsibility.

The meeting decided that:

- The proposal to discontinue the Joint Committee as a permanent subsidiary body should be maintained;
- That the member countries should be invited to form a Network (exact title to be determined)
 and to indicate in what way the new Network could contribute to the implementation of the
 integrated programme;
- Work methods should be agreed which enabled the Network to contribute effectively to the integrated programme of work, while minimizing the requirements for secretariat resources and allowing the Bureaux and the secretariat to maintain full responsibility for the content and quality of the outputs;

- The Joint Committee Steering Committee should be requested to make proposals on the set up, structure, methods and activities of the new Network before the summer break. These proposals will be presented and discussed at the twenty-fifth session of the Joint Committee in the Netherlands in September. A joint meeting of the Bureaux on the occasion of the Joint Committee session in Groningen should agree on a format, for approval by the joint session.
- The Joint Committee should make proposals on the implementation of activities which are part of the present integrated programme of work and also of the MCPFE programme.

The meeting asked the secretariat to consult with ILO, when the new staff member is appointed, if and to what extent they would be in a position to contribute resources to the joint programme."

- 6. Subsequently, the ILO staff member responsible (50% of his time) for forest and timber matters has indicated ILO's support for the goals of the Joint Committee and commitment to complete work under way at present. ILO wishes to cooperate in the future with UNECE/FAO on specific activities in the social and cultural area, on an ad hoc basis, but unfortunately does not have the resources to commit to maintaining secretariat services to a permanent intergovernmental body such as the Joint Committee.
- 7. The Joint Committee Steering Committee is preparing a proposal as requested by the bureaux. The joint session will be informed of discussions between the Joint Committee and the Chairmen of the TC and the EFC to be held on the occasion of the twenty-fifth session of the Joint Committee in September in the Netherlands.

The TC and the EFC are invited to review and endorse the integrated programme for 2005-2008 developed during the strategic review process.

It should agree on:

- the objective,
- the strategy,
- expected accomplishments and indicators of achievement,
- the programme elements,
- activities and outputs, methods of work, and
- the draft mandates of teams of specialists.

UNECE Timber Committee and the FAO European Forestry Commission Integrated programme of work on forests and timber

Objective

To contribute to achieving sustainable forest management, including the sound and legal use of wood, other forest products and services, throughout the UNECE region, and to ensure measurement of that progress.

To contribute to this objective, the TC and the EFC will promote cooperation between countries in the region and develop regional and sub-regional initiatives.

Strategy for 2005-2008

In order to support forest management, including the use of wood, other forest products and services, which is sustainable from the ecological, economic and social point of view, it is necessary to maintain a good balance between these three aspects. This balance should be based on a strong consensus about goals and methods among all stakeholders, and well integrated into the policy framework for other sectors (the cross-sectoral approach).

Achieving sustainable forest management is primarily a sovereign national responsibility. However, regional international cooperation, through the integrated UNECE/FAO programme and its partners, will contribute by developing and disseminating concepts, and information, sharing experience and defining standard measurement tools (indicators).

The main contribution of the programme is through developing and applying tools to analyse and monitor both policy and developments on the ground, collecting, validating and disseminating information and analysis, as well as stimulating the exchange of experience, and joint efforts to measure progress.

While all countries benefit from international cooperation, the programme recognizes the special needs of the countries of the CIS and south east Europe, where forest sector problems tend to be more acute and national capacity weaker.

Expected accomplishments and indicators of achievement

- 1. Improved practice of sustainable forest management, supported by an increased ability to measure sustainable forest management at the national and regional level.
 - 1.1. Percentage of UNECE countries with national forest programme (nfp) or similar holistic forest sector policy framework
 - 1.2. Percentage of UNECE countries able to provide satisfactory data on indicators of sustainable forest management to the Fifth Ministerial Conference on the protection of Forests in Europe
- 2. Improved policies to promote the sound use of wood, and increased ability to monitor it
 - 2.1. Percentage of UNECE countries with policies in place on sound use of wood, whether or not in the context of national forest programmes
 - 2.2. Percentage of UNECE countries able to provide satisfactory responses to UNECE/FAO/ITTO/Eurostat joint forest sector questionnaire

- 3. Increased capacity of countries in CIS and south-east Europe to achieve sustainable forest management at the national level, notably through developing appropriate policy measures
 - 3.1. Number of experts from CIS and south-east Europe participating in subprogramme workshops and seminars, and considering these activities of adequate relevance and quality
 - 3.2. Improvement in administrative capacity of CIS and south east European countries, as evidenced by the number of these countries adopting national forest programmes

Main activities and outputs, methods of work

The proposed main activities, outputs and methods of work, as well as partnerships and the allocation of Geneva based secretariat resources are attached. However, this operational information does not necessitate formal approval by intergovernmental bodies.

Formal structures:

UNECE Timber Committee

Meets annually in Geneva, as a forum for policy discussion and for discussion of market trends and outlook. It also reviews implementation of the work programme. Every four years, it meets in joint session with the European Forestry Commission, to carry out a strategic review of the whole integrated programme. The next joint session after 2004 will be in 2008 in Rome.

FAO European Forestry Commission

Meets every two years, alternately in a HQ location (Geneva or Rome) and a member country. It reviews recent developments in policy and institutions and acts as a policy forum. It identifies emerging policy issues in the region for the FAO Committee on Forests (COFO). It also reviews implementation of the work programme.

Bureaux

The Bureaux consist of the office-holders (Chairman and Vice-Chairs) of the TC and the EFC and the Chair of the Working Party. They meet at least annually, usually with representatives of MCPFE. The Bureaux decide on how the work programme is to be implemented.

Joint FAO/ECE Working Party on Forest Economics and Statistics

Meets annually in Geneva to provide guidance to activities in work areas 1, 2 and 3, as well as any other linked activity.

Teams of specialists

Several activities are implemented or guided by teams of specialists, which are time limited, voluntary groups of experts who work with the secretariat to achieve specified goals. Each team has time limited, specific terms of reference in a standard format. Drafts of these mandates are attached, although some await input from other partners, and are not final. The integrated programme has 7 teams as follows:

- Markets and marketing (work area 1)
- Monitoring forest resources for sustainable forest management in UNECE Region (work area
 2)
- Gender and forestry (element 4.1)
- Best practices in forest contracting (element 4.3)
- Support and contribution to sustainable development of the forest sector in central and eastern Europe and in the CIS (element 5.3)
- Forest fire (element 5.5)
- Forest communicators network (element 5.6)

Partnerships

The TC and the EFC work wherever possible in partnership with other organisations. As of 2004, there are operational partnerships in place with MCPFE, Eurostat and ITTO, and cooperation with a very wide range of organisations. There is scope for developing and strengthening partnerships with

several other organisations, including, among intergovernmental organisations the EU (DGs ENV, AGRI and INDUSTRY, COST Actions), EEA, ILO, EFI, and a wide range of NGOs, including WWF, IUCN, CEPI, CEI-Bois, CEPF, ENFIN. The modalities of cooperation should be determined and reported by programme element.
