LETTER DATED 2 NOVEMBER 1965 FROM THE PERMANENT REPRESENTATIVE OF INDIA
ADDRESSED TO THE SECRETARY-GENERAL

I have the honour to communicate the following further cease-fire violations and other incidents created by Pakistan.

Jammu and Kashmir

Gurais Sector

1. Pakistani troops directed medium machine-gun and mortar fire towards our post in an area nineteen miles north-west of Kanzalwan on 29 October 1965.

Keran Sector

2. Nine Pakistani troops were seen improving defences in an area five miles north of Keran on 28 October 1965.

3. Pakistani troops directed mortar fire towards our posts in areas thirteen and fourteen miles east-north-east of Keran on 29 October 1965.

4. Pakistani troops approximately one section strong were seen improving defences in an area ten miles north-east of Keran on 29 October 1965.

Tithwal Sector

5. Fifteen and thirty Pakistani troops were seen constructing bunkers five and five and a half miles south-west of Tithwal, respectively, on 28 October 1965.

6. Pakistani troops directed small arms and artillery fire towards our posts in areas seven miles north-north-west of Tangdhar and six miles south-east of Tithwal on 28/29 October 1965.

Uri Sector

7. Pakistani troops were seen strengthening their defences in an area Pir Kanthi two miles south-west of Uri on 28 October 1965.

8. Pakistani troops were observed fixing wire and laying mines in an area one mile west of Haji Pir pass on 28 October 1965.

9. Pakistani troops were seen constructing bunkers in areas eight and a half miles west and nine and a half miles south-west of Uri on 29 October 1965.

Gulmarg Sector

10. Pakistani troops fired 81 mm mortars, medium machine-guns and 3.7-inch Howitzers towards our three posts in an area nineteen miles west-north-west of Kanzalwan on 28 October 1965 in the presence of a United Nations observer.

Mendhar Sector

11. Pakistani troops were seen digging in an area ten miles west of Mendhar on the evening of 28 October 1965.

12. Pakistani troops directed 81 mm mortars, 3-inch mortars, 3.7-inch Howitzers and Browning machine-gun fire towards five of our posts in areas nine and a half miles west-north-west to seven and a half miles south-south-west of Mendhar on 28 and 29 October 1965.

13. Pakistani troops directed small arms mortar and artillery fire towards our four posts in areas eight miles west to five miles south-west of Mendhar on the night of 29/30 October 1965.

Naushahra Sector

14. Pakistani troops fired field guns towards an area approximately four miles east-north-east of Jhangar on 29 October 1965.

15. A Pakistani patrol infiltrated in an area four miles north-east of Jhangar on 29 October 1965.

16. Pakistani troops directed artillery fire towards our posts in areas three to five and a half miles east-north-east of Jhangar on 30 October 1965.

17. A Pakistani patrol was seen moving in an area five miles north-east of Jhangar on 30 October 1965.

18. Pakistani troops were seen improving defences in areas four miles west to four and a half miles north-east of Jhangar on 30 October 1965.

Akhnur Sector

19. Five Pakistani troops were seen constructing bunkers in an area six and a half miles north-north-east of Jaurian on 28 October 1965.

20. Nine Pakistani troops were seen digging trenches and constructing bunkers in an area approximately three miles south-west of Balwinder Bridge on 28 and 29 October 1965.

21. Approximately twenty-seven Pakistani troops were seen digging trenches in an area, at point 2710, four miles west-south-west of Balwinder Bridge on 29 October 1965.

22. Pakistani troops were seen constructing bunkers in areas seven miles west-north-west of Akhnur and three miles south-west of Balwinder Bridge on 30 October 1965.

Punjab

Sialkot Sector

23. Thirty to forty Pakistani troops in khaki and civil dress were observed digging crawl trenches in an area three and a half miles west-north-west of Suchetgarh at 1030 hours on 29 October 1965. They stopped digging on arrival of a United Nations observer.

24. Three Pakistani troops were observed improving defences in an area four and a half miles west of Bajrangarhi on 29 October 1965.

25. Pakistani troops were noticed digging twice in an area approximately four miles west of Phillora on the night of 28/29 October 1965.

26. Pakistani troops directed small arms fire towards our positions in an area five miles south-west of Phillora on the night of 29/30 October 1965.

27. Pakistani troops directed small arms fire towards our posts in areas five to six miles east of Chawinda on the night of 29/30 October 1965.

28. Three Pakistani soldiers were seen crawling towards our post in an area three and a half miles west of Phillora on 30 October 1965. They ignored our warning to stop.

Lahore Sector

29. Pakistani troops were observed digging in an area approximately one mile north of Jallo on 29 October 1965.

30. Approximately one company of Pakistani troops were seen debussing and moving in small groups towards the west bank of Ichhogil Canal in an area four miles west of Hudiara on 28 October 1965.

31. Pakistani troops fired towards our post in an area one and a half miles south-east of Bedian on the night of 28/29 October 1965.

32. Pakistani troops fired on our positions in an area three and a half miles south-south-east of Bedian on 29 October 1965.

33. Pakistani troops were seen digging fresh trenches and bringing defence stores in Paranawala area four miles north-west of Dera Baba Nanak on 30 October 1965.

34. A Pakistani air observation post aircraft flew from Narowal Kartarpur direction towards our positions in an area two and a half miles north-west of Dera Baba Nanak and back on 30 October 1965.

35. Pakistani troops directed small arms fire towards our post in an area half a mile north of Bhasin on 29 October 1965.

36. A Pakistani air observation post aircraft was seen flying over areas half a mile north-west of Dograi to one and a half miles north-north-west of Bhasin at 1730 hours on 29 October 1965.

37. Two Pakistani army sections arrived in an area three and a half miles south-south-west of Barki on 29 October 1965.

38. Pakistani troops were observed constructing bunkers and bringing up defence stores in areas two miles north-north-west to three and a half miles south of Bhasin on 30 October 1965.

39. Pakistani troops were observed constructing bunkers, improving defences and laying wire in areas four miles north-north-west to two and a half miles south of Barki on 30 October 1965.

40. Pakistani troops were noticed digging in an area south of Dograi on the night of 30/31 October 1965.

41. Pakistani troops directed medium machine-gun fire towards our post in an area three miles south of Barki on the night of 30/31 October 1965.

Fazilka Sector

42. Pakistani troops fired at our posts at Jalloke Dauan and Rajamotan, fourteen and sixteen miles south-west of Hussainiwala, respectively, on the night of 28/29 October 1965.

43. Pakistani troops fired with small arms and medium machine-gun towards our post at Rajoke on 29 October 1965.

44. Pakistani troops fired towards our positions in an area five and a half miles south-west and approximately three miles west of Fazilka on 29 October 1965.

45. Forty Pakistani civilians were seen picking cotton from Pakka and Beriwalla, seven and a half and six and a half miles south-west of Fazilka, respectively, on 29 October 1965.

46. Pakistani troops fired at our patrol in Nathalke area nine and a half miles north-north-east of Jalalabad on 30 October 1965.

47. Pakistani troops directed small arms fire towards our posts in an area three miles west-north-west of Fazilka on 29 October 1965.

48. Approximately thirty Pakistani troops arrived in an area four and a half miles south-west of Fazilka and started digging on 30 October 1965.

49. A Pakistani air observation post aircraft was seen flying over areas six and a half miles west-south-west to three miles west of Fazilka at 1130 hours on 30 October 1965.

Rajasthan

50. A Pakistani patrol approximately two sections strong was seen one mile south-east of Ghotaru at 1600 hours on 29 October 1965.

Cease-fire violation complaints have been or are being lodged in respect of all these violations.

I shall be grateful if this communication is circulated as a Security Council document.
