LETTER DATES 3 NOVEMBEE 1965 FROM THE PERMANENT REPRESENTATIVE OF PAKISTAN ADDRESSED TO THE SECRETARY-GENERAL

I have been instructed by my Government to inform you of the following violations of the cease-fire by Indian forces:

- (1) Indian troops fired with small arms on our troops located in area 768834 from 1830 hours to 1900 hours on 17 October 1965.
- (2) Indian troops were concentrating on the night of 18 and 19 October six miles north and north-west of Asutar LQ 8253. This was a clear indication of their hostile intention to attack either Ghotaru or Longanewala or both.
- (3) Indian troops fired with automatic weapons on our troops in area 768838 at 2100 hours on 19 October 1965.
- (4) Indian troops fired on our troops in area 791756 at 1630 hours on 19 October 1965.
- (5) Indian troops fired one light machine-gun burst in close vicinity of our screen at GR 864592 at 2145 hours on 19 October 1965.
- (6) Strong Indian patrols came to Village Goth Dipla in Rajasthan at 0930 hours on 19 October and turned out all the Muslim civilians from their homes and set fire to the village. Many Muslims were killed. Some of them escaped to Pakistan Village Tar Detar Dino Thesa.
- (7) An Indian aircraft flew over our territory in areas 2457 and 2556 from 0920 hours to 0925 hours on 20 October 1965.
- (8) Indian troops fired with mortars, automatic weapons and small arms on our position Shah Mohammad Bareke SM 2739 from 0920 hours to 1130 hours on 20 October 1965.
- (9) Indian troops directed heavy automatic and small arms fire from GR 248585 on our positions in area 2557 from 0925 hours to 0950 hours on 20 October 1965.

- (10) Indian troops fired with machine-guns and small arms from GR 263574 on our positions in area 2557 from 0520 hours on 20 October 1965.
- (11) One Indian reconnaissance aircraft flew over our position at Shah Mohammad Bareke SM 2739 at 0915 hours on 20 October 1965.
- (12) An Indian patrol came to area SM 2839 at 1605 hours on 20 October 1965 and opened fire on our position Shah Mohammad Bareke.
- (13) Indian troops fired three overhead rifle rounds over our screen positions GR 818599 and 823596 at 0735 hours, 1415 hours and 1545 hours on 20 October 1965.
- (14) One Indian patrol was observed patrolling on track Asutar IQ 8253 Ghotaru IQ 7666 at a distance of only 2,000 yards from Ghotaru at 2000 hours on 2C October 1965.
- (15) Indian troops laid mines in area 2562 and 2561 during the night of 20 and 21 October 1965.
- (16) Indian troops fired with automatic weapons and small arms on our position in area 2557 between 1420 hours and 1530 hours on 21 October 1965.
- (17) Indian troops supported by tanks occupied a position north of Kalron Ka Tala at 1700 hours on 21 October 1965.
- (18) Indian troops were reported to have moved towards Huron Ka Tala on 21 October 1965.
- (19) One platoon of Indian soldiers was seen planting mines in general area 40K QA 9573, 9572 and 9571 at 1430 hours on 22 October 1965.
- (20) One Indian Vampire aircraft flew over and strafed our post at Ghotaru IQ 7105 at 1207 hours on 27 October 1965.

UNIPOM has been informed of the above violations.

I shall be grateful if this letter is circulated as a Security Council document.
