LETTER DATED 3 NOVEMBER 1965 FROM THE PERMANENT REPRESENTATIVE OF INDIA
ADDRESSED TO THE SECRETARY-GENERAL

I have the honour to communicate the following further cease-fire violations and other incidents created by Pakistan:

Jammu and Kashmir

Kargil Sector

1. Eight Pakistani troops were seen in an area eleven miles north-west of Kargil on 29 October 1965. They were trying to improve the defences in this area.

Gurais Sector

2. Twenty-six Pakistani troops were seen constructing bunkers in an area eight miles north-east of Gurais on 30 October 1965.

Keran Sector

3. Pakistani troops were seen constructing bunkers in an area three miles north of Keran on 30 October 1965.

Tithwal Sector

4. Pakistani troops fired 81 mm mortars towards our post in an area three miles north-west of Tangdhar on 31 October 1965.

Uri Sector

5. Twenty Pakistani troops were seen improving defences in areas three and a half and five and a half miles south of Haji Pir Pass on 30 October 1965.

6. Pakistani troops were seen constructing bunkers in areas nine miles west to nine miles south-west of Uri on 30 October 1965.

Punch Sector

7. Pakistani troops fired rifle shots towards our post in areas five miles west and six miles south-west of Punch on 30 October 1965.

Mendhar Sector

8. Pakistani troops fired twenty-five pounders, 106/57 recoilless guns, 5.7 inch Howitzers, 81 mm mortars and machine-guns towards our posts in an area between four miles west south-west and nine miles west north-west of Mendhar on 30 October 1965.

Naushahra Sector

9. Pakistani troops fired 25 pounders towards our post in an area three miles north north-west of Jhangar on 30 October 1965.

10. Pakistani troops fired field guns towards our posts in an area between three and a half miles to five and a half miles east north-east of Jhangar on 30 October 1965.

11. Pakistani troops were seen constructing bunkers in areas between four miles west and three miles north of Jhangar on 30 October 1965.

Akhnur Sector

12. Pakistani troops were seen constructing bunkers in an area six miles west of Akhnur on 31 October 1965.

13. Pakistani troops were seen digging and constructing bunkers in an area three and a half miles and four and a half miles west south-west of Balwinder Bridge on 31 October 1965.

Punjab

Sialkot Sector

14. Three Pakistani troops intruded into our area, four miles north-west of Chawinda, at 0825 hours on 31 October 1965 and fired at our troops.

15. Pakistani troops were seen carrying defence stores in an area three and a half miles north-west of Suchetgarh on 31 October 1965.

16. Pakistani troops were seen improving their defences in areas from six miles south south-west to three miles north north-west of Suchetgarh on 31 October 1965.

Lahore Sector

17. One Pakistani vehicle unloaded defence stores in an area 400 yards south of Bhasin on 31 October 1965.
18. Pakistani troops were improving their defences in areas two and a half miles south and two miles south south-west of Jallo on 31 October 1965.
19. Pakistani civil lorries were seen unloading boxes containing defence stores in an area two and a half miles south south-west of Barki on 31 October 1965.
20. One Pakistani bulldozer was seen working in an area two and a half miles west south-west of Barki on 31 October 1965.
21. Pakistani troops were seen improving defences in an area four miles south south-west of Bedian on 31 October 1965.
22. Pakistani troops fired small arms towards our posts from Bhukkiwala area, three and a half miles east south-east of Rattoke at 1050 hours on 31 October 1965.
23. One Pakistani three-ton vehicle, full of troops, was seen moving in Bhukkiwala area on the evening of 31 October 1965. The enemy is sending reinforcements into this area.
24. Pakistani troops were seen laying mines in an area one mile east north-east of Khemkaran at 0900 hours on 31 October 1965.
25. Pakistani troops were seen bringing reinforcements (approximately one company) in an area five and a half miles north of Khemkaran on 31 October 1965.
26. A Pakistani patrol intruded into our area, two miles east north-east of Rattoke at 1000 hours on 31 October 1965, withdrew on being warned, but fired back at our troops.
27. A Pakistani patrol intruded into our territory, took up positions in an area two and a half miles east of Rattoke, and started firing towards Jhuggian Nur Mohammed, approximately four miles east south-east of Rattoke, on 31 October 1965. The patrol withdrew when warned.

Fazilka Sector

28. Pakistani troops were digging in areas two miles north north-west of Chananwala Railway Station and four miles west of Fazilka during the night of 30/31 October 1965.
29. Pakistani troops fired at our patrol in an area ten miles west of Ferozepore at 0930 hours on 30 October 1965.

30. Pakistani troops fired small arms at our positions in an area three miles west of Fazilka on 31 October 1965.

Rajasthan

31. Ten to fifteen Pakistani troops intruded into our territory in Dipla, sixty-two miles south-west of Barmer, at 1130 hours on 30 October 1965. They fired at our patrol in this area and later went back to their own territory.

32. One Pakistani aircraft flew over Tanot from north to south at 1335 hours on 1 November 1965.

Cease-fire violation complaints have been or are being lodged in respect of all these violations.

I shall be grateful if this communication is circulated as a Security Council document.
