# Note by the Secretary-General

- 1. By a communication dated 12 August 1965 the Secretary-General, in accordance with Articles 5 and 14 of the Statute of the International Court of Justice, invited national groups to undertake the nomination of candidates for the election, to be held during the twentieth regular session of the General Assembly, to fill the vacancy in the International Court of Justice caused by the death of Judge Abdel Hamid Badawi on 4 August 1965. In accordance with Article 15 of the Statute, the term of office of the person elected to fill the vacancy will expire on 5 February 1967, the date on which the deceased member's term of office would have expired.
- 2. In the aforementioned communication, the Secretary-General drew attention, inter alia, to the provisions of Article 5, paragraph 1, of the Statute of the Court that nominations should be undertaken "within a given time", and he requested that nominations should be sent so as to reach him not later than 15 October 1965.
- 5. In accordance with Article 7 of the Statute of the Court, the Secretary-General has the honour to submit to the General Assembly and to the Cecurity Council an alphabetical list of the candidates for the election nominated by national groups within the given time.
- 4. Curricula vitae of the candidates accompany the list.
