## 信息社会世界峰会执行秘书处的说明

### 参加信息社会世界高峰会议的非政府组织、民间团体和工商实体的 资格认定

1.

联合国大会第A/RES/56/183号决议鼓励联合国所有相关机构、特别是信息通信技术任务组，做出有效的贡献和积极参与，并鼓励其他政府间组织，包括国际和区域性机构、民间团体和私营部门，对高峰会议的政府间筹备进程和高峰会议本身做出贡献和积极参与。

2. 在政府间筹备委员会第一次会议上，各国政府通过了资格认定安排（WSIS/PC-1/DOC/11号文件附件3，见[http://www.itu.int/wsis/docs/pc1/official/arrangements\\_accreditation.doc](http://www.itu.int/wsis/docs/pc1/official/arrangements_accreditation.doc)）。

3.

根据资格认定安排，资格认定申请须通过邮递或传真的方式提交执行秘书处。提交资格认定申请的截止日期为每次政府间筹备委员会会议开始六周前。执行秘书处在联合国非政府组织联络处（NGLS）的协助下，根据申请者的背景及其在信息社会问题方面的参与情况，对其工作的相关性进行审议，并向政府间筹备委员会提出建议，以利该委员会就那些相关的、且其活动与峰会工作有关的非政府组织、民间团体和工商实体的资格认定做出决定。执行秘书处在每次政府间筹备委员会会议开始两周前，将资格认定推荐实体名单发给各会员国。

4.

执行秘书处已对2003年1月5日前收到的完整申请进行了评估。本文件**附件1**中含有非政府组织和民间团体实体的名单，**附件2**中含有执行秘书处推荐在此阶段进行资格认定的工商实体的名单。那些政府间筹备委员会第一次会议进行了临时资格认定、且符合资格认定安排中所规定条件的实体也包括在名单中。

5.

资格认定安排进一步做出规定，那些目前在经济与社会理事会（ECOSOC）具有咨商地位、且希望参加筹备委员会会议和峰会的非政府组织必须通知执行秘书处并进行登记。作为规定，它们将被认作已获资格认定。这类非政府组织的名单将在政府间筹备委员会开会两星期前发给会员国。因此，**附件3**含有那些目前在经济与社会理事会（ECOSOC）具有咨商地位、且表示希望参加筹备委员会会议和峰会的非政府组织名单。
