Operational activities for development

Report of the Second Committee*

Rapporteur: Mr. Azanaw Tadesse **Abreha** (Ethiopia)

1. At its 2nd plenary meeting, on 17 September 2004, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-ninth session the item entitled:

“Operational activities for development:

“(a) Operational activities for development of the United Nations system;

“(b) Triennial comprehensive policy review of operational activities for development of the United Nations system”

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate on sub-items (a) and (b) at its 25th and 26th meetings, on 4 November 2004. An account of the Committee’s consideration of the item is contained in the relevant summary records (A/C.2/59/SR.25 and 26). Attention is also drawn to the general debate held by the Committee at its 2nd to 8th meetings, from 4 to 6 October and on 12 October 2004 (see A/C.2/59/SR.2-8). An account of the Committee’s further consideration of the item will be given in an addendum to the present report (A/59/488/Add.1).

4. At the 25th meeting, on 4 November, introductory statements were made by the Executive Director of the United Nations Development Fund for Women and the Assistant Secretary-General of the Department of Economic and Social Affairs, under sub-items (a) and (b), respectively (see A/C.2/59/SR.25).

Also at the 25th meeting, pursuant to section C, paragraph 3 (d) of the annex to General Assembly resolution 58/316 of 1 July 2004, the Committee held a dialogue with the substantive representatives, during which comments were made and questions were posed by the representatives of Canada, Ghana and Burkina Faso, to which the Executive Director of the United Nations Development Fund for Women and the Assistant Secretary-General of the Department of Economic and Social Affairs responded (see A/C.2/59/SR.25).

6. At the same meeting, the Under-Secretary-General and High Representative of the Secretary-General for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States made a statement (*ibid.*).
