UNECE RECOMMENDATION FOR EARLY AND WARE POTATOES

Proposals Transmitted by Belgium

Note by the secretariat: The following document contains proposals for the amendment of the UNECE Recommendation for Early and Ware Potatoes.

- 1. Change the name of the standard in 'UNECE Standard FFV-30 for POTATOES', so you don't have to repeat 'early and ware' all the time. Leave out in the complete standard 'early and ware'.
- 2. If so, next to the definition of early potatoes, should come a definition for ware potatoes. Or at least mention the two groups of potatoes meant in this standard.
- 3. A. Minimum requirements (a), dash 6, dash 2: 'Cracks, ...': make the maximum depth '5 mm' for early AND ware potatoes. Or is it really necessary to have 2 different depths, because of differences in skin? It sure is difficult for the inspector (and the trade) to remember 2 different values. It would make the standard easier to read and to apply
- 4. A. Minimum requirements (a), dash 6, dash 3 : change 'pale green flush' in 'a pale green flush' (I suppose this is a bit hairsplitting, but I promised to make a remark on that)
- 5. A. Minimum requirements (a), dash 7 'grey, blue or black sub-epidermal stains; exceeding 5 mm in depth in the case of ware potatoes': cross out 'in the case of ware potatoes', because this should also be valid for early potatoes.
- 6. A. Minimum requirements (a), dash 9 'deep common potato scab and powdery potato scab of a depth of 2 mm or more in the case of ware potatoes'; cross out 'in the case of ware potatoes', because this should also be valid for early potatoes.
- 7. A. Minimum requirements (a), \$2, 'In the case of early potatoes a partial absence of the skin shall not be considered as a defect. Ware potatoes must be covered with well-formed skin.': I would like to put it with A. Minimum requirements (a), dash 2 'intact'.
- 8. A. Minimum requirements (a), \$3, 'In early potatoes no sprouting is allowed. Ware potatoes must be practically unsprouted, i.e. sprouts may be no longer than 3 mm': I would like to put it with A. Minimum requirements (a), dash 'sprouting' (which was crossed out before).
- 9. IV. A. Quality tolerances (ii): cross out the 2 dashes and replace with '2 per cent by weight of waste, of which a maximum of 1 per cent attached earth.' The standard would become easier to read and to apply if there would only be one value for waste/earth for Early and ware potatoes.
