## LAWS AND REGULATIONS

PROMULGATED TO GIVE EFFECT TO THE PROVISIONS OF THE INTERNATIONAL TREATIES ON NARCOTIC DRUGS AND PSYCHOTROPIC SUBSTANCES

THE GOVERNOR of the Netherlands Antilles,

Having considered: that the Opium National Ordinance 1960 (O.G. 1960, no. 65), as amended, the last time by national ordinance of February 7 1978 (O.G. 1978, no. 42), be further amended;

Having heard the Advisory Council, has laid down the following national ordinance in due consultation with Parliament:

# The second of the second Article 1

The Opium National Ordinance 1960 (O.G. 1960, no. 65), as amended, shall be further amended as follows:

- I. The heading shall read:
  "National Ordinance of March 28 1960 to lay down the provisions concerning opium and other narcotic drugs, as also concerning preparations which have a consciousness altering effect on the human being.".
- "that it shall be necessary to adjust the provisions concerning opium and other narcotic drugs to the provisions of the Single Convention on Narcotic Drugs signed in New York on March 30 1961, 1961 with appendices (Convention Memorandum ("Tractatenblad") 1963, no. 81), as also to effect some further arrangements thus allowing of a more effective way of combating the illicit trade in narcotic drugs and in preparations which have a consciousness altering effect on the human being;".
- III. At the End of the provision under the letter 1 of the first paragraph of article 1, the full stop shall be changed into a semi-colon, and to the first paragraph of article 1 the following provision shall be added:
  - "m. Substance: substance of human, animal, vegetable or chemical origin, such to include animals, plants, parts of animals or plants, as also micro-organisms;
  - n. compound: a solid or liquid mixture of substances;
  - o. preparation: substance or compound.".

- IV. The first paragraph of Article 3, under g, shall read: "g. the preparations to be designated by the minister, which have been included to fall within the scope of the Single Convention, and consciousness altering preparations, which, on being used, may be harmful to the health of the human being or to the community.".
  - V. In article 7, first paragraph under a, "preparation" shall be read instead of "narcotic drug".

Article 2

Decrees laid down by the Minister of Public Health pursuant to article 3, first paragraph under g, of the Opium National Ordinance 1960, as that section of the article read prior to the effectiveness of this national ordinance, shall be deemed laid down pursuant to the section of the article amended under VI in article 1 of this national ordinance.

Article 3

This national ordinance shall enter into force as and from the first day of the third month following that in which this national ordinance is proclaimed.
