In relation to the resolution adopted on the 23rd of this month by the Council of the OAS, acting provisionally as Organ of Consultation, and upon precise instructions that I have received from my government, I have the honor to inform you that on the 24th of this month the President of the Republic, Lieutenant Colonel Julio Adalberto Rivera, declared that the Government of El Salvador will unreservedly contribute its moral and material support to the execution of all those initial steps that tend to create more effective security measures against the various acts of extracontinental aggression, and that it adheres to the firm measures taken by the United States Government to halt the threat of soviet aggression in our hemisphere.

Excellency:

I have the honor to refer to paragraph four of the resolution of the Council of the Organization of American States serving provisionally as Organ of Consultation, which requests Member States to keep the Organ of Consultation informed of measures taken by them in accordance with paragraph two of the same resolution and to inform you that the quarantine instituted by the Government of the United States, in accordance with paragraph two, on October 24, 1962, was lifted for 48 hours, beginning daybreak October 30, 1962. The quarantine was reinstituted beginning daylight on November 1, 1962. The air surveillance of Cuba was also suspended for two days starting October 30, 1962. On November 1, 1962 the surveillance was resumed.

Sir:

In further reference to my note OEA No. 96, of October 27 last, in which I announced the departure of the destroyers "ROSALES" and "ESPORA" to participate in the quarantine operations undertaken in accordance with the recommendation of the Council of the OAS acting provisionally as Organ of Consultation on October 23, I am particularly pleased to advise you that for the purpose of participating with the combined forces in the search, rescue, and observation operations, the Government of Argentina has formed a group that has three aircraft; and that another Air Force group composed of three crews is undergoing an adaptation and training course, at the end of which it will join the combined forces in the Caribbean.

The government that I have the honor to represent has also, in conformity with the provisions of Resolution III.l.a of the Fourth Meeting of Consultation of Ministers of Foreign Affairs, ordered the Argentine Army to instruct a brigade to participate in the maintenance of continental peace should this become necessary.

Sir:

With reference to the content of paragraph 4 of the operative part of the resolution adopted on October 23, 1962, by the Council of the Organization of American States, acting provisionally as Organ of Consultation, and following the instructions of my government, I have the honor to acquaint you with the text of the following communique issued yesterday by the cabinet office of the Ministry of Defense of Venezuela:

"By provision of the National Government and in accordance with the recommendations of the provisional Organ /of Consultation/ of the Organization of American States, the Ministry of Defense reports that it has detached the destroyers 'Nueva Esparta' and 'Zulia' to cooperate with the forces of other member countries of the Organization on patrolling missions in areas near the eastern coastline of Venezuela."

> NOTE FROM THE DELEGATIONS OF THE UNITED STATES OF AMERICA, ARGENTINA AND THE DOMINICAN REPUBLIC, DATED NOVEMBER 9, 1962, REGARDING THE ESTABLISHMENT OF A "COMBINED QUARANTINE FORCE"

November 9, 1962

Mr. Chairman:

We have the honor to address Your Excellency in order to refer to the resolutions adopted on October 23, 1962, and November 5, 1962, by the Council of the Organization of American States, acting provisionally as the Organ of Consultation. Among the measures of a technical nature which the various contributing governments may undertake in order to achieve a coordinated and effective action, in conformity with the Resolution of November 5, 1962, arrangements have been made among the Governments of Argentina, the Dominican Republic, and the United States of America under which naval units of these countries are participating in the quarantine operations around Cuba established pursuant to the resolution adopted by the Organ of Consultation on October 23, 1962. By agreement among the participating governments, a combined force has been established known as the "Combined Quarantine Force" under the operational command of Rear Admiral John A. Tyree, Jr., (USN), whose flag ship is currently the USS MULLINEX. Under this arrangement, officers of the participating navies act as members of the Staff of the Combined Quarantine Force, and the respective naval units are integrated in that force in order to carry out the operations mentioned above.
