Excellency:

I have the honour to refer to the resolution approved by the Council of the Organization of American States on 4 January 1961 in which it stated that it was feasible and desirable that the Member States extend their suspension of trade with the Dominican Republic to the export to that country of petroleum, petroleum products, trucks and spare parts. In the resolution the Council also requested the Member States to prevent the re-export of these items from their territory to the Dominican Republic, and to inform the Council regarding the measures they take with respect to the resolution.

Accordingly, I wish to inform Your Excellency that pursuant to the above-mentioned resolution, the United States Government has taken the necessary action, effective 20 January 1961, to suspend the export of the cited items from the United States to the Dominican Republic. The action taken includes, as well, the re-export of these items to the Dominican Republic.

Accept, Excellency, the renewed assurances of my highest consideration.
