DATE AND VENUE OF THE PLENARY SESSION

1. The 53rd Plenary Session will be held at the Palais des Nations, Geneva, from Monday 13 June until Wednesday 15 June 2005. The meeting will commence at 9:30 a.m. on Monday 13 June and will finish on Wednesday at 12:30 p.m. The meeting of the OECD Committee on Statistics will be held on 15-16 June 2005 in Geneva back-to-back with the CES, starting at 14:30 on 15 June.

ACCOMMODATION, PASSPORTS, VISAS AND TRAVEL ARRANGEMENTS

4. All participants attending the meeting are requested to have a valid passport and, if required, a visa for Switzerland. Applications for visas should be made to the embassy or consulate of Switzerland in the country in which the participants reside. Visa applications should refer to the 53rd plenary session of the Conference of European Statisticians to be held at the Palais des Nations in Geneva. If a formal invitation letter is required by the embassy, this can be requested from the UNECE secretariat (fax: +4122 917 0040; e-mail: josephine.rauss@unece.org).

5. Participants are requested to make their own hotel and travel arrangements. The ECE secretariat in Geneva is not in a position to provide such services to delegates. Participants are advised to book hotel accommodation well in advance of the meeting, since available rooms are limited because of other meetings taking place in Geneva during the month of June. Maps of Geneva, list of hotels and information for visitors to the Palais des Nations are available on the above-mentioned Conference's website (click on 'Geneva' at the left side of the page).

REGISTRATION

6. Participants are kindly requested to send the completed registration form, which is attached, to the UNECE secretariat <u>by 15 May</u> (fax no. +41 22 917 0040). The information will be used to register participants with the UN Security Section and to obtain ID badges from the Security offices located at Villa les Feuillantines on the first day of the meeting (please see map on the website: 'Geneva', 'Plan of the UN building'). Delegates should arrive at the UN Security offices at about 8:00 a.m. to allow time for security clearance and registration.

7. For identification and security reasons, participants are requested to wear their security badges at all times while inside the Palais des Nations. Please also note that, due to new security procedures in place in the Palais des Nations, we advise delegates not to bring large luggage (e.g. suitcases) to the Palais. Such luggage is not permitted into the building, and there is only limited storage space for it at the Pregny entrance.

OFFICIAL LANGUAGES AND DOCUMENTATION

8. The meeting room will be equipped for simultaneous interpretation, which will be provided into and from the three official working languages of the UNECE (English, French and Russian).

9. The main documents of the plenary session will be distributed in the three official languages. Some of the background documents and supporting papers may be available in the original language only.

10. The main papers for discussion at the two seminars will be prepared by invited authors. However, the CES member countries are invited to contribute supporting papers to the two seminars. These supporting papers will not be presented by their authors but will be made available on the UNECE website, and will be taken into account in the respective discussions.

11. The following deadlines apply for papers:

- <u>15 March for submitting the invited papers</u> for the two seminars;
- <u>29 April for submitting the supporting papers</u> for the two seminars and background documents that do not require translation.

12. The invited and supporting papers should not exceed 8 pages and should be sent to the UNECE secretariat electronically in Word format to Josephine Rauss (josephine.rauss@unece.org).

13. All documents will be available on the meeting website. <u>Delegates are kindly requested to</u> bring their copies of the documents with them, as there will be no documents available in the meeting room.
