A. INTRODUCTION

1. Membership

The Permanent Headquarters Committee was established as an ad hoc Committee upon which each member of the General Assembly had the right to be represented by Resolution No. 26 (I), adopted at the eighteenth plenary meeting, 26 January 1946.

2. Officers

The officers of the Permanent Headquarters Committee during the first session were: Temporary Chairman at the opening of the first meeting, 2 February 1946, Mr. Arthur David Kemp Owen (Secretariat); Chairman, Mr. Eduardo Zuleta Angel (Colombia), elected at the first meeting; Vice-Chairman, Mr. Leolyn Dana Wilgress (Canada), elected at the first meeting; and Rapporteur, Mr. Nasrollah Entezam (Iran), elected at the first meeting.

3. Secretaries

Mr. Huntington Gilchrist was Secretary to the Permanent Headquarters Committee during the London part of the session, and Mr. Glenn Edmund Bennett in New York.

4. Sub-Committees

Sub-Committee 1, to inspect and report on proposed sites, was appointed at the seventeenth meeting, 14 November 1946. It was composed of the Chairman (Colombia), the Vice-Chairman (Canada) and the Rapporteur (Iran) of the Committee, and the members for Australia, Belgium, Bolivia, China, Cuba, Egypt, France, Iraq, the Netherlands, Poland, the Union of Soviet Socialist Republics, the United Kingdom, the United States of America, Uruguay, and Yugoslavia. At the first meeting, 15 November 1946, the Chairman,

/Vice-Chairman

Vice-Chairman and Rapporteur of the Committee were elected to the corresponding offices in Sub-Committee 1. Mr. Entezam presented its report (A/SITE/Sub.1/3, and Add.1, Add.2) to the eighteenth meeting of the Committee, 4 December 1946. For the check list of the documents of the Sub-Committee, see Part B (2).

Sub-Committee 2, to inspect and report on the Manhattan East River site, was appointed at the twenty-fifth meeting, 11 December 1946. It was composed of the nine members of the Headquarters Commission (Australia, China, France, Iraq, the Netherlands, the Union of Soviet Socialist Republics, the United Kingdom, Uruguay, and Yugoslavia) and the representative of the United States of America, assisted by the Chairman (Colombia), Vice-Chairman (Canada), and the Rapporteur (Iran) of the Committee. At its first meeting, 11 December 1946, Sub-Committee 2 elected as its chairman the Chairman of the Committee. At its second meeting, 12 December 1946, the Sub-Committee appointed a Drafting Committee consisting of the members for France, the Union of Soviet Socialist Republics, the United Kingdom, and the United States of America, to prepare a report in co-operation with Mr. Howard K. Menhinick (Secretariat). The draft report was presented to the third meeting of the Sub-Committee, 12 December 1946. Mr. Entezam presented the Sub-Committee's report (A/SITE/Sub.2/1) to the twenty-sixth meeting of the Committee, 12 December 1946. 5. The Interim Committee

The Interim Committee for the Selection of a Site for the Permanent Headquarters of the United Nations was appointed by the Preparatory Commission of the United Nations with the adoption at its fourth plenary meeting, 23 December 1945, of the report of Committee 8 (PC/CD/9). The Interim Committee was composed of representatives of Australia, China, Cuba, France, Iran, Iraq, the Netherlands, Poland, the Union of Soviet Socialist Republics, the United Kingdom, Uruguay, and Yugoslavia. At its first meeting, 27 December 1945, the Interim Committee elected Mr. Roberto E. MacEachen (Uruguay) as Chairman and Mr. Stoyan Gavrilović (Yugoslavia) as Vice-Chairman.

/The Interim

The Interim Committee appointed an Inspection Group and a Juridical Sub-Committee. For the check list of documents of the Interim Committee and its sub-committees, see Part B (4).

The Inspection Group, to inspect and report on proposed sites in the United States of America, was appointed at the first meeting of the Interim Committee, 27 December 1945. It was composed of representatives of China, France, Iraq, the Union of Soviet Socialist Republics, the United Kingdom, Uruguay, and Yugoslavia. At its first meeting, 29 December 1945, the Inspection Group elected Mr. Stoyan Gavrilović (Yugoslavia) as Chairman and Mr. Shuhsi Hsu (China) as Vice-Chairman. Mr. Gavrilović presented its rep (A/SITE/2, and Add.1, Add.2, Add.3) to the fourth meeting of the Interim Committee, 5 February 1946, when he was appointed Rapporteur, and to the meeting of the Permanent Headquarters Committee, 6 February 1946.

The Juridical Sub-Committee was appointed by the Interim Committee at second meeting, 27 December 1945, and was composed of representatives of Australia, China, Cuba, Poland (designated Chairman), the United Kingdom, Yugoslavia. The Chairman was Mr. E. Sobolewski (Poland). Mr. William Eric Beckett (United Kingdom) was elected Acting Chairman at the ninth meeting, 25 January 1946. He also acted as Rapporteur to the Sub-Committee on Privileges and Immunities of the Sixth Committee of the United Nations, to which the reports of the Juridical Sub-Committee were referred by agreement with the Chairman of the Interim Committee. The rep consisted of suggested changes (PC/ICH/W.19) in the draft of the general convention on the privileges of the United Nations recommended by the Preparatory Commission (in PC/20, Chap. VII, Appendix B), and a revised draft convention (A/ICH/W.21/Rev.1) between the United Nations and the Government of the United States of America based upon documents PC/G/24 and PC/G/31 of the Preparatory Commission.

6. Other bodies reporting to the Permanent Headquarters Committee

The Headquarters Commission was established by Resolution No. 25 (I) adopted by the General Assembly at its thirty-third plenary meeting,

14 February 1946, upon the first report (A/58/Rev.1) of the Permanent Headquarters Committee. The Commission was composed of representatives of Australia, China, France, Iraq, the Netherlands, the United Kingdom, the Union of Soviet Socialist Republics, Uruguay, and Yugoslavia. At its first meeting, 7 May 1946, the Commission elected Sir Angus Somerville Fletcher (United Kingdom) as chairman. Sir Angus presented the report of the Commission (A/69) and a note (A/104) on the film illustrating the report to the fourteenth meeting of the Committee, 7 November 1946. See forthcoming document A/HQC/W.56 for the check list of Commission documents.

The Committee to assist the Secretary-General to negotiate with the competent authorities of the United States of America the arrangements required as a result of the establishment of the seat of the United Nations in the United States of America was established on the recommendation of the Sixth Committee, to which it reported. See document A/C.6/132, Part B (7) for the check list of the documents of the negotiating committee.

The Headquarters Advisory Committee was established by Resolution No. 100 (I), adopted by the General Assembly at its sixty-fifth plenary meeting, 14 December 1946, upon the second report of the Permanent Headquarters Committee (A/277). The Headquarters Advisory Committee is composed of representatives of Australia, Belgium, Colombia, France, Greece, India, Norway, Poland, Syria, the Union of Soviet Socialist Republics, the United Kingdom, the United States of America, and Yugoslavia. At its first meeting, 6 January 1947, the Committee elected Mr. Warren Robinson Austin (United States of America) as Chairman. Mr. Herschel V. Johnson (United States of America) has on occasion taken the chair in Mr. Austin's stead. Working papers of this committee (series A/AC.7/) are not included in this check list.
