REPORT OF THE ECONOMIC AND SOCIAL COUNCIL

Report of the Second Committee (Part I)*

Rapporteur: Mr. Martin WALTER (Czechoslovakia)

- 1. At its 3rd plenary meeting, on 23 September 1988, the General Assembly, on the recommendation of the General Committee, decided to include in its agenda the item entitled "Report of the Economic and Social Council" and to allocate to the Second Committee chapters of the Council's report 1/ that were considered under the relevant items of the agenda (see A/C.2/43/1).
- 2. In the context of item 1.2, the Second Committee considered the following questions referred by the Economic and Social Council to the General Assembly that did not fall within the purview of items specifically allocated to the Second Committee:
 - (a) Transport and Communications Decade in Africa;
 - (b) Indigenous entrepreneurs in economic development;
 - (c) Assistance to the Palestinian people;
 - (d) Guidelines for international decades;

 - (q) Inclusion of Mozambique in the list of the least developed countries;
- (h) Reactivation of economic growth and development in developing countries; 2/
 - (i) Fight against locust and grasshopper infestation in Africa; 3/
- (j) Implementation of section II of the annex to General Assembly resolution 32/197 on the restructuring of the economic and social sector of the United Nations system;
 - (k) United Nations Population Award.
- 3. The Committee held a general discussion on this item at its 10th to 15th meetings, on 11 to 14 October 1988. An account of the Committee's discussion is contained in the relevant summary records (A/C.2/43/2R.10-15).
