Appointment of members of the Joint Inspection Unit

Note by the President of the General Assembly

1. As indicated in paragraph 2 of the note by the Secretary-General (A/59/108), the General Assembly, by its decision 57/416 of 6 June 2003, appointed one member of the Joint Inspection Unit for a five-year term of office beginning on 1 January 2004 and expiring on 31 December 2008. The Secretary-General has been informed that that member, Christopher Thomas (Trinidad and Tobago), submitted his resignation on 25 June 2004. The General Assembly will accordingly be required, at the fifty-ninth session, to appoint a person to serve as a member of the Joint Inspection Unit for a period expiring on 31 December 2008.

2. In accordance with the procedures described in article 3, paragraph 1, of the statute of the Joint Inspection Unit (see A/59/108/Add.1), the President of the General Assembly, having consulted the regional group concerned, determined that Peru should be requested to propose a candidate to replace Mr. Thomas (see annex I).

3. The candidate, in accordance with General Assembly resolution 59/267 of 23 December 2004, should have experience in at least one of the fields as follows: oversight, audit, inspection, investigation, evaluation, finance, project evaluation, programme evaluation, human resources management, management, public administration, monitoring and/or programme performance, as well as knowledge of the United Nations system and its role in international relations (see resolution 59/267, para. 7).

4. The President of the General Assembly held further consultations as described in article 3, paragraph 2, of the statute of the Joint Inspection Unit, including consultations with the President of the Economic and Social Council and with the Secretary-General in his capacity as Chairman of the United Nations System Chief Executives Board for Coordination. The replies received from the President of the Economic and Social Council and from the Secretary-General to identical letters

addressed to them on 16 February 2005 by the President of the Assembly are attached (see annexes II and III).

5. Having completed the required consultations, the President of the General Assembly has the honour to submit to the Assembly the candidature of Juan Luis Larrabure (Peru) for appointment as a member of the Joint Inspection Unit for a period expiring on 31 December 2008.
