

- 5. Paragraph 10, line 2: Insert "Bahamas" between "Argentina" and "Barbados".

- 14. Footnote 12, last line: Replace "Fraenk" by "Fraenkl".
- 15. Footnote 13, first line: Replace "1 million" by "40%".
 - 16. Footnote 13, first line: Replace "possibly" by "perhaps".
 - 17. Footnote 13, line 3: Replace the word "This" by the following "(J. MacCarthy estimates 600,000 out of 1,500,000; Lepsius 1 million out of 1.8-2 midlion). The intent".
- 17a. Footnote 13, line 16: Underline "Deutschland und Armenian".
- 18. Footnote 13, last line: After "1982); "add the following: "J. MacCarthy, Muslims and Minorities (New York University Press, 1983); M. Vandemeulebroucke: Report for the European Parliament's Political Affairs Committee (1985); V. Dadrian: The Genocide of the Armenians in World War 1 and The Criminal Prosecution of Authors of Genocide by Recourse to Domestic Penal Codes (not yet published)."
- 19. Footnote 15, first line: Replace the first word "The" by "Some of the".

- 21. Footnote 15, last line: At the end of the footnote, add the following sentence: "This happened in a context of violence, and considerable efforts at reconciliation have since been made.".
- 22. Paragraph 22, line 29: Between "suggested." and "It could seem", insert the following: "Certainly the suffering of the Palestinians, and the successive massacres they have endured, should never be forgotten.".
- 23. Footnote 16: At the end of the footnote, add the following sentence: "This is denied by the Government of Paraguay.".

- 25. Paragraph 30. line 8: Delete "a" before "sexual".
- 26. Paragraph 30, line 8: Insert "and sexually orientated" between "sexual" and "groups".
- 27. Paragraph 35, first line: Replace "considerable" by "prolonged".
- 28. Paragraph 56, three last lines: Delete the following: Mamong those which have not yet ratified are Burundi, Equatorial Guinea, Paraguay, South Africa, Uganda and the United States of America".
- 28a. Paragraph 56, at end: After "Convention" insert "; too many have not".

- 29. Paragraph 57, line 2: Delete the words "Kampuchea and".
- 30. Paragraph 71, line 3: Replace the word "to" by "too".
- 31. Paragraph 73, line 10: Between "acquitted" and "When", insert the following: "The Turks also in 1919-20 held trials: not of 'war criminals' but of some of the Ottomans guilty of the Armenian genocide".
- 32. Footnote 64, line 10: Replace the word "did" by "might".
- 33. Paragraph 77, line 15: Between "parallels" and "It is important", insert the following sentence: "It is noteworthy and encouraging that the resolution appointing the new Special Rapporteur on Torture was adopted by the Commission on Human Rights without a single negative vote.".
- 33a. Paragraph 79, line 6: Replace "Experience" by "Experienced".
- 34. Paragraph 83, line 7: Between "such as" and "the Office", insert "the United Nations High Commissioner for Refugees".
- 35. Faragraph 85, line 5: Between "Government of Spain" and "A constructive", insert the following sentence: "One model could be a working group to be established by the United Nations Commission on Human Rights".
- 35a. Paragraph 86, line 1: replace "alia" by "alios".
- 36. Paragraph 92, second line: Insert "63" between "54" and "64".
