

Overview

- 19.1 The programme is under the responsibility of the Economic Commission for Europe (ECE). The activities for which the ECE is responsible fall within programme 16, Economic development in Europe, of the biennial programme plan and priorities of the period 2006-2007 (A/59/6/Rev.1), as adopted by the General Assembly in resolution 59/275 of 23 December 2004.
- 19.2 The programme is guided by the relevant resolutions of the General Assembly and the Economic and Social Council, as well as by the goals and commitments contained in the World Summit on Sustainable Development Plan of Implementation, the Monterrey Consensus and the United Nations Millennium Declaration. The overall objectives of the programme for the biennium 2006-2007 are: (a) to promote the economic integration of ECE countries in the context of post-European Union enlargement and taking into account the various stages of development of ECE transition economies (acceding countries, emerging market economies and less advanced transition economies); (b) to foster sustainable development in the countries of the region, with a focus on promoting the conditions for sustained growth and trade and improving the environment; and (c) to contribute to the economic and environmental dimensions of security in Europe.
- In order to fulfil these objectives, the overall ECE programme of work is structured around nine interdependent and complementary subprogrammes: environment, transport, statistics, economic analysis, sustainable energy, trade development, timber, human settlements and industrial restructuring and enterprise development. Its implementation is achieved through different types of interrelated and mutually supporting activities, namely: the negotiation and implementation of conventions, standards and guidelines; the organization of policy debates and exchange of experience in the key areas of ECE work; the development of policy analysis, studies and supporting statistics; and the provision of technical assistance. In implementing these activities, ECE will build upon its convening power and a membership that spans three continents, as it is the only regional organization which brings together North America, the European Union, the other non-European Union Western European countries, South-East Europe and Commonwealth of Independent States countries to dialogue and cooperate on economic and sectoral issues which correspond to ECE fields of expertise.
- 19.4 The ECE programme of work will not be fundamentally affected by the European Union enlargement. First, the normative work developed under many subprogrammes extends beyond the ECE region, that is, it has a global role (e.g. in the case of trade facilitation standards, standards on vehicle construction and transport of dangerous goods and principles for official statistics, etc.). Second, some components of normative work are not affected, as they apply to the ECE region as a whole, thus including North America and other ECE member countries not likely to join the European Union. Third, ECE develops legally binding instruments and "soft legislation" (e.g. policy guidelines) in areas which are not part of the Acquis Communautaire (e.g. human settlements and energy) and from which ECE members including European Union countries, benefit. Fourth, ECE offers a region-wide platform for promoting regulatory compatibility or approximation among the enlarged European Union and other ECE member States (e.g. in trade and investment promotion and energy reform). This is indispensable for economic cooperation in Europe and contributes to preventing the emergence of new dividing lines in Europe. Finally, it should also be noted that there are a number of areas where the key actors are non-European Union members who will always remain outside of the Union. This applies, for example, to the areas of timber, where the principal producer countries are Canada, the Russian Federation and the United States of America, and sustainable energy, where the Russian Federation and the United States of America are among the major players.

- 19.5 In operational terms, the issue of the European Union enlargement and its impact on the ECE programme of work is addressed within the existing mechanisms of consultations with the European Union and the European Commission. In addition, the European Union presidency and the European Commission participate regularly in the meetings of the Group of Experts on the Programme of Work, which oversees the ECE work programme as a whole.
- 19.6 With regard to technical cooperation activities, these are directly linked to the Commission's core activities, particularly in the normative field. Following the European Union enlargement in May 2004, the emphasis is on enhanced support to ECE member States that are most in need (Commonwealth of Independent States countries in particular Central Asia and the Caucasus and South-East Europe). In this context, attention will be paid to the further development and implementation of the Special Programme for the Economies of Central Asia, to be jointly undertaken by ECE and the Economic and Social Commission for Asia and the Pacific (ESCAP).
- 19.7 In the biennium 2006-2007, changes are introduced in a number of subprogrammes as follows: (a) subprogramme 1, Environment: ECE will undertake additional activities in response to increasing requests by the Commission on Sustainable Development for regional contributions to the follow-up to the World Summit on Sustainable Development. Furthermore, the Fifth Ministerial Conference on Environment for Europe agreed on a number of new actions that have been assigned to ECE for implementation; (b) subprogramme 2, Transport: a substantial amount of additional work is expected as a result of the development of the 1998 Global Agreement on global technical regulations for vehicle construction; (c) subprogramme 4, Economic analysis: the analytical work of ECE will be reoriented along the following lines: shortening of the analysis of macroeconomic developments; increasing focus on structural issues of relevance to transition economies, as well as on the regional perspectives with regard to the core United Nations themes. In addition, the *Economic Survey of Europe* will be reduced from two issues per year to one per year.
- 19.8 Following the adoption in 2003 of the Organization for Security and Cooperation in Europe (OSCE) New Strategy Document on economic and environmental dimensions of security in the region, a memorandum of understanding was signed by the Executive Secretary of ECE and the Secretary-General of OSCE on the occasion of the meeting of the OSCE Ministerial Council in December 2004. The memorandum outlines the roles and modalities of cooperation between the two organizations on regular reviews of the commitments by OSCE member States contained in the Strategy Document. ECE will therefore further integrate the security dimension in its relevant subprogrammes, namely, environment, energy, transport, trade development and economic analysis.
- 19.9 In order to maximize synergies, ensure coordination and avoid duplication, ECE will continue to cooperate actively with other international organizations present in the region. Coordination with other United Nations entities will be strengthened through existing mechanisms, in particular the Executive Committee for Economic and Social Affairs and the regional coordination meetings. This coordination will be pursued both with global level entities, in particular the Department of Economic and Social Affairs and the United Nations Conference on Trade and Development, and with the other regional commissions for promoting interregional cooperation. ECE will also seek to strengthen its cooperation with non-United Nations regional institutions and organizations, in particular the European Commission and the Organization for Economic Cooperation and Development (OECD).
- 19.10 ECE partnerships with the business community and non-governmental organizations will be maintained as a means to promote and support the implementation of ECE activities and projects, in particular those relating to strategies, norms and standards developed for the region, as well as other technical assistance activities.

- 19.11 The preparation of the proposed programme budget has undergone an intensive consultation process. The programme narratives were guided by the directions and priorities provided by the ECE principal subsidiary bodies, or their bureaux, and further reviewed by the Group of Experts on the Programme of Work, which subsequently made its recommendations on the programme budget. These recommendations were endorsed by the Commission in December 2004 and taken into account in finalizing the programme budget proposal.
- 19.12 At its annual session in February 2004, the Economic Commission for Europe decided to commission a comprehensive report on the state of ECE to determine what changes to the role, mandate and functions of ECE were necessary in the light of the changes in the European institutional architecture. The report is expected to be ready by July 2005 and its recommendations and possible actions thereon considered by the Commission during the second half of the year.
- 19.13 The expected accomplishments and indicators of achievement for ECE in the biennium 2006-2007 are detailed, together with required resources, under the programme of work, as well as under executive direction and management. The overall framework of these expected accomplishments and indicators of achievement is shown in table 19.1.

19.14 The issue of publications as part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as shown below in summary and as distributed in the output information for each subprogramme.

- 19.15 The overall resources required for the biennium 2006-2007 for this section amount to \$54,739,700, reflecting a net decrease of \$22,100 (or 0.04 per cent). The decrease in table 19.4 can be summarized as follows:
 - (a) Net decrease of \$21,100 under executive direction and management reflecting:
 - (i) The redeployment to subprogramme 4, Economic analysis, of the resources for travel of experts to the annual seminar held prior to the session of the Commission (\$36,900); and
 - (ii) Increased requirements for official travel of staff (\$15,800) in order to meet the growing demand on the office to participate in global, regional and subregional events, particularly in countries with economies in transition;
 - (b) Net decrease of \$185,500 under the programme of work as a result of:
 - (i) An increase of \$193,600 under subprogramme 1, Environment, reflecting the inward redeployment of one General Service (Other level) post from subprogramme 3, Statistics, in order to enable the subprogramme to continue to deliver its high-level and continually increasing programme of work;
 - (ii) A net increase of \$238,600 under subprogramme 2, Transport, comprising: a. an increase of \$261,000 under posts, reflecting the inward redeployment of one P-3 post from subprogramme 4, Economic analysis, in order to perform the necessary technical and administrative functions related to the development and updating of the Compendium of Candidate Global Technical Regulations and of the Registry of Global Technical Regulations foreseen in the 1998 Agreement; partly offset by b. a decrease of \$22,400 under external printing, due to the expected greater use of publication facilities of the United Nations Office at Geneva;
 - (iii) A net decrease of \$447,100 under subprogramme 3, Statistics, comprising: a. a decrease of \$456,200 under posts, reflecting the outward redeployment of one General Service (Other level) post to subprogramme 1, Environment; the outward redeployment of one P-2, Associate Information System Officer post to programme support; and the exchange of one P-4 from subprogramme 3 with one P-3 from subprogramme 9, following a review of the staffing structure and reorganization of the Statistical Division; partly offset by b. an increase of \$9,100 under official travel of staff in order to meet the increasing demand to participate in meetings and to better coordinate the statistical activities of international statistical institutes in the region and to intensify activities having impact on the Commonwealth of Independent States and South-East Europe;
 - (iv) A net decrease of \$224,100 under subprogramme 4, Economic analysis, comprising: a. a decrease of \$261,000 under posts, reflecting the outward redeployment of one P-3 post to subprogramme 2, Transport; partly offset by b. an increase of \$36,900 under ad hoc expert group meetings, reflecting the redeployment from executive direction and management of resources for travel of experts to the annual seminar held prior to the session of the Commission;
 - (v) An increase of \$4,500 under subprogramme 8, Human settlements, reflecting estimated expenditure requirements to meet the proposed programme of work under consultancy;
 - (vi) A net increase of \$49,000 under subprogramme 9, Industrial restructuring and enterprise development, comprising: a. an increase of \$53,500 under posts, reflecting the exchange of one P-3 from subprogramme 9 with one P-4 from subprogramme 3, reflecting the degree of complexity and increased level of responsibilities required to effectively carry out the functions relating to the information and communication technologies and

- knowledge-based economy in the ECE region; partly offset by b. a decrease of \$4,500 under consultancy;
- (c) Net increase of \$184,500 under programme support reflecting: a. an increase of \$209,100 as a result of the inward redeployment of one P-2, Associate Information System Officer post, from subprogramme 3, Statistics, in order to enable the Statistical Division to concentrate fully on its core functions and to allow the Information Service Unit to take full responsibility of the smooth running of the statistical databases of ECE, its administration and further developments; partly offset by b. a decrease of \$24,600 under non-post requirements, arising from decreased requirements for joint administrative activities, partly offset by increased requirements for official travel of staff due to the increased demand for consultation and participation at meetings of the Special Programme for the Economies of Central Asia and the Commonwealth of Independent States.
- 19.16 During the biennium 2006-2007, the projected extrabudgetary resources of \$13,467,000, or 19.7 per cent of the total resources available to this programme, will be utilized to supplement resources from the regular budget, primarily to finance the organization of workshops, seminars and symposiums for the countries in the region, particularly in countries with economies in transition; to support the implementation of the conventions on the environment adopted within the framework of ECE; to support cooperative agreements signed by various ECE member States on transport; and to share best practice and stimulate contacts in various other areas of the programme of work.
- 19.17 Pursuant to General Assembly resolution 58/269, resources identified for the conduct of monitoring and evaluation would amount to \$1,025,800 reflected under executive direction and management and under each subprogramme. Out of the total amount of \$1,025,800, an amount of \$6,500 is expected to be funded from extrabudgetary resources. Findings from the evaluations are used to readjust directions and methods of work, and for the preparation of the results statements in the programme performance report.
- 19.18 The percentage distribution of resources under this section would be as shown in table 19.3.

19.19 Unlike for other regional commissions, resources for administration and conference and general services for ECE are not included under its own programme budget. They are included in a consolidated fashion under section 28E, Administration, Geneva, in respect of administration and general services, and under section 2, General Assembly affairs and conference services, in respect

of conference-servicing costs. They are thus administered by the United Nations Office at Geneva in an integrated fashion.

19.20 In order to permit a comparison among regional commissions, while at the same time maintaining the advantages of integrated management and avoiding duplication of effort, the estimated resources (at current rates) to be provided by the United Nations Office at Geneva to ECE for administrative, conference and general services during the biennium 2006-2007 are summarized below:

A. Policymaking organs

- 19.21 The Commission, which reports to the Economic and Social Council, provides the work of the secretariat with overall direction. It meets annually for three working days, supplemented by ad hoc informal half-day sessions every three months. It has seven principal subsidiary bodies: the Committee on Environmental Policy (subprogramme 1, Environment); the Inland Transport Committee (subprogramme 2, Transport); the Conference of European Statisticians (subprogramme 3, Statistics); the Committee on Sustainable Energy (subprogramme 5, Sustainable energy); the Committee for Trade, Industry and Enterprise Development (subprogramme 6, Trade, industry and enterprise development and subprogramme 9, Industrial restructuring and enterprise development); the Timber Committee (subprogramme 7, Timber); and the Committee on Human Settlements (subprogramme 8, Human settlements). The principal subsidiary bodies meet two to three days annually to provide guidance to ECE on work relating to their respective sectors.
- 19.22 The Group of Experts on the Programme of Work meets every two years in the third quarter of the year prior to the preparation of the programme budget submission to provide the Commission with recommendations on possible adjustments and shifts in the ECE programme of work. In the course of the biennium, it also meets to take up specific issues as requested by the Commission and to review various aspects of the ECE work programme.
- 19.23 The Steering Group, established in 2001 and consisting of the ECE Bureau, chairpersons of all principal subsidiary bodies, the Executive Secretary and the ECE Directors, meets at least once a year during the annual session of the Commission. It provides views and advice on priorities and strategic directions of ECE work, especially on cross-sectoral and intersectoral issues.

B. Executive direction and management

Resource requirements (before recosting): \$4,403,700

19.24 In order to fulfil its responsibilities in terms of executive direction and overall management of ECE, the Office of the Executive Secretary has the following functions:

- (a) To feed the debate on the strategic directions of ECE and to develop a forward-looking strategy for adjusting ECE activities to respond to emerging and foreseeable needs and priorities of its member States;
- (b) To coordinate and prepare the ECE biennial programme plan and priorities and the programme budget; to ensure efficient and inclusive processes for the planning, monitoring and evaluation of the subprogrammes; to encourage the undertaking of self-evaluations and the use of evaluation findings;
- (c) To service meetings of the Commission and its Bureau, including preparation of relevant reports; to ensure an interface between the Bureau of the Commission and the Bureaux of the principal subsidiary bodies; and to ensure follow-up to decisions of the Commission; and to provide support to the Group of Experts on the Programme of Work and the Steering Group;
- (d) To ensure and report on the implementation of the resolutions and decisions of the General Assembly and the Economic and Social Council that are relevant to the work of ECE, including the regional follow-up to United Nations global conferences and events, in accordance with the ECE role as a regional outpost of the United Nations, pursuant to Economic and Social Council resolution 1998/46;
- (e) To cooperate and coordinate with other international organizations and United Nations departments, including within the economic commissions-economic and social affairs framework and the United Nations inter-agency coordination meetings;
- (f) To foster relationships with member Governments and keep abreast of the needs and priorities of ECE member States;
- (g) To foster gender mainstreaming in ECE subprogrammes;
- (h) To provide guidance and directions for the work of the secretariat; to increase transparency and interdivisional cooperation, to improve process for budget preparation and human resource management; to ensure compliance with the Performance Appraisal System (PAS); to issue guidelines and directives for the substantive divisions of the secretariat; to provide clearance for the ECE publications and key documents prepared for the principal subsidiary bodies of ECE.
- 19.25 The Office of the Executive Secretary includes an Information Unit which comprises one P-4 post and one General Service (Other level) post and, inter alia, works to increase the visibility of ECE, make ECE products more widely known and used, through the dissemination of information about the activities of ECE to the ECE membership and the public at large. Such dissemination is carried out through various channels, such as publications, the Internet and contact with the media.

External factors

19.26 The objectives and expected accomplishments of executive direction and management are expected to be achieved on the assumption that: (a) there are no major shortfalls in funding that might affect assistance provided, recruitment of staff and timely delivery of products and services; (b) there is active participation and support of ECE member States; and (c) there is willingness and ability of other organizations to cooperate.

Outputs

- 19.27 During the biennium, the following outputs will be delivered:
 - (a) Servicing of intergovernmental and expert bodies (regular budget):
 - (i) Economic Commission for Europe (ECE):

- a. Substantive servicing of meetings: ad hoc sessions of the Commission (8); annual session of the Commission (8); meetings of the Group of Experts on the Programme of Work (14); meetings relating to global conferences follow-up or to cross-sectoral issues (4);
- b. Parliamentary documentation: documents for meetings relating to global conferences or to cross-sectoral issues (2); documents for the ad hoc sessions of the Commission (4); documents for the annual sessions of the Commission (12); report of the annual session of the Commission (2);
- (b) Other substantive activities (regular budget):
 - (i) Recurrent publications: catalogue of ECE publications (4); Compendium of Legal Instruments, Norms and Standards (2); ECE report (2);
 - (ii) Non-recurrent publications: guide to the ECE (2); history of the ECE for the 60th anniversary (1);
 - (iii) Booklets, fact sheets, wallcharts, information kits: ECE Highlights; general information brochure;
 - (iv) Press releases, press conferences: briefings for the permanent missions; press conferences on ECE activities; press releases on ECE activities;
 - (v) Special events: special event for the 60th anniversary of ECE (1).


19.28 The amount of \$4,403,700, reflecting a decrease of \$21,100, is required for the continuation of the 13 existing posts and related non-post resources comprising of consultants and experts, travel of staff, contractual services and hospitality. The decrease of \$21,100 relates to the redeployment to subprogramme 4, Economic analysis, of resources for travel of experts, partly offset by increased requirements under other official travel of staff.

19.36 The amount of \$8,836,400, reflecting an increase of \$238,600 is required for 34 posts and related non-post resources comprising of consultants and experts, travel of staff and contractual services. The increase under posts reflects the inward redeployment of one P-3 post from subprogramme 4, Economic analysis, in order to perform the necessary technical and administrative functions related to the development and updating of the Compendium of Candidate Global Technical Regulations and of the Registry of Global Technical Regulations foreseen in the 1998 Agreement. The decrease in non-post resources is due to reduced requirements under external printing from the anticipated greater use of the publication facilities of the United Nations Office at Geneva.

19.40 The amount of \$8,029,400, reflecting a decrease of \$447,100, is required to cover 32 posts and related non-post resources comprising of consultants and experts, travel of staff and supplies and materials. The decrease in posts is due to: (a) the outward redeployment of one General Service (Other level) post to subprogramme 1, Environment; (b) the outward redeployment of one P-2, Associate Information System Officer post, to programme support; and (c) the exchange of one P-4 post from subprogramme 3 with one P-3 post from subprogramme 9, following a review of the staffing structure and reorganization of the Statistical Division. The subprogramme aims at providing an in-depth and comprehensive analysis of current economic developments and problems in the ECE region, focusing on macroeconomic and structural issues as well as on core United Nations development themes. It thus provides an international perspective for national economic policymakers through policy debates and publications. The activities in the field of population aims at supporting the implementation of the final documents of the regional and global conferences in this area through monitoring and exchange of experiences; they will also contribute to better informed policymaking through data collection and research activities, with a particular emphasis on issues concerning generations and gender.

19.64 The amount of \$1,792,900, reflecting an increase of \$49,000 is required for six posts and related non-post resources comprising of consultants and experts, travel of staff and supplies and materials. The increase in post requirements reflects the exchange of one P-3 post from subprogramme 9 with one P-4 post from subprogramme 3, owing to the degree of complexity and increased level of responsibilities required to carry out effectively the functions relating to the information and communication technologies and knowledge-based economy in ECE. The decrease in non-post resources reflects decreased requirements under consultancy, based on the actual expenditure trend.

D. Programme support

Resource requirements (before recosting): \$6,816,100

19.65 Programme support comprises the Executive Office, the Information Systems Unit and the Technical Cooperation Unit. Services provided under this heading relate to budget and finance, human resources management, general and technical services, conference services for ECE meetings and administration of publications programme, information technology services and coordination of functions for intersectoral and cross-sectoral activities.

Outputs

- 19.66 During the biennium 2004-2005, the following outputs will be delivered:
 - (a) Overall management: coordination of the administrative support, including human resources, financial and budgetary support and provision of guidance, supervision on the control, monitoring and reporting on the implementation of the programme budget;
 - (b) General and technical services:
 - (i) Determination of policy related to information technology strategies and acquisition plans; planning and coordination of informatics and telematic resources; collaborative work with service providers and supervision, monitoring and control of the outsourced information technology operations;
 - (ii) Project management and establishment of information technology resources, provision of information technology services (Internet/Intranet and groupware applications) to the divisions in support of the substantive programmes to improve cooperation with member States and other international organizations in the area of information, collection, dissemination and communication;
 - (iii) Acquisition of information technology equipment and other equipment and furniture, materials and supplies. Desktop configuration and installation, including security measures such as anti-virus. Provision of help-desk services to the whole of ECE. Installation of new infrastructure systems and services, such as an archiving and documentation infrastructure or a Web content management system;
 - (iv) Operation and coordination of the Integrated Management Information System (IMIS)-related functions within ECE;

(c) Conference services:

(i) Establishment and management of the ECE programme of meetings, related documentation, facilities and services required in close coordination with Conference Services at the United Nations Office at Geneva; arrangements for ECE meetings hosted outside Geneva by member Governments; and informal meetings held outside Geneva

- within the context of the ECE programme of workshops for countries with economies in transition;
- (ii) Preparation and organization of the annual session of ECE, its quarterly ad hoc informal meetings and required documentation and meetings services;
- (iii) Preparation and administration of the programme of publications;
- (d) Programme budget and accounts:
 - (i) Preparation of the biennial programme budgets and financial performance reports in liaison with the Office of Programme Planning, Budget and Accounts;
 - (ii) Financial control and certification of all accounts in cooperation with the Financial Resources Management Service at the United Nations Office at Geneva;
 - (iii) Administration of technical cooperation activities and extrabudgetary resources;
- (e) Human resources management:
 - (i) Administration of staff, including recruitment, placement and career development, in coordination with the Human Resources Management Service of the United Nations Office at Geneva and the Office of Human Resources Management at Headquarters;
 - (ii) Identification of staff training needs, including the provision of training to upgrade professional skills and in-house training in computer applications and arrangements for appropriate courses in cooperation with the Staff Development and Learning Service, at the United Nations Office at Geneva;
 - (iii) Staff management relations in the context of the ECE Sectoral Assembly and elected staff representatives;
- (f) Technical cooperation management:
 - (i) Provision of support for priority setting of technical cooperation, taking into account the needs and requests for technical assistance in transition economies, particularly South-East Europe, the Caucasus and Central Asia;
 - (ii) Coordination of and support to operational activities undertaken by ECE divisions, including by the regional advisers, based on the above priority-setting process;
 - (iii) Carrying out of regular consultations with subregional country groupings and initiatives in order to respond efficiently to the needs of countries with similar problems and concerns;
 - (iv) Supporting multisectoral technical assistance programmes in subregions and providing servicing and advice to their governing bodies such as the Special Programme for the Economies of Central Asia Regional Advisory Committee;
 - Monitoring of the implementation of technical cooperation activities undertaken within the cooperative agreements of the ECE and the subregional country groupings and initiatives;
 - (vi) Evaluation of technical assistance activities in a results-based perspective and ensuring the exchange of experiences among subprogrammes in this respect;

19.67 The amount of \$6,816,100, reflecting an increase of \$184,500, is required for 18 posts and related non-post resources comprising other staff costs, consultants and experts, travel of staff, contractual services, general operating expenses, supplies and materials, furniture and equipment and grants and contributions. The increase under posts reflects the inward redeployment of one P-2, Associate Information System Officer post, from subprogramme 3, Statistics, in order to enable the Statistical Division to concentrate on fully its core functions and to allow the Information Section Unit to take full responsibility of the smooth running of the statistical databases of ECE, its administration and further developments. The decrease under non-post resources relates mainly to: (a) decreased requirements for joint administrative activities, reflecting reduced costs for services provided by the International Computing Centre, partly offset by (b) increased requirements under official travel of staff, reflecting the increased demand for consultation and participation at meetings of the Special Programme for the Economies of Central Asia and the Commonwealth of Independent States and the high cost of travel to those regions.

V.4 The Committee also recommends that thought be given to devising other means of providing the information now being communicated through hard-copy publications, such as increasing use of the Internet and the United Nations-wide Intranet, as well as seminars and workshops

The number of publications planned for 2006-2007 that will be produced in hard copy only is 72 (or 44 per cent of the estimated total number of publications), as compared to an estimated total of 102 for 2004-2005. The remainder will be produced either in both print and electronic versions or in electronic versions only. Electronic versions are available either as CD-ROMS or through the Internet. In fact, the total number of publications to be produced in 2006-2007 has been reduced to 164, down from 192 estimated for 2004-2005.

Brief description of the recommendation

Action taken to implement the recommendation

V.5 The Advisory Committee does not find the measures adopted so far to be adequate and believes that the regional commissions should intensify their efforts to collaborate and interact among themselves and with other regional entities in order to share experiences, lessons learned and workload.

ECE cooperates with other regional commissions in various substantive areas, namely, information and communication technology, transport and trade facilitation, and with the Economic and Social Commission for Asia and the Pacific in the framework of the Special Programme for the Economies of Central Asia in the areas of water, energy and transport. In terms of coordination, each regional commission annually convenes a regional coordination meeting gathering the heads of the regional offices of United Nations entities and specialized agencies; at the global level, coordination takes place in the framework of the Executive Committee on Economic and Social Affairs which gathers the five regional commissions, UNCTAD, the Department of Economic and Social Affairs and other departments and entities working in the economic and social areas. In addition, for programme planning and related matters, the relevant chiefs meet annually to discuss pertinent issues, including results-based budgeting.

The Advisory Committee recalls that in paragraph 72 of General Assembly resolution 56/253, the Assembly noted with concern the high proportion of General Service posts compared to Professional posts in the regional commissions and requested the Secretary-General to report to it at its fifty-seventh session on efforts undertaken, as appropriate. The Committee notes the information contained in paragraph 66 of the Introduction to the proposed programme budget, and requests that information on such steps as may have been taken to address the request of the Assembly, including the elaboration of local prevailing conditions, be provided for each regional commission in the context of the next estimates.

The number of General Service regular budget posts in ECE was reduced by three at the time of the approval of the proposed programme budget for the biennium 2004-2005 (para. 26 of resolution 58/270 of 23 December 2003). As the number of General Service posts in ECE was not high in proportion to the Professional posts, the cuts impacted negatively in the delivery of some of its work programme, for example, some meetings had to be cancelled and/or postponed and the internal capacity for layout and cover design of publications was reduced.

Brief description of the recommendation

Action taken to implement the recommendation

V.55 The Advisory Committee recalls its recommendation in paragraph V.50 of its previous report (A/56/7) on the feasibility of setting up videoconferencing facilities for communication between the regional commissions and member States, or between different United Nations entities. Upon enquiry as to the response to its recommendation set out in table 20.29, the Committee was informed that a number of technical problems had been solved and that the matter would be pursued more actively. The Committee welcomes this information and requests ECE to report on the progress achieved in the context of the next budget submission.

The ECE used videoconferencing for meetings with the United Nations Headquarters, for recruitment interviews of candidates and for technical meetings, when feasible and adequate.

Office of Internal Oversight Services

Report of the Office of Internal Oversight Services on its audit of the regional commissions (A/58/785)

71. The Executive Secretaries of the regional commissions should undertake an overall reassessment of their intergovernmental machinery to streamline the processes and avoid duplication. Recommendations to revitalize and support those entities that could be useful and a change in the focus of others that have been inactive should be presented to the member States for their consideration. The Executive Secretaries should specifically review the overall coherence and effectiveness of their respective intergovernmental bodies, with particular emphasis on: (i) standardizing rules and procedures for the establishment of those bodies (including subsidiary bodies); (ii) regularly reviewing and monitoring participation by members of the regional commissions; (iii) clarifying mandates to avoid overlap among different bodies; (iv) revisiting mandates of non-functioning bodies; (v) aligning those bodies and the substantive divisions servicing them; and (vi) regularly reporting and following up on the recommendations made by intergovernmental bodies. The results of that review should be included in the report on regional cooperation in the economic, social and related fields. That

would allow for an integrated view of the impact

A comprehensive review of the state of ECE is ongoing by external evaluators engaged by the Commission. The review includes the functioning of the intergovernmental structure of ECE. The final report, expected in July 2005, will contain recommendations which the Commission will consider and decide upon at an ad hoc session.

Brief description of the recommendation

Action taken to implement the recommendation

of intergovernmental bodies in the various regions and facilitate the exchange of best practices among all the regional commissions (AN/2003/459/01/003).

- 75. The Executive Secretaries of the regional commissions should agree on a common policy with respect to self-evaluations so that: (i) evaluation approaches and procedures can be harmonized, especially with respect to the planning and selection of the entity to be evaluated, the scope of the evaluation, its methodology, conclusions, timing and costs; (ii) their cycle and depth are sufficient to cover all the programmes of work and their component parts periodically; and (iii) the recommendations arising out of those evaluations may be monitored and reported to the Executive Secretaries in order to achieve specific process improvements. In accordance with the guidance provided by OIOS on programme monitoring and reporting, self-evaluation findings should be incorporated into the regular reporting under the results-based budgeting framework (AN/2003/459/01/005).
- 77. In the area of fund-raising, there should be a focal point within each regional commission to: (i) follow up on all fund-raising meetings, contacts and activities; (ii) coordinate, prepare and follow up on the pledging conference; (iii) maintain a database of all projects in need of fund-raising; (iv) prepare a quarterly report on the progress of fund-raising activities for the Executive Secretaries, with circulation to all divisional heads; and (v) exchange best practices and lessons learned in fund-raising efforts (AN/2003/459/01/006).

This will require further consultations but effort is ongoing.


