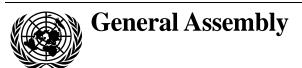

# **Overview**

- 15.1 The overall responsibility for the human settlements programme is vested in the United Nations Human Settlements Programme (UN-Habitat). The activities for which UN-Habitat is responsible fall within programme 12 of the biennial programme plan for the period 2006-2007.
- 15.2 The Programme is guided by the General Assembly and its subsidiary organs, which include the Governing Council and the Committee of Permanent Representatives to UN-Habitat. UN-Habitat, serving as the focal point for human settlements in the United Nations system, as mandated by the Assembly in its resolution 56/206 of 21 December 2001, provides support to its Governing Council in keeping the human settlements programme under appraisal; assists Member States in providing, through the Governing Council, the Economic and Social Council and the General Assembly, a coordinated mechanism for promoting and monitoring the implementation of the Habitat Agenda and the United Nations Millennium Declaration targets on slums, water and sanitation; assists the Secretary-General in enhancing the policy coherence and coordination of the human settlements programme; enhances cooperation and partnerships with local authorities, non-governmental organizations, the private sector and major groups in civil society in the implementation of the Habitat Agenda at the global, regional, national and local levels; provides advisory services at the request of Member States, focusing on enhancing in-country capacity to realize adequate shelter for all and sustainable human settlements development; and facilitates mobilization of financing of housing and basic infrastructure.
- 15.3 In keeping with the biennial programme plan for the period 2006-2007, the work of UN-Habitat during 2006-2007 will continue to be organized around four subprogrammes, which reflect the recommendations of the Second United Nations Conference on Human Settlements, held in Istanbul, Turkey, from 3 to 14 June 1996 (Habitat II) and the Habitat Agenda, the Millennium Declaration, the Declaration on Cities and Other Human Settlements in the New Millennium, as well as the relevant recommendations and commitments of the World Summit on Sustainable Development.
- 15.4 UN-Habitat will focus its resources and activities on the attainment of the Millennium Declaration targets as set forth in General Assembly resolution 55/2 of 8 September 2000. In particular, the Global Campaign for Secure Tenure and the Global Campaign on Urban Governance will continue to guide the efforts to implement relevant goals of the Millennium Declaration, that is, achieving a significant improvement in the lives of at least 100 million slum dwellers by the year 2020, as well as reducing by half the proportion of people without access to safe drinking water and sanitation by the year 2015.
- 15.5 As the proposals are in line with the biennial programme plan for the period 2006-2007, no significant programmatic changes are expected. However, youth is emerging as an important and cross-cutting stakeholder group in human settlements development and sustainable urbanization. It is increasingly being recognized that when given the right opportunities, young people can be effective agents of change. Accordingly, in the biennium 2006-2007, more effort will be placed on mainstreaming youth in the normative and operative programmes of UN-Habitat. A road map will also be developed for the promotion of urban youth empowerment and participation in the implementation of the Habitat Agenda and relevant Millennium Declaration targets. UN-Habitat will also put more emphasis on activities in the area of disaster preparedness and management and post-crises reconstruction, following its inclusion in the Executive Committee on Humanitarian Affairs, in recognition of its mandate as a link between emergency relief, stabilization and reconstruction. A special feature of the UN-Habitat strategy will be to highlight the role of women in the efforts to improve shelter conditions and urban governance.

- 15.6 UN-Habitat will serve as the focal point for the implementation of the programme within the United Nations system and will collaborate and cooperate with Governments and other United Nations organizations, including the Department of Economic and Social Affairs, the Office of the United Nations High Commissioner for Human Rights, the Economic Commission for Africa, the Economic Commission for Europe, the Economic Commission for Latin America and the Caribbean, the Economic and Social Commission for Asia and the Pacific, the Economic and Social Commission for Western Asia, the United Nations Development Programme (UNDP), the United Nations Office for Project Services, the United Nations Children's Fund, the United Nations Environment Programme (UNEP), the Office of the United Nations High Commissioner for Refugees, the United Nations Relief and Works Agency for Palestine Refugees in the Near East, the Food and Agriculture Organization of the United Nations, the World Health Organization, the World Bank, the United Nations Industrial Development Organization, the Global Environment Facility, the United Nations Office on Drugs and Crime, the United Nations Institute for Training and Research, the International Labour Organization (ILO) and the Joint United Nations Programme on HIV/AIDS. Outside the United Nations, UN-Habitat will also cooperate with Governments, local authorities, international financial institutions, regional development banks and other Habitat Agenda partners.
- UN-Habitat maintains liaison offices in New York, Geneva and Brussels whose main functions include coordination, harmonization and representation. In his report (A/59/395), submitted in compliance with General Assembly resolution 58/270 of 23 December 2003, by which the Assembly requested the Secretary-General to review the structure and functions of all liaison or representation offices in New York of organizations headquartered elsewhere, funded from the United Nations regular budget, the Secretary-General informed the Assembly that the New York office represents UN-Habitat in meetings of the General Assembly, the Economic and Social Council, relevant functional commissions, the Committee for Programme and Coordination, the Advisory Committee on Administrative and Budgetary Questions and other policymaking bodies. The office supports the substantive work of UN-Habitat and contributes to the strengthening of cooperation and coordination with the United Nations Secretariat, funds and programmes, and other agencies of the common system. In this regard, the office ensures representation at interagency meetings and participates in the meetings of the United Nations Development Group, the Executive Committee on Economic and Social Affairs and their support groups. In addition, the office maintains relations with the UN-Habitat partners in the North America region and carries out information activities at United Nations Headquarters and in the North America region. The staff of the office consists of one D-1, one P-4 and two GS (OL) posts financed from the regular budget and one P-3 post funded from extrabudgetary resources.
- 15.8 Pursuant to General Assembly resolutions 56/253 of 24 December 2001 and 57/292 of 20 December 2002, the United Nations Office at Nairobi is to be further strengthened, with a view to easing the administrative costs levied on the substantive programmes of UNEP and UN-Habitat. In this connection, proposals for further strengthening the regular budget component of the Office are included in section 28 G, Administration, Nairobi, of the proposed programme budget for the biennium 2006-2007. In its estimates for the biennium, UN-Habitat has taken into account those proposals to strengthen the United Nations Office at Nairobi.
- 15.9 The Programme's main expected accomplishments and indicators of achievement for the biennium 2006-2007 are detailed, together with required resources, under the programme of work, as well as under executive direction and management. The overall framework of these expected accomplishments and indicators of achievement is shown in table 15.1.

15.10 The issue of publications has been reviewed as part of the programme of work. It is anticipated that recurrent and non-recurrent publications will be issued as shown below in table 15.2 and as distributed in the output information for executive direction and management and for each subprogramme.

- 15.11 The overall resources required for the biennium 2006-2007 for this section amount to \$16,527,800 before recosting, reflecting an increase of \$515,000 (or 3.2 per cent). The proposed changes, reflected in table 15.4 below, are summarized as follows:
  - (a) The increase of \$138,400 under executive direction and management relates to \$135,500 for post and \$2,900 for non-post requirements. In particular, the increase relates to the establishment of one P-4 post, contractual services and general operating expenses, relating to the UN-Habitat share of centrally provided data processing infrastructure services and support costs for the New York office;
  - (b) A net increase of \$376,600 under programme of work, results from:
    - (i) A net decrease of \$154,500 under subprogramme 1, comprising \$135,500 for posts arising from full funding of one P-4 post approved in the biennium 2004-2005 and the outward redeployment of one P-4 post to subprogramme 2; and a decrease of \$19,000 under general operating expenses;
    - (ii) An increase of \$531,100 under subprogramme 2 for the full funding of one P-5 post established in the biennium 2004-2005; establishment of one new P-3 post for a human settlements officer and the inward redeployment of one P-4 post from subprogramme 1.
- 15.12 During the biennium 2006-2007, expected extrabudgetary resources amounting to \$149,807,500, or 89.3 per cent of the total resources available to the programme, will supplement resources from the United Nations regular budget, estimated at 10.7 per cent. The extrabudgetary resources are used to finance technical cooperation activities, which are a central feature of the programme. The existing arrangements for intergovernmental review and management of these extrabudgetary

- funds provide for the Governing Council of the United Nations Human Settlements Programme to approve biennial budgets to govern the use of such extrabudgetary resources.
- 15.13 The monitoring and evaluation functions of UN-Habitat are managed and coordinated by the Monitoring and Evaluation Unit. The Unit, which is organizationally placed under executive direction and management, is tasked with the responsibility of improving monitoring and evaluation systems and coordinating monitoring and evaluation activities of UN-Habitat towards planned objectives, realizing the expected accomplishments and improving the organizational accountability of UN-Habitat. It is estimated that for the biennium 2006-2007, resources amounting to \$1,458,000, consisting of \$352,100 under the regular budget and \$1,105,900 under extrabudgetary resources, will be required to carry out the activities planned.
- 15.14 The estimated percentage distribution of the total resources under this section for the biennium 2006-2007 is as shown in table 15.3 below.

# A. Policymaking organs

### Resource requirements (before recosting): \$26,000

- 15.15 In its resolution 56/206, the General Assembly transformed the Commission on Human Settlements into the Governing Council of UN-Habitat, a subsidiary body of the Assembly, with effect from 1 January 2002. The Governing Council reports to the Assembly through the Economic and Social Council and provides overall policy guidance, direction and supervision to UN-Habitat. The Committee of Permanent Representatives to UN-Habitat was also transformed into an intersessional subsidiary body of the Governing Council. The objectives, functions and responsibilities of the Governing Council are set out in Assembly resolution 32/162 of 19 December 1977 and in paragraph 222 of the Habitat Agenda, which was adopted at Habitat II.
- 15.16 The Governing Council is composed of 58 Member States, which have a membership term of four years. It holds its regular sessions biennially at the headquarters of UN-Habitat in Nairobi. During these sessions, the Governing Council reviews the biennial programme of work of UN-Habitat, the budget of the United Nations Habitat and Human Settlements Foundation as well as the operational activities that are carried out by UN-Habitat. The sessions bring together representatives of Member States as well as Habitat Agenda Partners, which comprise local authorities, non-governmental organizations, the private sector, the Global Parliamentarians on Habitat, women's groups, Youth for Habitat, trade unions, professionals and researchers, foundations and academies of science. The Committee of Permanent Representatives normally meets eight times during a biennium, while its three working groups each meet once a month, making a total of approximately 70 meetings. The Governing Council, its intersessional subsidiary body, the Committee of Permanent Representatives and its three working groups are serviced by the secretariat of the Governing Council, External Relations and Inter-agency Affairs Section of UN-Habitat.

15.17 The provision of \$26,000 covers overtime requirements for substantive servicing of the meetings of the Governing Council of UN-Habitat (\$20,400) and hospitality requirements during its biennial sessions (\$5,600).

# B. Executive direction and management

### Resource requirements (before recosting): \$3,189,700

15.18 Executive direction and management is under the responsibility of the Executive Director, whose office includes the Monitoring and Evaluation Unit and the UN-Habitat liaison offices in New

York, Geneva and Brussels. The Executive Director provides overall direction and coordination in the management of the implementation of the organization's work programme and its relations with Member States, United Nations offices, programmes, funds, agencies and other UN-Habitat partners in coordinating the system-wide implementation of the Habitat Agenda and the Millennium Declaration targets. The Monitoring and Evaluation Unit is responsible for monitoring the implementation of the work programme and evaluating the activities of the programme. The Office also provides information, press, media outreach to the international community and all Habitat Agenda Partners, plans and executes major global, regional and national media events and has responsibility for the coordination of fund-raising activities. The functions of the liaison offices include participating in the work of the General Assembly, the Economic and Social Council and meetings of other intergovernmental bodies, interdepartmental and inter-agency meetings and providing substantive support in meetings and policy advice on human settlements as well as carrying out outreach activities.


- 15.20 The amount of \$2,747,000 for posts, including an increase of \$135,500, would provide for the 13 posts reflected in table 15.8. The increase relates to the establishment of one P-4 Programme and Management Oversight Officer post.
- 15.21 The amount of \$442,700 for non-post resources, including an increase of \$2,900, would provide for: other staff costs (\$201,900); travel of staff (\$82,600); contractual services (\$9,300); general operating expenses (\$99,300); and furniture and equipment and supplies and materials (\$49,600). The increase relates primarily to the New York liaison office of UN-Habitat, namely its share of centrally provided data-processing infrastructure services costs, including those of storage area networks, application servers, departmental servers, backup units and desktop connectivity.

# Subprogramme 1 Shelter and sustainable human settlements development

# Resource requirements (before recosting): \$5,968,400

- 15.22 The Shelter and Sustainable Human Settlements Development Division will be responsible for the implementation of subprogramme 1. The programme of work has been formulated on the basis of subprogramme 1 of programme 12 of the biennial programme plan for the period 2006-2007.
- 15.23 The subprogramme will carry out both advocacy and normative activities through the two global campaigns, for secure tenure and on urban governance; however, efforts will be focused mainly on global advocacy on the two global campaigns as well as on the Millennium Declaration targets on slums, water and sanitation. The Global Campaign for Secure Tenure will maintain its strategy of promoting secure tenure for all, partnership with the urban poor as well as inclusive and sustainable human settlements policies. In particular, the campaign will promote the rights of women as essential to successful shelter policies. The Global Campaign on Urban Governance will continue to promote accountable and transparent urban governance that responds and benefits all sectors of society, particularly the urban poor. A special feature of the strategy will be to focus on the role of women as active participants and beneficiaries in the efforts to improve shelter conditions and urban governance.

15.26 The requirements of \$5,482,100 for posts reflect a decrease of \$135,500. The net decrease is the result of: (a) full funding for one P-4 post newly established in the biennium 2004-2005; and (b) the outward redeployment of one P-4 post to subprogramme 2, to strengthen the Policy Analysis, Synthesis and Dialogue Branch, which has the responsibility of preparing UN-Habitat flagship reports. The amount of \$486,300 for non-post resources, reflecting a decrease of \$19,000, would provide for: consultants and experts (\$117,800); travel of staff (\$97,300); contractual services (\$33,200); general operating expenses (\$153,200), against which the decrease of \$19,000 is applied; furniture and equipment and supplies and materials (\$84,800).

# Subprogramme 2 Monitoring the Habitat Agenda

### Resource requirements (before recosting): \$5,752,500

- 15.27 The responsibility for implementing this subprogramme lies with the Monitoring and Research Division. The programme of work has been formulated on the basis of subprogramme 2 of programme 12 of the biennial programme plan for the period 2006-2007.
- 15.28 In implementing the programme of work, the subprogramme will continue to monitor progress made in the implementation of the Habitat Agenda and the Millennium Declaration targets on slums, water and sanitation. This will be done by collecting, analysing and disseminating global data and information on human settlements and urbanization as well as collating and disseminating knowledge on urban economies. The subprogramme will also identify best practices, test and mainstream gender and partners in human settlements programmes and projects. Following an increasing recognition of the role of youth as an important partner in human settlements development, UN-Habitat will mainstream youth in its normative and operational activities.

15.31 The amount of \$5,301,500 for post requirements reflects an increase of \$531,100 resulting from: (a) full funding for one P-5 post established in the biennium 2004-2005; (b) establishment of one new P-3 post for a Human Settlements Officer; and (c) inward redeployment of one P-4 post from subprogramme 1. # **Subprogramme 3 Regional and technical cooperation**

# Resource requirements (before recosting): \$1,316,800

15.32 The Regional and Technical Cooperation Division will implement this subprogramme. The programme of work has been formulated on the basis of subprogramme 3 of programme 12 of the biennial programme plan for the period 2006-2007. The Division will focus its efforts on the normative functions that include setting standards, proposing norms and principles as well as operational activities comprising policy formulation, capacity-building and demonstration projects. UN-Habitat programme managers posted in 45 countries will promote mainstreaming of urban issues in United Nations development assistance frameworks and poverty reduction strategy programmes and promote global programmes and campaigns. Women are expected to be active participants and beneficiaries of the programmes and projects implemented under this subprogramme, including those aimed at mainstreaming gender issues and policies.

15.35 An amount of \$1,211,600 for post resources, at the maintenance level, would provide for the five posts reflected in table 15.15. The amount of \$105,200 in non-post resources, at the maintenance level, would provide for: consultants and experts (\$20,000); travel of staff (\$22,900); contractual services (\$6,400); general operating expenses (\$38,300); supplies and materials (\$4,800), and furniture and equipment (\$12,800).

# Subprogramme 4 Human settlements financing

### Resource requirements (before recosting): \$274,400

- 15.36 The United Nations Habitat and Human Settlements Foundation (the Foundation) was established by the General Assembly in its resolution 3327 (XXIX) of 16 December 1974 as an international facility to assist in strengthening national human settlements programmes, particularly in developing countries. In its resolution 56/206, the Assembly called upon the Executive Director of UN-Habitat to strengthen the Foundation in order to achieve its primary operative objective, as set out in resolution 3327 (XXIX), of supporting the implementation of the Habitat Agenda, including supporting shelter, related infrastructure development programmes and housing finance institutions and mechanisms, particularly in developing countries. In its resolution 56/206, the Assembly also called upon the Executive Director to continue fund-raising appeals and initiatives for a substantial increase of the Foundation's resources.
- 15.37 The Foundation is managed by the Deputy Executive Director in his or her capacity as Deputy Administrator, assisted by a Director of Technical and Financial Services. Responsibility for this subprogramme rests with the United Nations Habitat and Human Settlements Foundation, anchored in the Human Settlements Financing Division. The programme of work has been formulated on the basis of subprogramme 4 of programme 12 of the biennial programme plan for the period 2006-2007.
- 15.38 The main focus of the work programme will be on strengthening the Foundation, providing support for the mobilization of seed finance, working with partners and providing technical assistance. Particular emphasis will be placed on mobilizing finance from international sources for leveraging domestic investment for slum upgrading and other pro-poor human settlements. UN-Habitat will continue to position itself as a broker between Governments at all levels and international finance institutions to promote the development of affordable housing and infrastructure.

#### **External factors**

15.39 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) there is an increase in the level of financial commitment and support received from international and regional development banks, bilateral development cooperation agencies and international donor facilities to strengthen the Habitat Foundation; (b) there is support among Member States and domestic financial institutions at the country level to develop financial

mechanisms for mobilizing domestic capital for slum upgrading; and (c) international financial institutions and UN-Habitat provide the political will to overcome institutional barriers and identify modalities for effective partnership.

### **Outputs**

- 15.40 During the biennium, the following outputs will be delivered:

15.41 The amount of \$257,600 for post resources provides for one P-4 post. The amount of \$16,800 for non-post resources, at the maintenance level, would provide for: travel of staff (\$7,900); general operating expenses (\$6,200); supplies and materials (\$1,000) and office furniture and equipment (\$1,700).

15.42 The implementation of the programme of work will be supported through a number of services, including human resources planning, financial management and programme planning and coordination. Programme support services are provided by the Programme Support Division, programme management officers in the regional offices of UN-Habitat and the Division of Administrative Services of the United Nations Office at Nairobi.


# **Advisory Committee on Administrative and Budgetary Questions** (A/58/7 (para. IV.66))

In view of the introduction of results-based budgeting and the stress on accountability, the Committee is of the opinion that it may be necessary in future to review the results-based budgeting presentation of budget sections where there is a relatively small regular budget component of a programme that is largely funded from extrabudgetary resources, such as those on environment, human settlements, human rights, Palestine refugees and international drug control.

The format of the UN-Habitat proposed programme budget for the biennium 2006-2007 reflects the UN-Habitat plans, programmes, objectives and expected accomplishments of the entire programme in a more concise format and in accordance with the biennial programme plan for the period 2006-2007. The Advisory Committee on Administrative and Budgetary Questions, in its report on the proposed work programme and budget of the United Nations Human Settlements Foundation for the biennium 2006-2007 (HSP/GC/20/9/Rev.1/Add.1), welcomed the improved presentation, which, inter alia, combines the work programme and budget submission for 2006-2007 in a results-based budget format, as recommended by the Advisory Committee.
