HUMAN RIGHTS COMMITTEE Eighty-third session New York, 14 March-1 April 2005

PROVISIONAL AGENDA AND ANNOTATIONS

Note by the Secretary-General

- 1. The eighty-third session of the Human Rights Committee will be held at United Nations Headquarters from 14 March to 1 April 2005. The first meeting will be convened Monday, 14 March 2005 at 10 a.m.
- 2. In accordance with rule 6 of the Committee's rules of procedure, the Secretary-General has prepared, in consultation with the Chairperson of the Committee, the attached provisional agenda for the eighty-third session. Annotations to the provisional agenda are also attached.
- 3. Pursuant to rule 33 of the Committee's rules of procedure, the meetings of the Committee will be held in public unless the Committee decides otherwise or it appears from the relevant provisions of the Covenant or the Optional Protocol that the meetings should be held in private.
- 4. The attention of States parties is drawn, in particular, to the annotations to item 8, which contains the tentative timetable for the consideration of reports during the eighty-third session. In accordance with rule 68 of the Committee's rules of procedure, representatives of States parties are expected to be present at the meetings of the Committee when their reports are examined.
- 5. As established under rule 95 of its rules of procedure, a working group should meet for a period of one week prior to its eighty-third session. The pre-sessional working group will meet from 7 to 11 March 2005.

ANNOTATIONS

1. Opening of the session by the representative of the Secretary-General

The Representative of the Secretary-General will open the eighty-third session of the Committee.

2. Solemn declaration by newly elected members of the Committee in accordance with article 38 of the Covenant

In accordance with article 38 of the Covenant and rule 16 of the rules of procedure, the eight members of the Committee elected or re-elected at the Twenty-Third Meeting of States Parties to the Covenant on 9 September 2004 and the new member elected at the Twenty-Fourth Meeting of States Parties to the Covenant on 8 February 2005 will make the following solemn declaration:

"I solemnly undertake to discharge my duties as a member of the Human Rights Committee impartially and conscientiously."

3. Election of Chairperson and other officers of the Committee

In accordance with article 39, paragraph 1, of the Covenant and rule 17 of the rules of procedure, the Committee shall elect from among its members a Chairperson, three Vice-Chairpersons and a Rapporteur. The officers of the Committee shall be elected for a term of two years (rule 18 of the rules of procedure). Under rule 58 of the rules of procedure, elections shall be held by secret ballot, unless the Committee decides otherwise in the case of an election to fill a place for which there is only one candidate.

4. Adoption of the agenda

Under rule 8 of the Committee's rules of procedure, the first item on the agenda for any session shall be the adoption of the agenda. In accordance with rule 9, the Committee may revise the agenda during a session and may, as appropriate, defer or delete items.

5. Organizational and other matters

Under this item, the Committee will consider miscellaneous issues relevant to the Committee's business.

6. Meeting with representatives of non-governmental and intergovernmental organizations

At its eighty-second session, the Committee decided to hear representatives of non-governmental and intergovernmental organizations represented at United Nations Headquarters. The meeting has accordingly been scheduled for the morning meeting on Monday, 14 March 2005, from 11.30 a.m. to 1.00 p.m. (subject to the completion of items 1-5 by 11.30 a.m.).

7. Submission of reports by States parties under article 40 of the Covenant

A. Reports received

Apart from the reports which are scheduled for consideration by the Committee at its eighty-third session (see the timetable for consideration of reports under item 8 below), the Secretary-General has received the initial report of Honduras, the second periodic reports of Brazil, the Hong Kong Special Administrative Region (China) and Paraguay; and the fifth periodic reports of Canada and Norway.

B. Reports due

For the situation with regard to the submission of reports by States parties under article 40 of the Covenant, reference is made to chapter III and annex IV of the Committee's annual report to the General Assembly for 2004 (see A/59/40, vol. I).

8. Consideration of reports submitted by States parties under article 40 of the Covenant and of country situations

A tentative timetable for the consideration of reports and country situations at the eighty-third session, prepared in consultation with the Committee, is given below:

In accordance with rule 68 of the Committee's rules of procedure, the Secretary-General has informed the States parties concerned of the dates on which their respective reports are scheduled for consideration by the Committee at its eighty-third session.

The reports to be considered during the eighty-third session are those of Greece, Iceland, Kenya, Mauritius and Uzbekistan.

Country report task forces will examine and adopt a list of issues on the reports of Italy, Slovenia, the Syrian Arab Republic, Tajikistan, Thailand and Yemen.

9. Follow-up to concluding observations and to Views under the Optional Protocol

At its seventy-fourth session, the Committee adopted decisions governing the procedure for following up on concluding observations. During the seventy-fifth session, a Special Rapporteur for follow-up on concluding observations was appointed; he will provide a progress report on his activities during the eighty-third session. The Special Rapporteur for follow-up on Views will equally provide a progress report on his activities.

10. General comments of the Committee

Under this item, the Committee will begin consideration of a draft revised general comment on article 14 (right to a fair trial).

11. Consideration of communications under the Optional Protocol to the Covenant

In accordance with the provisions of chapter XVII of the rules of procedure, the Committee will consider under this item communications which are or appear to be submitted to it under the Optional Protocol.

A total of 311 communications are pending before the Committee as of 24 January 2005. Pursuant to the Committee's new rules of procedure allowing the joint examination of admissibility and merits in most cases, the Committee's examination of these communications may result in the adoption of Views, or in decisions declaring the communications admissible or inadmissible.

In accordance with article 5, paragraph 3, of the Optional Protocol and rule 88 of the Committee's rules of procedure, this agenda item will be considered in closed meetings.
