**SUMMARY OF TRADE FACILITATION RECOMMENDATIONS**

Note by the secretariat

This document is **for information**.

It summarizes the trade facilitation recommendations developed and maintained by the United Nations Centre for Trade Facilitation and Electronic Business (UN/CEFACT). Based on best business practice worldwide, these recommendations, many of which become international standards of the International Organization for Standardization, facilitate the interchange of trade documents and information and the establishment of simplified and harmonised procedures.

The document should provide trade policy makers, trade facilitation practitioners, traders and business with a solid foundation for successful trade facilitation implementation.

## Introduction

1. This paper presents a summary of the recommendations and standards developed over the past 40 years by the United Nations Centre for Trade Facilitation and Electronic Business (UN/CEFACT). The recommendations, many of which become international standards of the International Organization for Standardization (ISO), reflect best practices in trade procedures and related data and documentary requirements. They benefit government administrations, traders and providers of trade-related services.

2. UN/CEFACT recommendations have been implemented worldwide to simplify and harmonise international trade procedures and information flows. For example, the UN Layout Key for Trade Documents (Recommendation 1) is the international standard for international trade documents. It is the basis for many of today's key trade documents such as the Single Administrative Document used within the European Union, the Freight Forwarding Instruction of the International Federation of Freight Forwarders' Associations (FIATA), the Dangerous Goods Declaration of UNECE, the Goods Declaration for Export (revised Kyoto Convention) of the World Customs Organization (WCO), and many others. Furthermore, the UN/EDIFACT Standard (Recommendation 25) is the only accepted international standard for Electronic Data Interchange and is used throughout the commercial and administrative world. The UN/EDIFACT Standard is complemented by a series of UN/CEFACT recommendations on codes used in international trade. These include the UN Code for Trade and Transport Locations (Recommendation 16), Codes for Modes of Transport (Recommendation 19) and Code for Representation of Names of Countries (Recommendation 3).

3. UN/CEFACT recommendations also cover practical aspects of trade facilitation implementation. For example, Recommendation 4 on National Trade Facilitation Organs details the suggested approach to establishing a consultative mechanism between trade and government for the implementation of trade facilitation measures and instruments. In addition, Recommendation 18 on Facilitation Measures related to International Trade Procedures puts forward a series of measures for consideration by Governments and business in pursuing better trade facilitation.

4. More recently, UN/CEFACT has developed a new Recommendation and Guidelines on Establishing a Single Window to Enhance the Efficient Exchange of Information between Trade and Government (Recommendation 33). Often with relatively modest investment costs, such facilities are one of the new approaches to trade facilitation implementation that can bring enormous benefits to both trade and Governments.

5. The summary information on each UN/CEFACT recommendation provided in this publication includes:

- Brief description
- Equivalent ISO standard number (where appropriate)
- Current status, indicating whether the recommendation is under development, approved or currently under revision
- Dates and publication numbers of documents containing the first approved and last revised versions of the recommendation
- Website containing the English version, or any other relevant website
- Indication and publication numbers of the French and Russian editions

7. It is recognized that the approach to the implementation of these recommendations will vary depending on the unique conditions, needs and priorities as well as resources in individual countries and regions. However, irrespective of how they are implemented, UNECE believes that international standards such as those developed by UN/CEFACT create a solid foundation for successful trade facilitation implementation. Based on best business practice worldwide, these standards facilitate the interchange of trade documents and information and the establishment of simplified and harmonised procedures. They also provide the implementer with stability, scalability and interoperability for the longer-term development of international trade.

8. We encourage all countries to seriously consider these standards and recommendations when adopting trade facilitation measures. We also encourage the active participation of all countries in the work of UN/CEFACT in developing such recommendations.

If information is electronic, then individual data elements should only be submitted once. In addition, participating authorities and agencies should co-ordinate their controls through the Single Window. It may provide facilities for payment of relevant duties, taxes and fees. In practical terms, the Single Window aims to expedite and simplify information flows between trade and government and bring meaningful gains to all parties involved in cross-border trade. The Single Window is generally managed centrally by a lead agency, usually Customs, enabling the appropriate governmental authorities to have access to the relevant information.
