**FINANCIAL AND BUDGETARY MATTERS OF EMEP**Note by the secretariat**Introduction**

1. This note presents the status of contributions by Parties to the EMEP Protocol. It reports on the use of resources in 2004 and sets out the proposed budget for EMEP for the year 2006. The note also proposes the adoption of a revised scale of contributions as an amendment to the annex to the EMEP Protocol and presents the calculated schedule of mandatory contributions for 2006.

**I. STATUS OF THE TRUST FUND, CONTRIBUTIONS IN KIND  
AND VOLUNTARY CONTRIBUTIONS**

2. The contributions paid by the Parties to the Convention for the long-term financing of EMEP as of 18 May 2005 are summarized in table 1 below. They include both the mandatory contributions from the Parties to the EMEP Protocol within the geographic scope of EMEP and the voluntary contributions from Canada and the United States, as Parties outside the geographic scope of EMEP. On 18 May 2005, the Protocol on the Long-term Financing of the Cooperative Programme for Monitoring and Evaluation of Long-range Transmission of Air Pollutants in Europe (EMEP) had 41 Parties.

Documents prepared under the auspices or at the request of the Executive Body for the Convention on Long-range Transboundary Air Pollution for GENERAL circulation should be considered provisional unless APPROVED by the Executive Body.

3. Table 1 also includes the mandatory contributions in kind. In 2004 only Belarus contributed in kind to the work of the Task Force on Emission Inventories and Projections. All other Parties have agreed to pay their contributions in cash. A voluntary contribution of US\$ 5,000 in cash was made by the United States.
4. In addition to the contributions summarized in table 1, voluntary extrabudgetary contributions directly to the centres have been allocated over several years. In the period 1994-2003, the Meteorological Synthesizing Centre-West (MSC-W) received in total the equivalent of US\$ 8,337,275 from Norway, the United Kingdom, or through projects financed by the Nordic Council of Ministers and the European Community. In 2004, MSC-W received extrabudgetary contributions (either directly from its host institution, the Norwegian Meteorological Institute, or through projects financed by the Nordic Council of Ministers and the European Community) that totalled US\$ 1,947,993. In 2001 and 2002, MSC-W received a contribution in kind from the United Kingdom. Between 1994 and 2003, the Chemical Coordinating Centre (CCC) received in total the equivalent of US\$ 1,316,474 from its host institution, the Norwegian Institute for Air Research (NILU). In 2004, CCC received from NILU the equivalent of US\$ 208,000. In 2001, MSC-E received US\$ 30,000 from the World Meteorological Organization. It also received US\$ 120,000 from the Arctic Monitoring and Assessment Programme (AMAP) in the period 2001-2002, and US\$ 4,400 from the UNECE Working Group on Environmental Monitoring in 2003. In 2004, MSC-E received US\$ 13,830 from the European Commission.
5. According to the payment records of the secretariat, by 18 May 2005 the total arrears in cash and in kind from 1991 to 2004 stood at US\$ 370,986, of which US\$ 54,792 were outstanding payments in cash. For Greece, Portugal, and Romania payments are outstanding for 2004. Italy has arrears for 2003 and 2004, although it paid part of its contribution in 2005. Greece also made a payment in 2005, which was not sufficient to cover its arrears and its contribution for 2005.
6. Ukraine is still in arrears for 1992, 1993, 1994, 1996, 1997, 1998, 1999, 2000, 2001, 2002, 2003 and 2004. Ukraine's arrears from 1992 to 2001 relate to contributions in kind worth US\$ 316,194. A project on the development of a national model for environmental impact assessment of heavy metal emissions had been initiated by Ukraine in order to cover its arrears to EMEP for 1992-1994, equivalent to US\$ 140,989. In a letter dated 15 April 2004, Ukraine informed the secretariat about progress in the development of the project. Due to financial difficulties, the work had not been completed by the end of 2003, as originally planned. As of 18 May 2005, the secretariat had no information on the further implementation of the project.
7. A project to establish an international benchmark station for EMEP background monitoring on the Black Sea island of Zmejiny was approved by the Steering Body at its

twenty-eighth session to cover Ukraine's arrears for the period 1996-2001, equivalent to US\$ 175,205 (EB.AIR/GE.1/2004/2, para. 73 (l)). At its meeting in February 2005, the Bureau recommended a change in the location of the site in view of the pending case between Romania and Ukraine concerning their maritime boundary. The secretariat informed Ukraine of this recommendation by the Bureau and invited it to report on progress at the twenty-ninth session of the Steering Body.

8. To cover its contribution in kind for 2004, Belarus carried out a project on further research on HCB and PCB emission inventory improvement in the Commonwealth of Independent States (CIS). The Bureau, at its meeting in February 2005, recommended that the EMEP Steering Body approve the contribution by Belarus for 2004 (EB.AIR/GE.1/2005/9, para. 12).

9. In addition, as detailed in table 1 below, payments in cash for 2005 totalling US\$ 532,110 had been received by 18 May 2005. The expected contributions from Belgium, the Czech Republic, Estonia, Finland, France, Germany, Ireland, Lithuania, the Netherlands, Poland, Portugal, Romania, Serbia and Montenegro, Slovakia, Slovenia, Spain, Sweden, Turkey, Ukraine and the European Community in cash to the Trust Fund and a contribution in kind from Belarus are still outstanding.

## **II. USE OF RESOURCES BY THE EMEP CENTRES IN 2004**

10. Table 2 presents a summary of the use of resources by CCC, MSC-E and MSC-W. This overview is based on the detailed information prepared by the centres and presented to the EMEP Bureau.

11. Much of the work of EMEP relies on extrabudgetary contributions. The extrabudgetary resources listed in paragraph 4 above were used to supplement resources provided through mandatory contributions in all areas of work. CCC used extrabudgetary resources to add about 20% to the resources provided by the EMEP Trust Fund. They were mainly used to provide additional resources for acid deposition and photo-oxidants measurements, and to host a workshop on the implementation of the EMEP monitoring strategy. In addition, the low US\$/Nkr exchange rate reduced the financial resources available. MSC-W used extrabudgetary contributions to cover 73% of its expenditure in 2004. It should be noted that the total operating expenses of MSC-W have increased significantly (by almost 40%) with respect to previous years, mainly owing to an increased demand for computer resources for the calculation of source-receptor relationships. Most of the work of the Centre for Integrated Assessment Modelling (CIAM) was financed through non-EMEP sources. MSC-E received funding from the European Commission to contribute to the EC project "Estimation of willingness-to-pay to reduce risks of exposure to heavy metals and cost-benefit analysis for reducing heavy metals occurrence in Europe" (ESPREME).

### **III. BUDGET AND MANDATORY CONTRIBUTIONS FOR 2006**

12. At its twentieth session, the Executive Body decided, based upon the recommendation by the EMEP Steering Body, to increase the EMEP budget for the period 2004 to 2006 to US\$ 2,142,520 and to apply the 2003 United Nations scale of assessments as a basis for calculating the EMEP scale of mandatory contributions from 2004 - 2006. At its twenty-second session, the Executive Body requested the secretariat to prepare a revision to the annex to the EMEP Protocol, using the 2004 United Nations scale of assessments for submission to the Steering Body at its next session (ECE/EB.AIR/83, para.89 (f)).

13. The EMEP Bureau, at its meeting in February 2005, considered the detailed 2006 budget and adopted the proposal for the 2006 budget set out in table 3 below. The Bureau left the overall budget unchanged and did not modify the distribution between the centres. A significant increase is proposed in the budget line for hemispheric modelling.

14. At its twenty-eighth session, the Steering Body agreed to keep the CIAM budget for 2006 at the same level as in 2005 (EB.AIR/GE.1/2004/2, para.73(f), EB.AIR/GE.1/2003/4, para.59). It is proposed that the budget for 2006 and the provisional budgets for 2007 and 2008 remain at the same level.

15. In accordance with the request by the Executive Body at its twenty-second session to apply the 2004 United Nations scale of assessments as a basis for calculating the EMEP scale of mandatory contributions from 2006, the EMEP scale presented in table 4 has been updated. The schedule of mandatory contributions from Parties for 2006, calculated on the basis of the above budget, is set out in the last column of table 4.

16. The Bureau approved in 2005 a project on further research to improve the inventory of particulate matter emissions in the Commonwealth of Independent States, taking the example of Belarus, to cover the 2006 contribution from Belarus. The project should be conducted in close consultation with the Task Force on Emission Inventories and Projections or one of its panels (EB.AIR/GE.1/2005/9, para. 12).

17. In order to update the annex to the EMEP Protocol on the basis of the 2004 United Nations scale of assessments, the Steering Body may wish to recommend to the Executive Body to amend the annex to the EMEP Protocol accordingly. The draft annex to the EMEP Protocol is set out in the annex to this document.

### **IV. PROPOSED DECISIONS FOR THE EMEP STEERING BODY**

18. The Steering Body may wish to:

- (a) Take note of the status of contributions to the financing of EMEP provided in document EB.AIR/GE.1/2005/11 and the additional information provided by the secretariat during the session;
- (b) Approve the use of resources by the EMEP centres in 2004 as presented in table 2 of EB.AIR/GE.1/2005/11;
- (c) Also approve the 2004 contribution in kind from Belarus;
- (d) Agree on the detailed budget for 2006 set out in table 3 of EB.AIR/GE.1/2005/11 and the schedule of mandatory contributions from Parties for 2006 as set out in the last column of table 4 of that document;
- (e) Also agree on the proposed budget of CIAM for 2006 as set out in the report of the Task Force on Integrated Assessment Modelling (EB.AIR/GE.1/2003/4, para. 59) and on keeping the proposed budgets for 2007 and 2008 at the same level;
- (f) Recommend to the Executive Body to adopt the 2006 budgets and the revised schedule of contributions;
- (g) Call upon the Parties to the EMEP Protocol to consider making voluntary contributions (in kind or in cash through the trust fund) to ensure that the work, especially the difficult tasks required in 2006 for carrying out the protocol reviews, including the work on integrated assessment modelling, can be accomplished as foreseen in the work-plan; and
- (h) Recommend to the Executive Body to amend the EMEP Protocol by adopting, in accordance with article 4, paragraph 3, of the Protocol, the revised annex set out in the annex to document EB.AIR/GE.1/2005/11.
