# <u>Information to the civilian population</u>

The UK's ratification of Amended Protocol II was announced in the UK Parliament on 11 February 1999 and is, therefore, in the public domain. The general population of the UK have also been informed through advertisements in the national press, of the entry into force of the Ottawa Convention on 1 March 1999, and on the implications for all UK citizens of the Ottawa Convention.

## Mine clearance programmes

UK territory, on which it is known mines have been laid and still exist, lies in the Falkland Islands located in the South Atlantic Ocean. Currently remaining from the 1982 conflict between the UK and Argentina, are 117 minefields containing either anti-personnel, anti-vehicle mines or a combination of both. The UK and Argentina are working together to assess the costs and feasibility of mine clearance options in the Falkland Islands.

## Rehabilitation programmes

The UK runs health and social development programmes with targeted elements for disabled people including those injured by landmines.

## International technical information exchange

The UK works closely with the United Nations Mine Action Service (UNMAS) and the Geneva International Centre for Humanitarian Demining (GICHD) – including technical information exchange - to facilitate international coordination and cooperation in the field of de-mining. The UK is also a member of the International Test and Evaluation Programme which promotes a shared approach to technological demining solutions.

#### International cooperation on mine clearance

The UK has previously provided support to international demining activity through a variety of official organisations (for example, BiH Mine Action Centre and the UN Mine Action Coordination Centre in Kosovo), non-Governmental organisations and commercial companies. In the future UK funding for demining will be channelled through the UN (UNMAS and UNDP). The UK also provides support to the GICHD.

## International co-operation on technical co-operation and assistance

The UK provides, on a case by case basis, technical assistance, specialist training and advice on bi- and multilateral levels.

## Other relevant matters

The Mine Information and Training Centre (MITC) at Minley in Surrey, established by the UK Ministry of Defence, is the UK military centre of excellence for humanitarian mine action and mine awareness training. It provides a focus for the mine awareness training to military personnel prior to deployment overseas and the staff frequently travel to assess other mines awareness instructors to ensure that standards are maintained. It also provides mine awareness training and advice together with more general information on mines to other Government Departments, non-government organisations, academia, industry and civilians. Since December 1997, the centre has trained in excess of 51,000 people including over 1,500 returning Kosovo refugees.
