The PRESIDENT (interpretation from Spanish): I call on Mr. Virgilio A. Reyes of the Philippines, Rapporteur of the First Committee, to present the reports of that Committee on agenda items 51 to 69, 139, 141, 145 and 70 to 73 in one statement.

Mr. REYES (Philippines), Rapporteur of the First Committee: I am honoured and pleased to present to the General Assembly the reports of the First Committee on its work concerning disarmament, the question of Antarctica, and international peace and security, under agenda items 51 to 73, 139, 141 and 145.

The reports are before the General Assembly in the following documents: A/43/830 to A/43/841, A/43/855 to A/43/861 and A/43/894 to A/43/896 on disarmament items; and A/43/911 and A/43/912 to A/43/914 on the question of Antarctica and international security items. At the current session 26 items were allocated to the First Committee, including three new items.

This year the Committee met in the aftermath of the third special session of the General Assembly devoted to disarmament, which, despite the strenuous efforts exerted by all the parties concerned, was in the end not in a position to adopt a consolidated final document. Accordingly, it was evident that the First Committee would have to address a number of the issues that were raised but remained unresolved at that special session. This lent a greater measure of urgency and significance to the work of the First Committee at the forty-third session.

As in previous years, the First Committee considered the items allocated to it in three general phases, namely, disarmament issues, the question of Antarctica and international peace and security. The large number of agenda items on disarmament reflected the continued concern of many Member States with that important issue and for the role of multilateralism in finding solutions to the cutstanding problems in that field. At the same time, the continued debate on Antarctica and international peace and security emphasized the international community's views regarding goals that are complementary to disarmament and, in the case of international security, set in a broader context than disarmament.

At this session of the General Assembly, those three issues will be acted upon at the same meeting. If anything, this serves to bring to mind the common thread running through those issues, that is the realization of the primary purpose of the United Nations, namely, international peace and security.

The Committee devoted some 23 meetings to the general debate and exchange of views on all disarmament items for more than two weeks, from 17 October to 2 November. Thereafter, the Committee set aside two weeks to consider and act upon the draft resolutions submitted on disarmament items, including informal consultations among delegations.

A record number of delegations - 126 in all - participated in the general debate, which proved to be relatively free of polemics and forward-looking in its scope. Indeed, as was stated by the Chairman of the First Committee in his concluding statement on disarmament issues, confrontation has been replaced by co-operation, rhetoric by pragmatism. The Committee, in his view, could be deemed to have made a constructive contribution to an improved international atmosphere and better understanding among States.

As many delegations remarked, the impetus for that positive atmosphere has, to a large extent, been provided by the improved relations between the Union of Soviet Socialist Republics and the United States of America. At the same time, the various moves towards a satisfactory resolution of various regional conflicts helped bolster the constructive spirit prevalent during the debate of the First Committee.

The primacy of nuclear disarmament continued to occupy the First Committee's attention as it sought to identify mutually acceptable modalities for attaining the ultimate objective of a world entirely free of nuclear weapons. Among the modalities actively debated under this general rubric were the cessation of the nuclear-arms race, the prevention of nuclear war, nuclear freeze, a comprehensive nuclear-test ban and bilateral negotiations on nuclear weapons.

At the same time, the issue of conventional disarmament was placed in a wider perspective, including the broader implications of international arms transfers.

New emphasis was laid on the urgent topic of chemical weapons. Verification, compliance and confidence-building measures also loomed high on the Committee's agenda. The prevention of an arms race in outer space was discussed as a topic of concern. Furthermore, the international community manifested its concern for such issues as the dumping of nuclear and toxic wastes and the impact of scientific and technological developments on international security.

The First Committee also devoted attention to consultations concerning the Paris conference on the 1925 Geneva Protocol prohibiting the use of chemical weapons. It was the prevailing hope among delegations that the conference, to be held from 7 to 11 January 1989, would inter alia reaffirm the importance of the 1925 Geneva Protocol and give fresh impetus to the negotiations on a treaty banning chemical weapons being conducted in the Conference on Disarmament in Geneva.

During the session of the Committee, interest in United Nations studies resurfaced, indicating an effort to analyse and assess current or developing situations with regard to a wide range of old and new issues. They include the updating of an existing study on nuclear weapons, the establishment of a nuclear-weapon-free zone in the Middle East, the United Nations and verification, arms transfers, the effect of scientific and technological developments on the arms race, and the completion of an ongoing effort to develop further guidelines and procedures for investigation into alleged use of chemical weapons.

Among the 67 draft resolutions adopted on disarmament issues, there are 23 draft resolutions dealing with the question of nuclear disarmament, including the prevention of nuclear war, a nuclear-weapon-test ban, bilateral negotiations on nuclear weapons, a nuclear-arms freeze, security assurances for non-nuclear-weapon States and nuclear-weapon-free zones. Such a large number of draft resolutions on the subject demonstrates the importance accorded to issues related to nuclear weapons. With regard to other disarmament questions, three draft resolutions were adopted on chemical and biological weapons, six draft resolutions on conventional disarmament, including the question of international arms transfers, one draft resolution dealing with the prevention of an arms ruse in outer space, two draft resolutions relating to questions of verification and compliance, two draft resolutions concerning confidence-building measures and 30 draft resolutions regarding other questions, including the Conference on Disarmament, the Disarmament Commission, the Indian Ocean as a zone of peace, the relationship between disarmament and development, the United Nations fellowship and training programme, the reduction of military budgets, and the World Disarmament Campaign.

Through concerted efforts, the First Committee made a modest contribution to a gradual and incremental process of consensus-building, not only by preserving

consensus on issues already agreed upon, but also by exercising restraint in not pressing disagreements to a point of no return. The eight draft resolutions on disarmament questions, which were not pressed to a vote or were merged, were notable not so much for their number but for the political sensitivity of the issues involved.

International arms transfers, nuclear freeze, the role of the United Nations in the field of verification, the prevention of an arms race in outer space and objective information on military matters were all areas bedevilled by serious differences in the not too distant past. In preserving and broadening the emerging consensus on those crucial issues, the First Committee took advantage of a general relaxation in the international climate.

Turning to the second phase of the First Committee's work, I should now like to draw attention to the report of the First Committee on agenda item 70, entitled "Question of Antarctica" (A/43/911). As reflected in the debate on that item, despite efforts aimed at achieving consensus, this proved to be elusive.

Two draft resolutions were adopted by roll-call vote in which a number of delegations indicated that they were not participating in the vote, as reflected in the Committee's report. In that connection, I should like to draw the attention of the Assembly to document A/43/911 in which a technical error has occurred in the second paragraph of footnote 1 on page 3. Indeed, it should be noted that the delegation of Cameroon indicated, subsequent to the vote, that it had intended to vote in favour of draft resolution A/C.1/43/L.82. Accordingly, a corrigendum is being issued forthwith and will shortly be available to the Assembly as document A/43/911/Corr.1.

In draft resolution A, the General Assembly, inter alia, expresses its conviction that any minerals régime on Antarctica should, in order to be of benefit

to all mankind, be negotiated with the full participation of all members of the international community. The draft resolution also reiterates its call upon the Antarctic Treaty Consultative Parties to invite the Secretary-General or his representative to all meetings of the Treaty parties, including their consultative meetings.

In pursuance of draft resolution B, the Assembly would appeal once again to the Treaty parties to take urgent measures to exclude the racist apartheid régime of South Africa from participation in the meetings of the Consultative Parties at the earliest possible date. This draft resolution would also invite the States Parties to the Antarctic Treaty to inform the Occatary-General on action taken with regard to the provisions of the draft resolution.

As far as the third phase of the Committee's work is concerned, the reports relating to the relevant agenda items, namely 71, 72 and 73, are contained in documents A/43/912, A/43/913 and A/43/914, respectively.

With regard to item 71 on "Strengthening of security and co-operation in the Mediterranean region", concern was expressed by a number of States that despite the recent positive developments in the international situation, this region continued to be a potential source of instability and conflict. According to the draft resolution, which was adopted without a vote, the General Assembly would reaffirm that the security of the Mediterranean was closely linked with European security and with international peace and security, and would reaffirm the need for just and viable solutions, including the withdrawal of foreign forces of occupation and the right of peoples under colonial or foreign domination to self-determination.

At this session, under item 72, entitled "Review of the implementation of the Declaration on the Strengthening of International Security", the Committee adopted four draft resolutions, thus reflecting the preoccupations of Member States on various aspects of international peace and security.

According to the first draft resolution, a new initiative at the current session, entitled "Strengthening of regional and international peace and security", the Assembly would, inter alia, urge all States, in the implementation of agreements reached with the United Nations on peace-keeping arrangements, further to strengthen co-operation with the Secretary-General in the discharge of his functions deriving from the Charter and from the mandates and decisions of the Security Council and the Assembly.

According to the second draft resolution, entitled "Need for a result-oriented political dialogue to improve the international situation", the Assembly would, inter alia, reaffirm its appeal to all Member States to enhance the role of the

United Nations as a forum for political dialogue and negotiation and specifically to consider ways and means of strengthening the role and efficiency of the Assembly.

According to the third draft resolution, entitled "Tenth anniversary of the adoption of the Declaration on the Preparation of Societies for Life in Peace", the Assembly would, inter alia, reaffirm the lasting validity of the purposes and principles enshrined in that Declaration, based on the Charter, and would take note, with appreciation, of the important role the Declaration has played in promoting world peace and international security, common understanding and mutually beneficial co-operation. It would call upon all States to spare no efforts towards the fullest implementation of the Declaration at the national and international levels and towards increasing its national and international role by strictly adhering to the principles enshrined in that document.

Finally, the fourth draft resolution relates to the "Review of the implementation of the Declaration on the Strengthening of International Security", an issue considered annually by the Committee since the adoption of the Declaration in 1970. Under this draft the Assembly would, inter alia, reaffirm the validity of the Declaration on the Strengthening of International Security and call upon all States to contribute effectively to its implementation and once again urge all States to abide strictly, in their international relations, by their commitment to the Charter of the United Nations.

Item 73, entitled "Comprehensive system of international peace and security", once again formed part of the deliberations of the First Committee. The sensitive and complex character of the issue occasionally prompted differing exchanges of views among delegations. Under the terms of the draft resolution adopted by the Committee and entitled "Comprehensive approach to strengthening international peace and security in accordance with the Charter of the United Nations", the Assembly

would, inter alia, encourage Member States to contribute to an international dialogue, primarily within the framework of the United Nations, the Security Council, the General Assembly and their subsidiary bodies, in order to find universally acceptable ways and means and to co-ordinate practical measures to strengthen on a comprehensive basis the system of security laid down in the Chartof the United Nations and enhance the role and effectiveness of the United Nations in the maintenance of international peace and security in all aspects.

It may be pertinent to point out that the First Committee has once again endeavoured to achieve a greater degree of rationalization with regard to its proceedings. In this connection, it should be noted that the programme of work an timetable adopted by the Committee this year already included a number of measures to that effect, including the provision for an additional period for the purpose of consultations on draft resolutions before the Committee. This may, indeed, have been partly instrumental in facilitating the process of seeking mergers of various texts and enlarging upon the area of consensus.

Both within the Committee and in informal consultations spearheaded by the Chairman, members also considered the rationalization of the Committee's agenda items, taking into account, inter alia, General Assembly resolution 42/42 N adopted last year, as well as suggestions made by former chairmen of the Committee. After several rounds of open-ended consultation had been held, the Chairman issued a working paper containing suggestions on the question of rearrangement of the Committee's agenda items for future consideration.

Before concluding this afternoon my work as Rapporteur of the First Committee, I should like to pay a particular tribute to all those who have helped me to carry out my task. First of all, I would like to thank Ambassador Douglas Roche, Chairman of the First Committee. His diplomatic skills, expertise and patience

enabled him to establish an atmosphere of dialogue, work and compromise, which allowed the First Committee to conclude its work successfully within the given time period. I greatly appreciate his co-operation in my work as Rapporteur.

I would also like to pay a tribute to the two Vice-Chairmen, Ambassador Batiouk and Ambassador Bayart, who are also highly effective and skilled diplomats.

I should also like to take this opportunity sincerely to thank the personnel of the Secretariat of the First Committee, in particular, Mr. Yasushi Akashi, Under-Secretary-General for Disarmament Affairs, and Mr. Vasiliy Safronchuk, Under-Secretary-General for Political and Security Council Affairs.

I would also like to state how grateful I am, in particular, to the Secretary of the First Committee, Mr. Sohrab Kheradi for the highest degree of knowledge and competence in the field of disarmament, and his entire team, who spared no effort to facilitate the work of the Committee and to conclude it in good time.

It was a great honour for me and for my country, the Philippines, to serve as Rapporteur of this important Committee.

In concluding, I wish to recall the words of the late renowned Filipino nationalist, Claro Mayo Recto, who said:

"Not everyone slept during the night of our forefathers."

The issues of disarmament, peace and security had indeed experienced a long night in which multilateral efforts sometimes appeared to be in vain. Yet there were those who unceasingly and tirelessly laboured to bring about the dawn and the new rays of hope that we are witnessing today.

We would hope that just as we look back with appreciation and admiration on past efforts, future generations may also look back at our efforts and say, "Not everyone slept during the night of our forefathers."

The reports of the First Committee which are before the Assembly indicate in detail the actions taken regarding each item and the results of the voting on the draft resolutions approved. It would therefore not be necessary for me to elaborate on them in detail.

I now have the honour to submit to the Assembly for consideration and adoption the recommendations formulated by the First Committee in the reports that I have just introduced.

The PRESIDENT (interpretation from Spanish): If there is no objection, under rule 66 of the rules of procedure, I shall take it that the General Assembly decides not to hold a debate on the reports of the First Committee introduced to it today.

## It was so decided.

The PRESIDENT (interpretation from Spanish): In accordance with this decision, statements will be limited to explanations of vote. The position of delegations with respect to the different recommendations of the First Committee have been expressed in the meetings of the First Committee and are reflected in the relevant records.

I would also like to remind delegations that the General Assembly, in paragraph 7 of its decision 34/401, established that:

"When the same draft resolution is considered in a Main Committee and in plenary meeting, a delegation should, as far as possible, explain its vote only once, i.e., either in the Committee or in plenary meeting unless that delegation's vote in plenary meeting is different from its vote in the Committee."

#### (The President)

I should like also to remind members that, in accordance with General Assembly decision 34/401, explanations of vote should be limited to 10 minutes and should be made by delegations from their seats.

We turn first to the report (A/43/830) of the First Committee on agenda item 51, entitled "Implementation of General Assembly resolution 42/25 concerning the signature and ratification of Additional Protocol I of the Treaty for the Prohibition of Nuclear Weapons in Latin America (Treaty of Tlatelolco)".

We shall now take a decision on the draft resolution recommended by the First Committee in paragraph 7 of its report.

The draft resolution was adopted by 149 votes to none, with 5 abstentions (resolution 43/62).

Mr. INSANALLY (Guyana): The delegation of Guyana would like to make a brief explanation of its vote on the draft resolution contained in document A/43/830, on the implementation of General Assembly resolution 42/25 concerning the signature and ratification of Additional Protocol I of the Treaty for the Prohibition of Nuclear Weapons in Latin America - known as the Treaty of Tlatelolco.

Guyana has always expressed its commitment to the Treaty's objective, which is, in essence, the insulation of Latin America and the Caribbean from the threat of nuclear weaponry. It has thus been sympathetic to the thrust of this draft resolution, which is the latest in a series of resolutions on this item first adopted in 1979 and which seeks to bring all concerned parties under the Treaty's umbrella.

We have chosen in the past to abstain on the draft resolutions on this item as a form of protest against the exclusionary clause in the Treaty - namely, article 25, paragraph 2 - which, in our view, discriminated against Guyana and

prevented us from being a part to the Treaty. We cannot ever appear to condone such a breach of the principle of universality of membership.

It is our expectation, however, that this impediment will be removed in the near future and that we shall be enabled, if we so wish, to accede to the Treaty. Because of this prospect and the importance we attach to the establishment wherever feasible of nuclear-weapon-free zones as a positive disarmament measure, we have on this occasion decided to give our full support to the draft resolution.
