## I Background

The interest in Public-Private Partnerships (PPPs) for public service delivery continues to grow. The approach is applied for the traditional infrastructure services, such as energy and transport and also for health and education as well as new public administration projects in defence and prisons. At the same time, despite the interest, PPPs are still not well developed in most countries in the ECE region. This is due to the lack of skills and knowledge about the PPP concept within both the public and private sectors.

To address this challenge it has been proposed that the next topic of the 4<sup>th</sup> PPP Alliance Annual Meeting will be devoted to how governments can turn PPP service delivery into a reality. In view of their considerable experience in the implementation of PPPs, the UK Government has kindly offered to host this conference. Some 700 PPP projects have been agreed under the UK's private finance initiative representing an investment of €60 billion euro.

The United Nations Economic Commission for Europe (UNECE) PPP Alliance, under the auspices of the Working Party on International Legal and Commercial Practices (WP.5), improves the understanding of PPPs amongst the public and private sectors. To this end, it has established expert groups, prepared guidelines on best practice and organized conferences and seminars on various aspects of public-private partnerships. It works in cooperation with the EU, EBRD, EIB and the OECD in undertaking these objectives. In 2004 twenty-four governments from UNECE member states have joined the Alliance and was that time cochaired by Ireland and France. The Alliance also includes members from the private sector with experience of undertaking PPPs in Europe.
